

AN ORDINANCE AMENDING SECTION 30.37 OF THE CITY OF VILLA HILLS CODE OF ORDINANCES REVISING THE SCHEDULE FOR COUNCIL COMMITTEE MEETINGS; AND ESTABLISHING MEETING DATES FOR JANUARY 2019.

WHEREAS, the incoming Mayor and City Council desire to change the January 2019 Council meeting schedule due to scheduling conflicts; and

WHEREAS, the incoming City Council has reviewed its current committee schedule and determined certain meeting times need to be adjusted; and

WHEREAS, City Council desires to bring its full meeting schedule into compliance with KRS 61.810 et seq.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF VILLA HILLS, KENTON COUNTY, KENTUCKY.

SECTION I

On Wednesday, January 9, 2019, and Wednesday January 23, 2019 the City of Villa Hills shall hold regularly scheduled City Council meetings. The meeting will begin at 6:30 PM and be held at the City Building at 719 Rogers Road, Villa Hills, Kentucky.

SECTION II

Subsection (3) of Section 30.37(A) of the City of Villa Hills Code of Ordinances is amended as follows:

- (3) The following committee meeting schedule shall be established:
- a. The Safety Committee shall meet on the second Tuesday of the month. The meeting will begin at 6:30 p.m. and be held at 719 Rogers Road, Villa Hills, Kentucky;
 - b. The Recreation Committee shall meet on the second Thursday of the month. The meeting will begin at 6:30 p.m. and be held at 719 Rogers Road, Villa Hills, Kentucky;
 - c. The Administration Committee shall meet on the first Wednesday of the month. The meeting will begin at 6:30 p.m. and be held at 720 Rogers Road, Villa Hills, Kentucky;

- d. The Public Works Committee shall meet on the second Wednesday of the month. The meeting will begin at 1:00 p.m. and be held at 720 Rogers Road, Villa Hills, Kentucky;
- e. The Finance Committee shall meet on the Monday before the regularly scheduled Council meeting. The meeting will begin at 7:00 p.m. and be held at 719 Rogers Road, Villa Hills, Kentucky;
- f. The Events and Beautification Committee shall meet on the first Monday of the month. The meeting will begin at 6:30 p.m. and be held at 720 Rogers Road, Villa Hills, Kentucky

SECTION III

Any and all Ordinances in conflict with this Ordinance shall be, and hereby are, repealed to the extent of said conflict.

SECTION IV


This Ordinance shall take effect and be in full force from and after its passage, publication, which may be in summary form, and recording, according to law.
