Sentenced 10 yrs on Rape 2 and 5 years on Intimidating a witness, sex offender registry ordered for 20 years, restraining orders approved by court for victim,

2020-06180 – Rape 1st, Unlawful transaction with a minor 3rd, Use of electronic communication device to entice a minor to a sex act - *Change of Plea scheduled for September 2021*

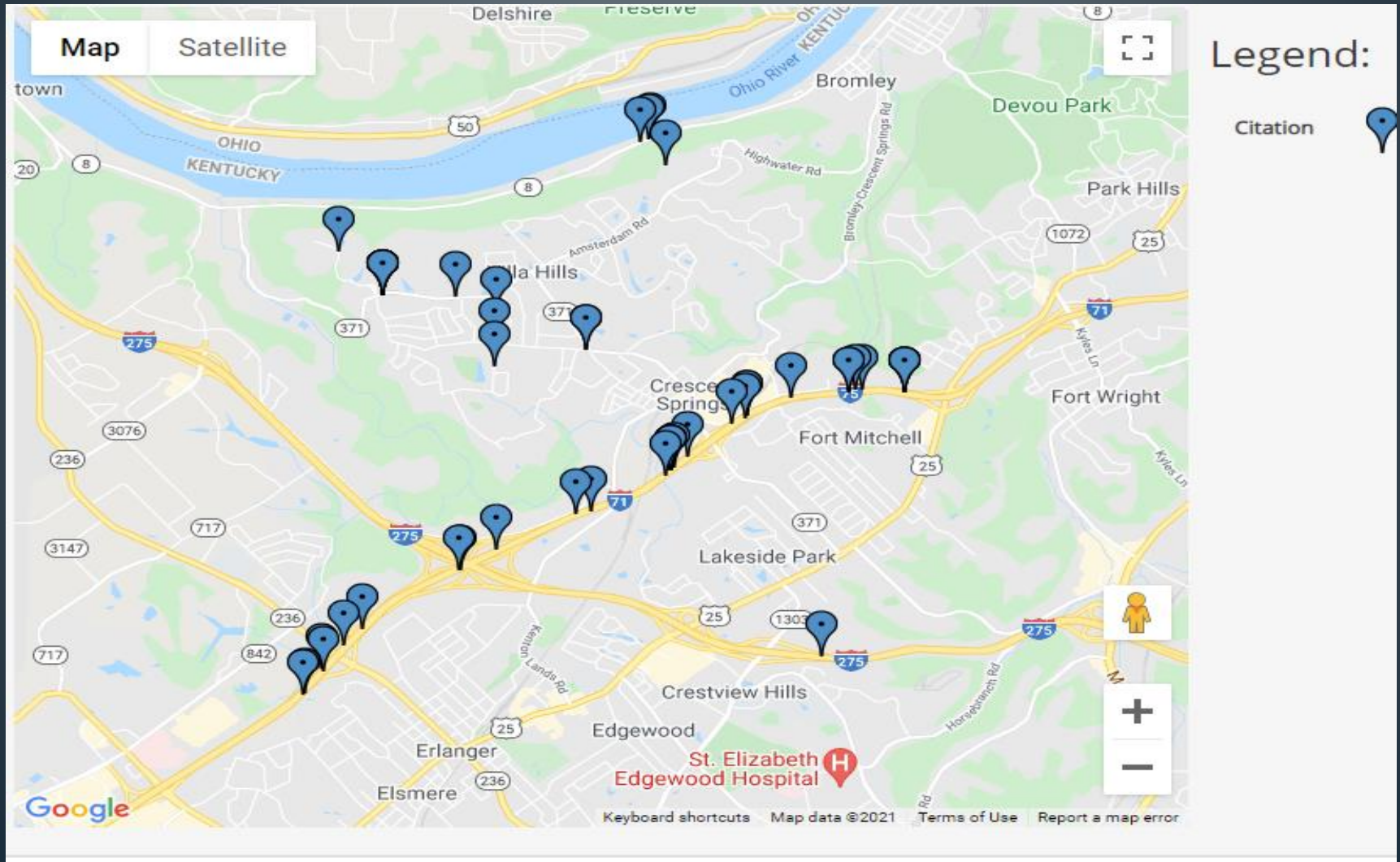
2020-11185 – TBUT >\$500/ PCS 1st – *change of plea scheduled for one suspect / other suspect at large*

2020-05218 – PCS 1st unspecified, Fleeing and Evading 2nd – *suspect plead guilty to a significant number of trafficking and possession charges in relation to a Drug Strike Force investigation, as result, this charge was dismissed as part of the plea deal – per Commonwealth*

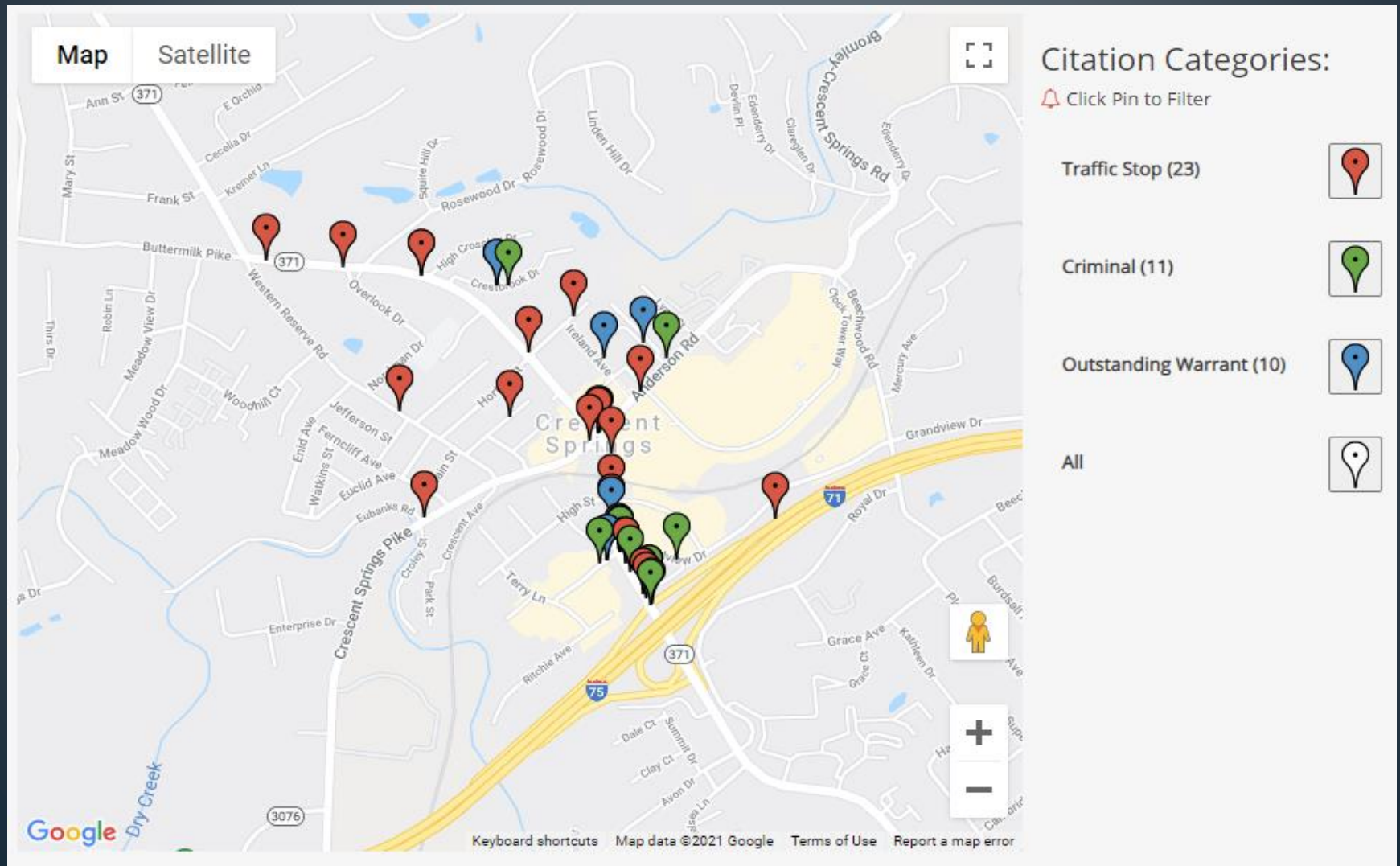
2021-06258 – Traf Marijuana >8oz<5lb(enhanced)/POM/PDP – *Grand Jury scheduled/ One suspect at large*

2020-10223 – Operating on Suspended OL / No insurance – *GUILTY – sentenced to 60 days jail/ 60 conditional fined \$50.00*

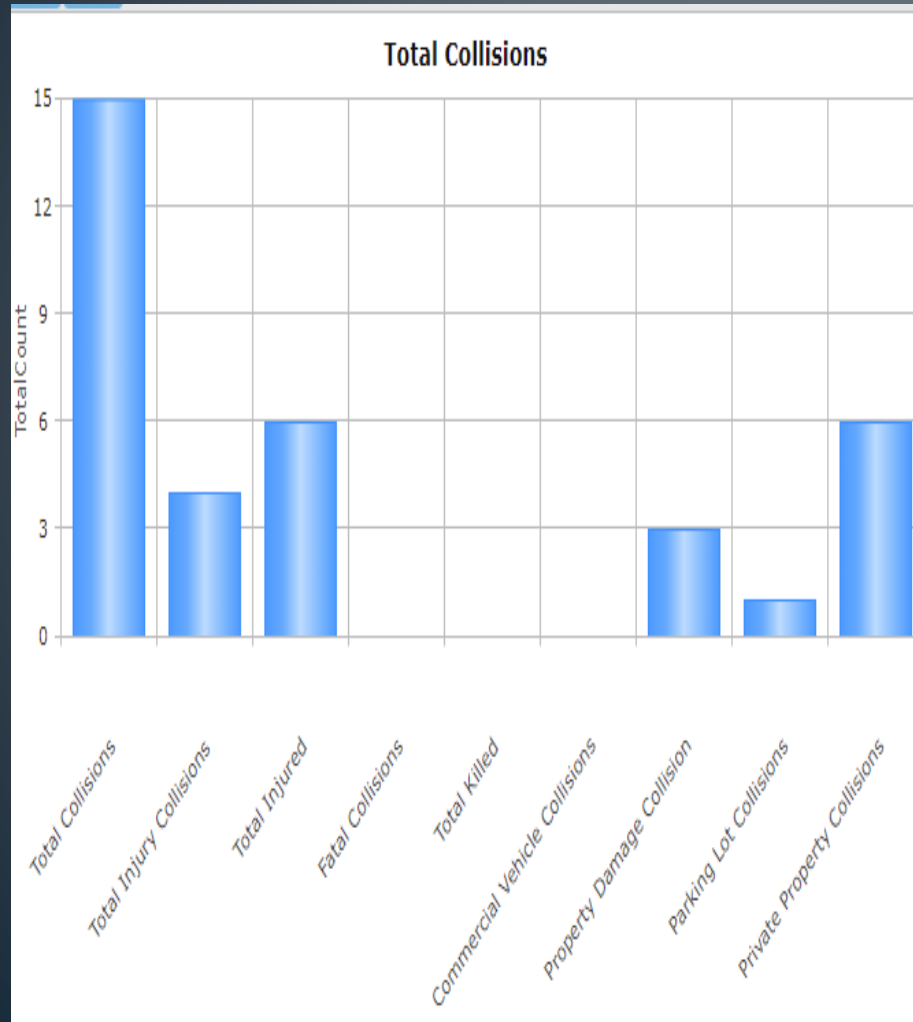

Citations Crescent Springs



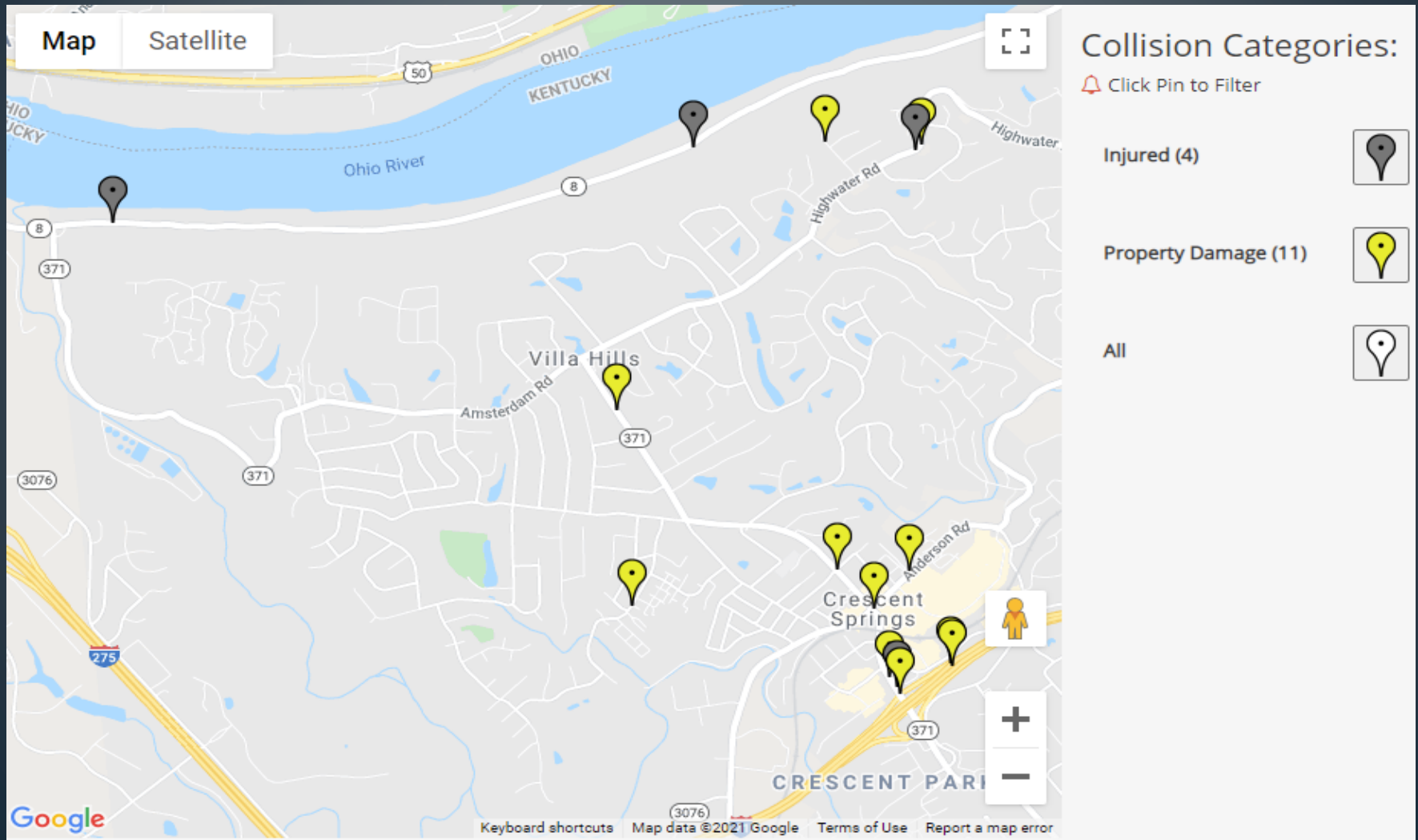

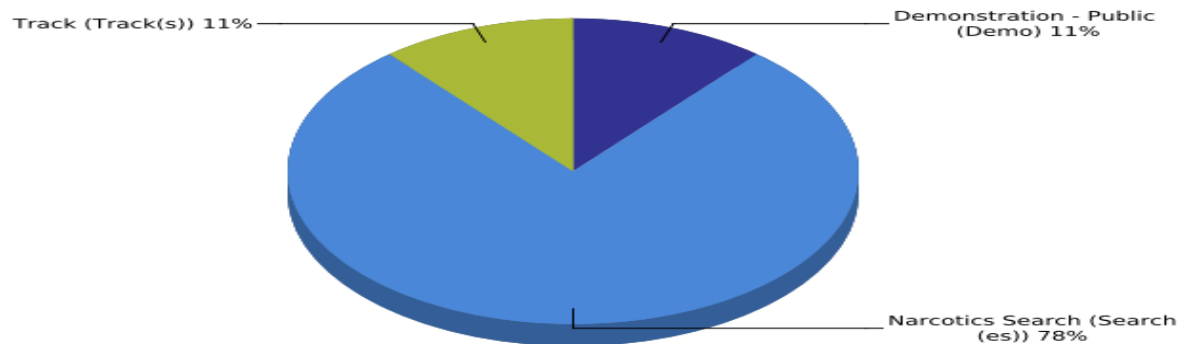
