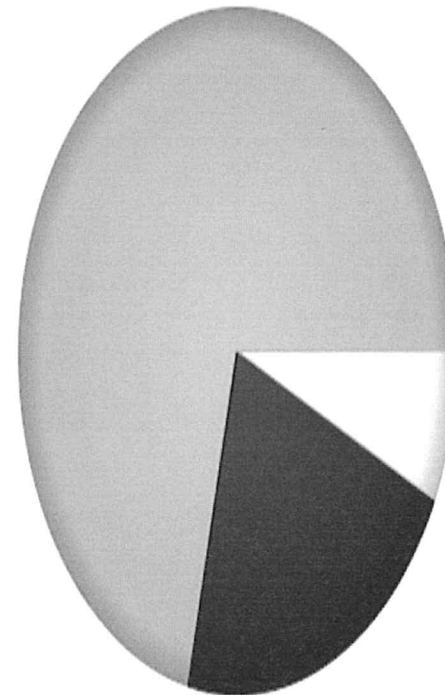

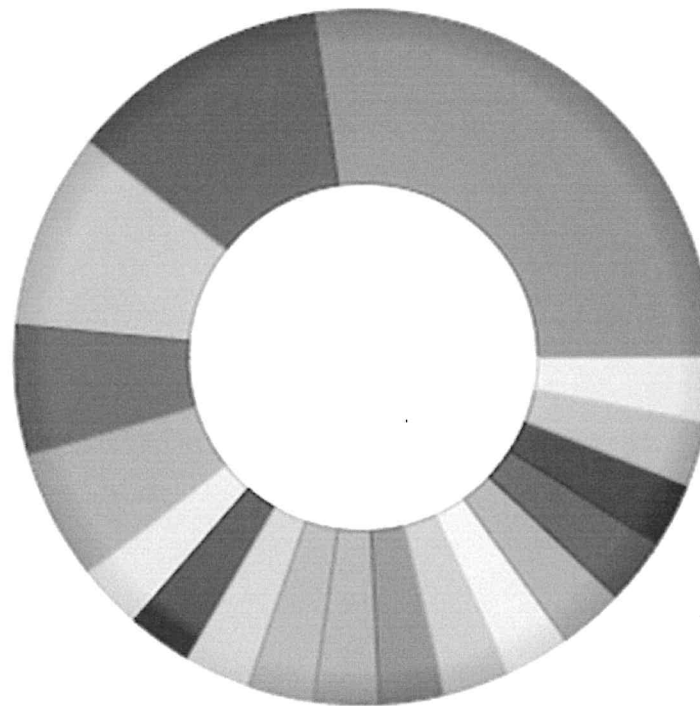

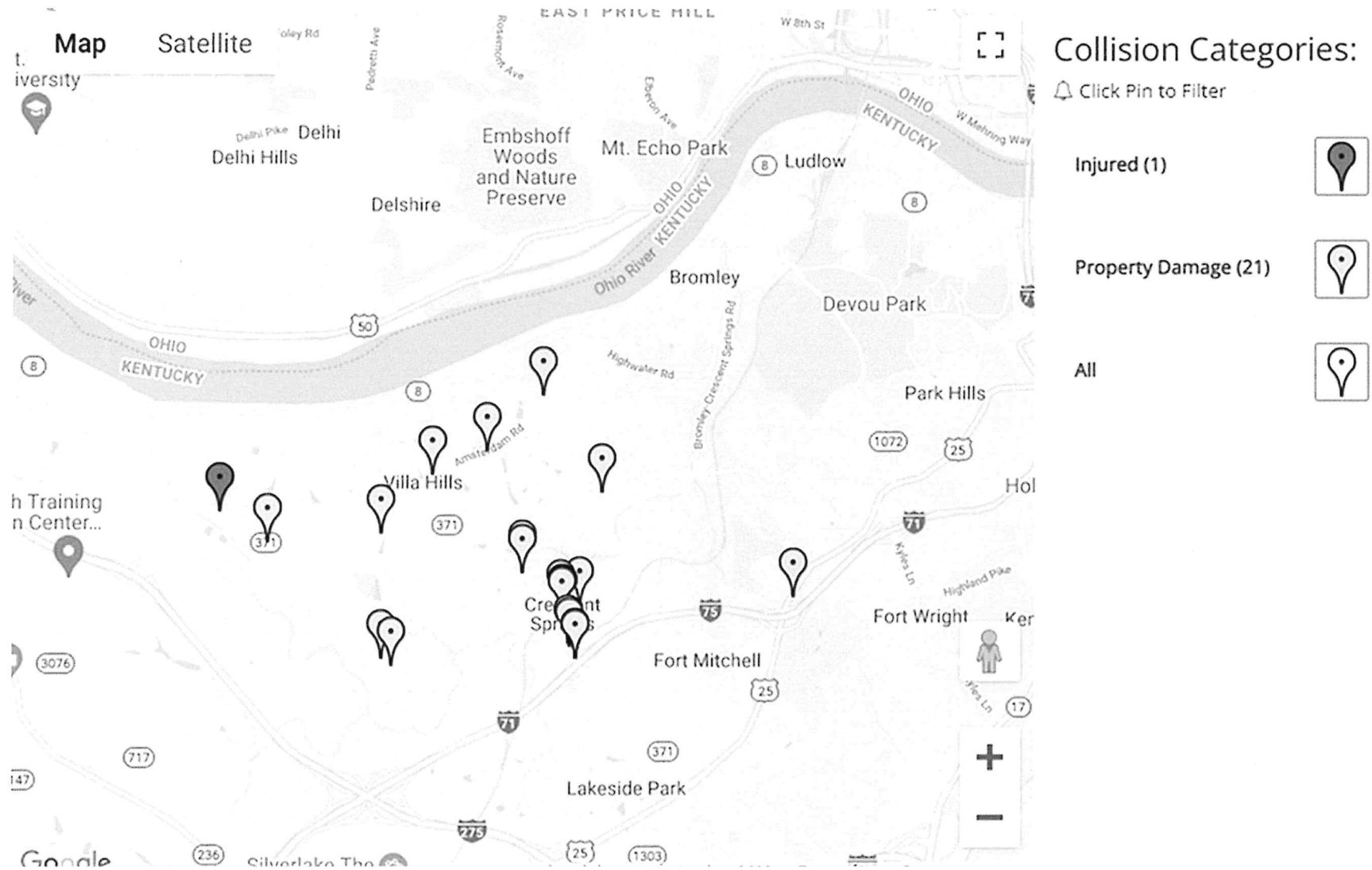

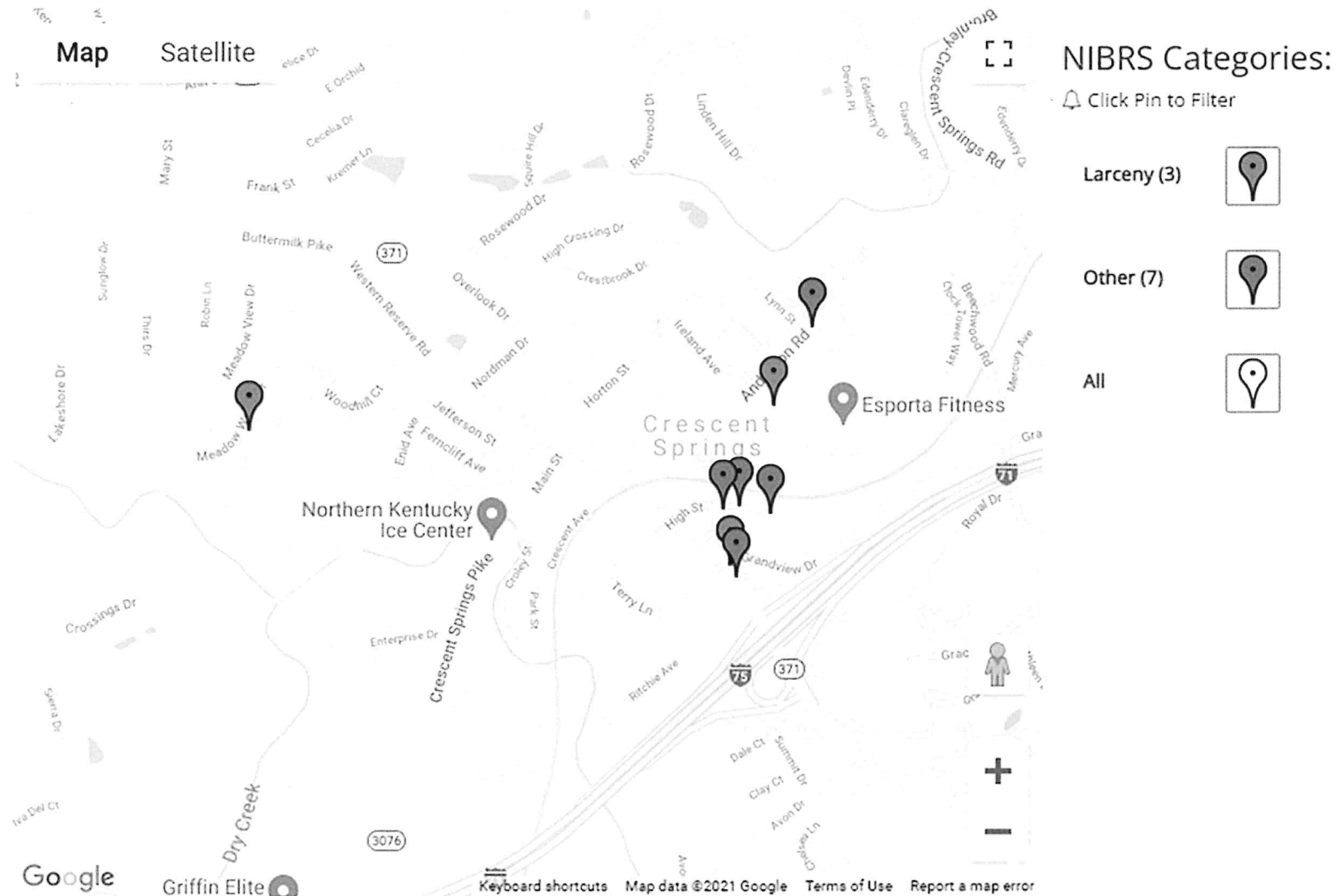
Collision Mapping

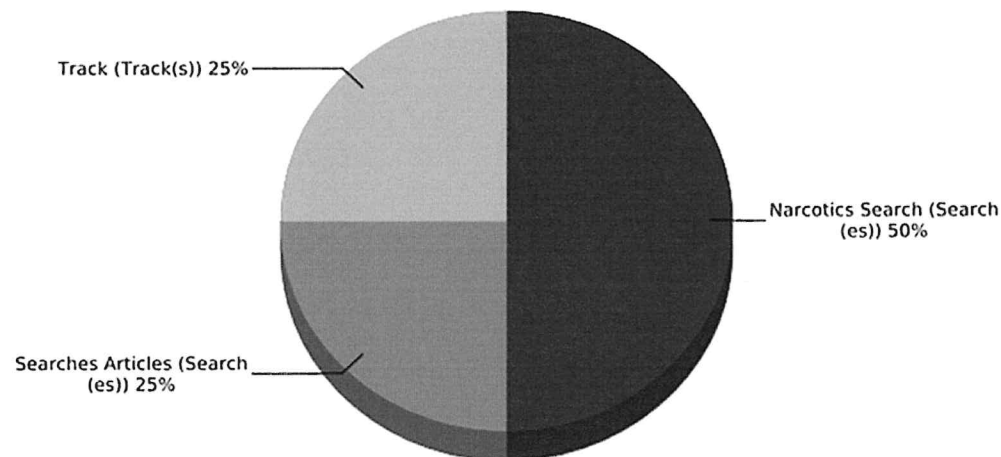

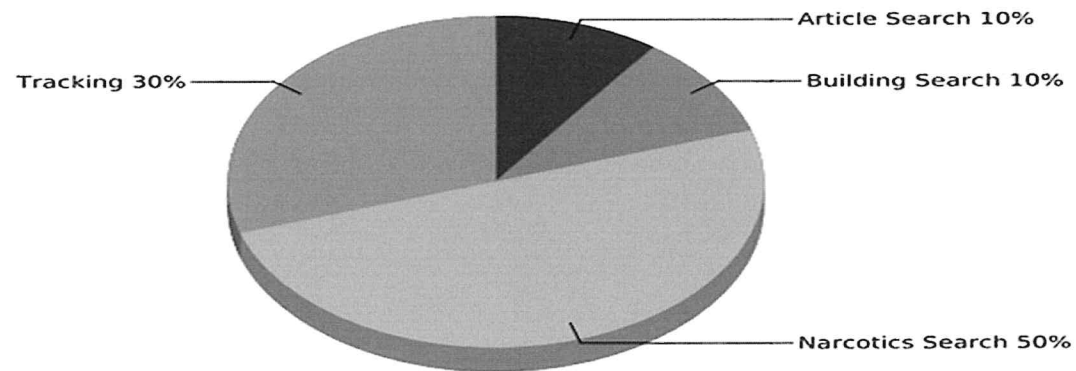
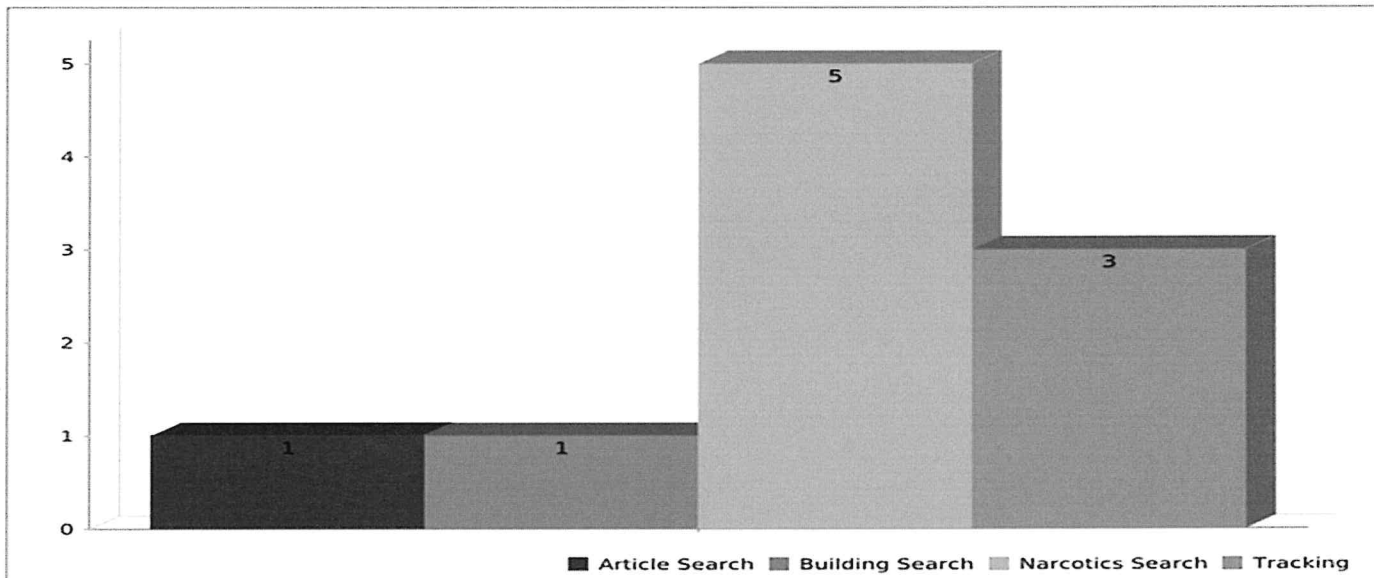
