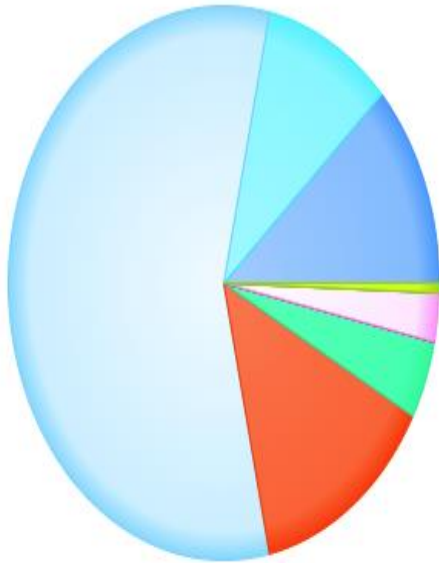

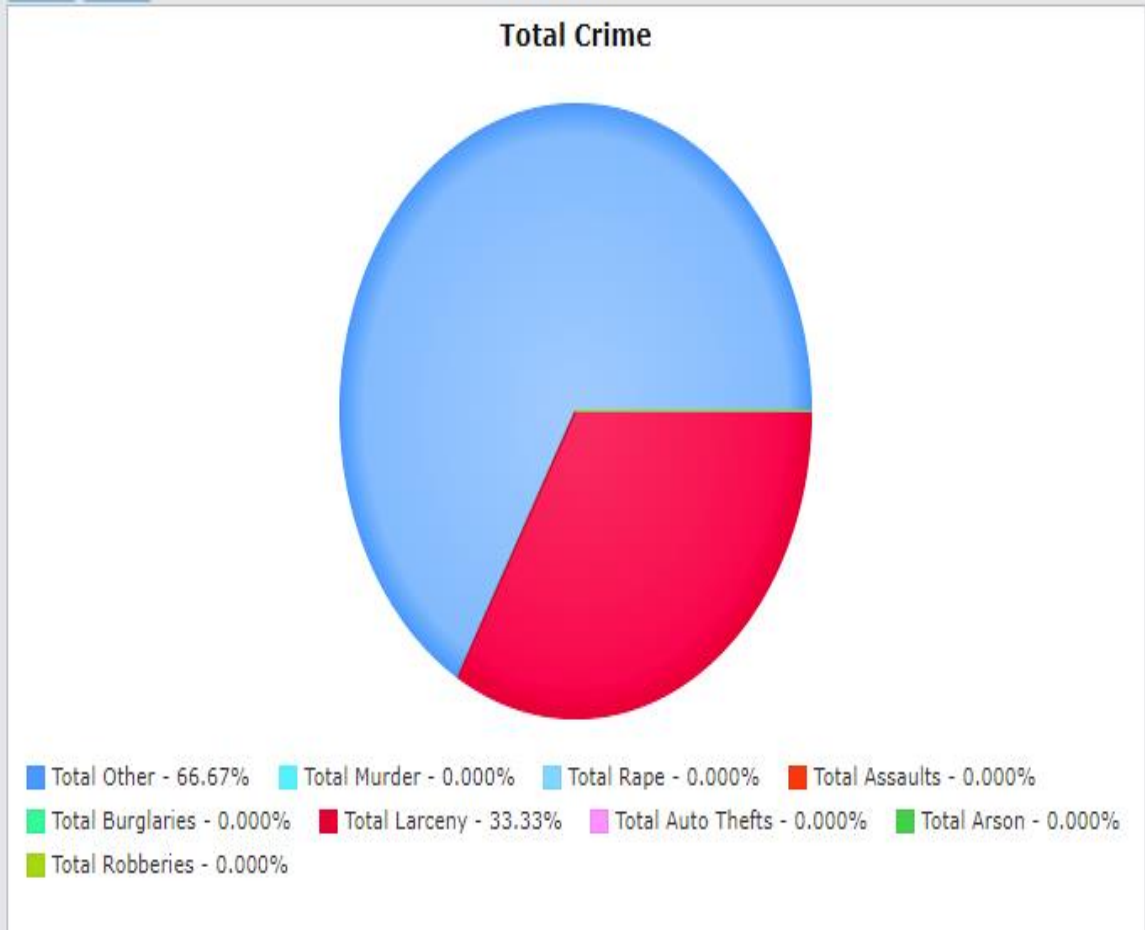

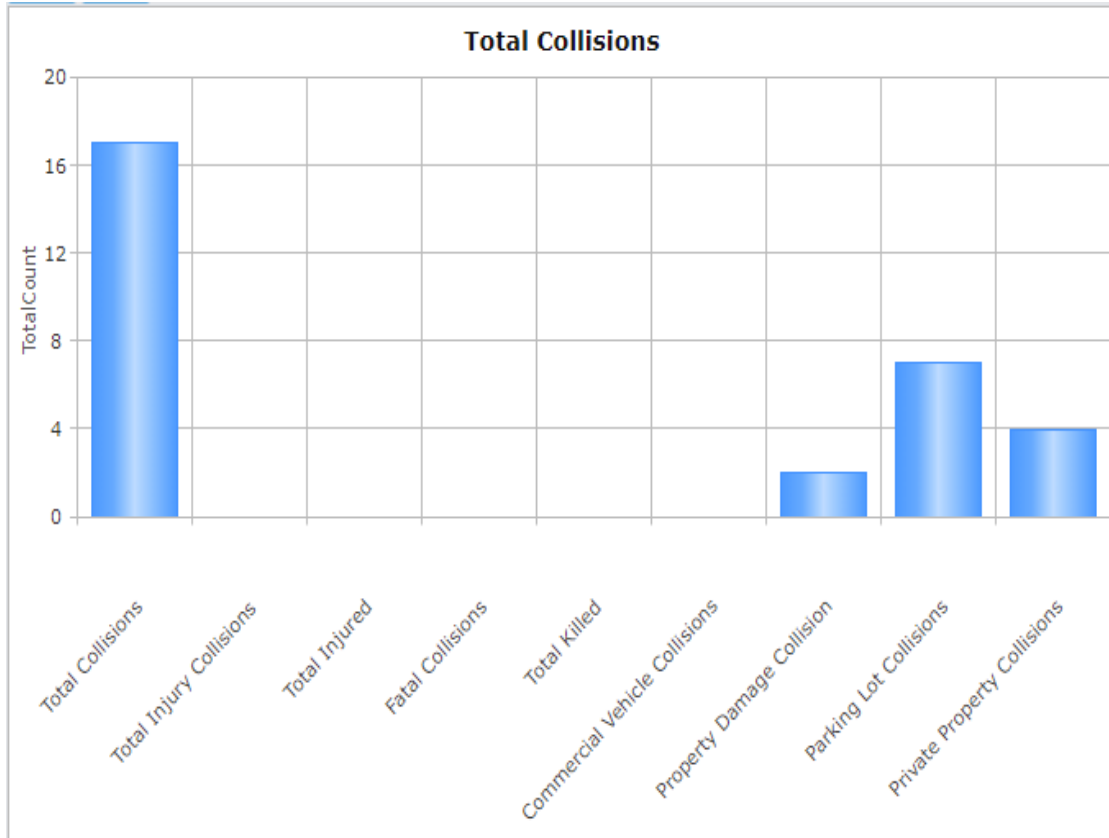

2021-13254 – TBUT > \$1k - Warrants issued on suspects

2022-03631 – Sex Abuse 1st x2 / Promoting Minor in a sex act – *waived to grand jury - new JV victims came to light 4/29/22 with same suspect, passed information to Florence PD for investigation.*

2022-03064 – Intimidating a participant in a participant in legal process – *charges signed with CDW office. Due to new information, waiting to hear from Co. Attorney if he wants to go forward with a search warrant on suspect home.*

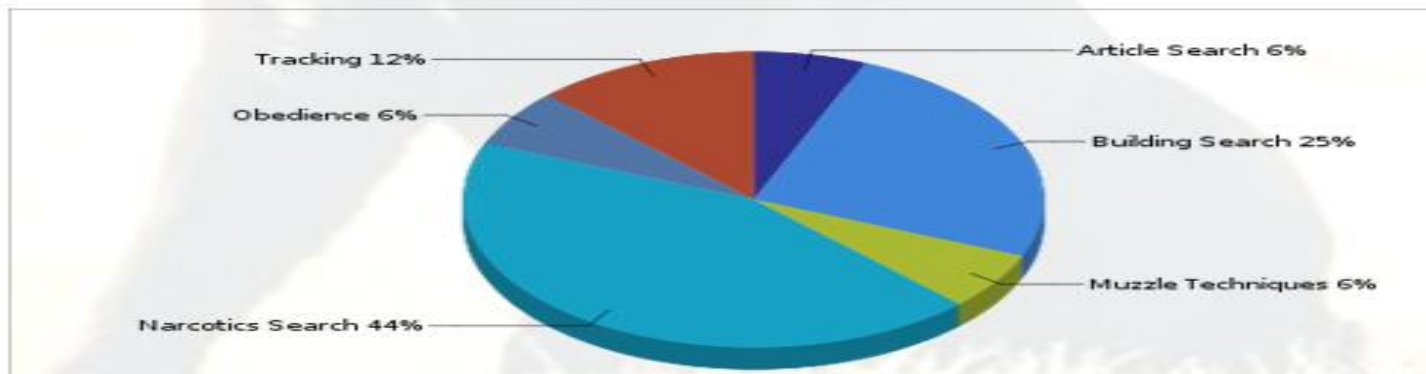
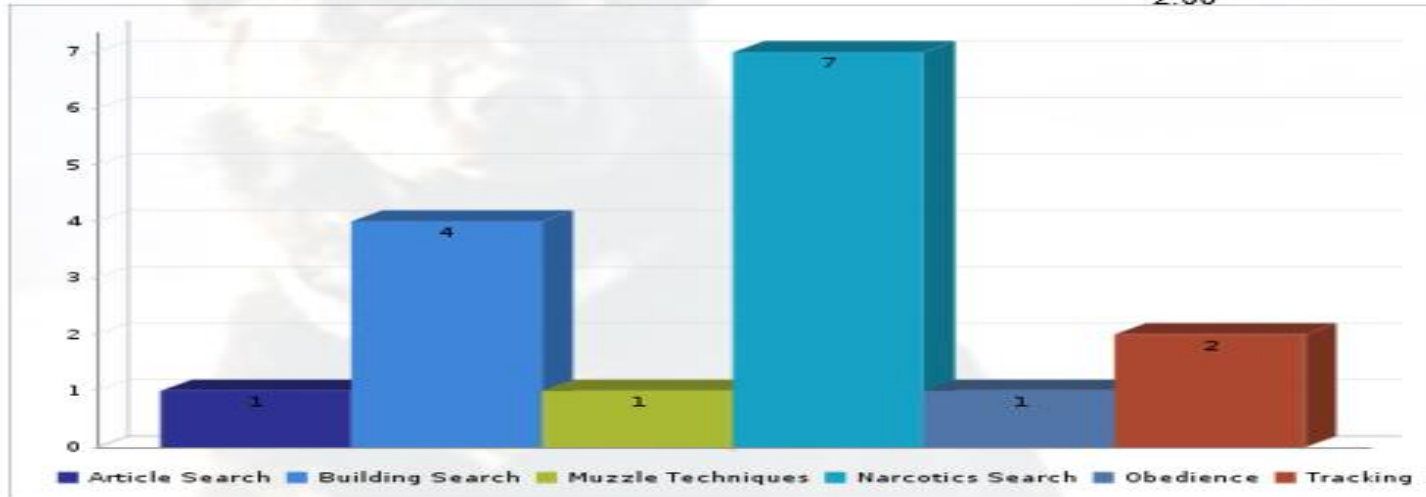

Notes: 2022-03482 we assisted the US Marshalls in Crescent Springs with a warrant arrest that K9 Onexx credited a no bite apprehension. We deployed for a track in Erlanger of an armed robbery suspect that resulted to be unfounded. We assisted Fort Wright with an armed robbery at Arby's and clearing the building after the workers were locked in the freezer by the suspect at gunpoint. I managed to have several narcotics arrest for meth and seized a handgun from a convicted felon this month. K9 Onexx did not credit any of those arrests due to not being needed for probable cause during those traffic stops.
