AN ORDINANCE OF THE CITY OF VILLA HILLS, IN KENTON COUNTY, KENTUCKY, AMENDING SECTIONS 74.30 STREETS WITH NO PARKING AND 74.31 STREETS DESIGNATED WITH FIRE LANES TO ADD THE STREETS AND ALLEYS IN THE SANCTUARY VILLAGE SUBDIVISION.

Be it ordained by the City Council of the City of Villa Hills, Kentucky, as follows:

SECTION I

Section 74.30 of the Villa Hills Code of Ordinances is hereby amended to add the following streets and retain its other provisions:

§ 74.30 STREETS WITH NO PARKING

Allegheny Way	Both	Alley
Honeylocust Way	Both	Alley
Sourwood Way	Both	Alley
Sweetgum Way	Both	Alley
Pawpaw Way	Both	Alley
Sugar Maple Way	Both	Alley
Walburg Ave	Both	<u>Island between Amsterdam Road and Buckeye Court</u>

SECTION II

Section 74.31 of the Villa Hills Code of Ordinances is hereby amended to add the following streets in the appropriate alphabetical position and retain its other provisions:

§ 74.31 STREETS DESIGNATED WITH FIRE LANES

The following streets are designated as having fire lanes where parking at all times is prohibited. Fire lanes are to be used by emergency vehicles only.

Shellbark Cir.	East/North/West	Inside lane of circle
Walburg Ave.	West/East	West side from [Amsterdam Road] <u>Buckeye Court</u> to Willow Oak Dr. East Side from [Willow Oak Dr.] <u>the north end of Honeylocust Way</u> to White Pine Dr. West Side from White Pine Dr. to River Birch Dr.
White Pine Dr.	North/ East	North side from the cul-de-sac through the bend west past Shadbark Ln. East side from Shellbark Cir. To the bend just west of Shadbark Ln.
Willow Oak Dr.	South/North	[South side from Walburg Ave to Billiter Dr.] North Side from Billiter Dr. to Shadbark Ln. South Side from Shadbark Ln. to White Pine Dr.

SECTION III

If any sentence, clause, section or part of this ordinance or the application thereof to any particular situation is, for any reason, found to be unconstitutional, illegal or invalid, such cannot effect or appeal any of the remaining provisions, sentences, clauses or sections or parts of this ordinance.

SECTION IV

All ordinances, in conflict herewith, are hereby repealed.


SECTION V


