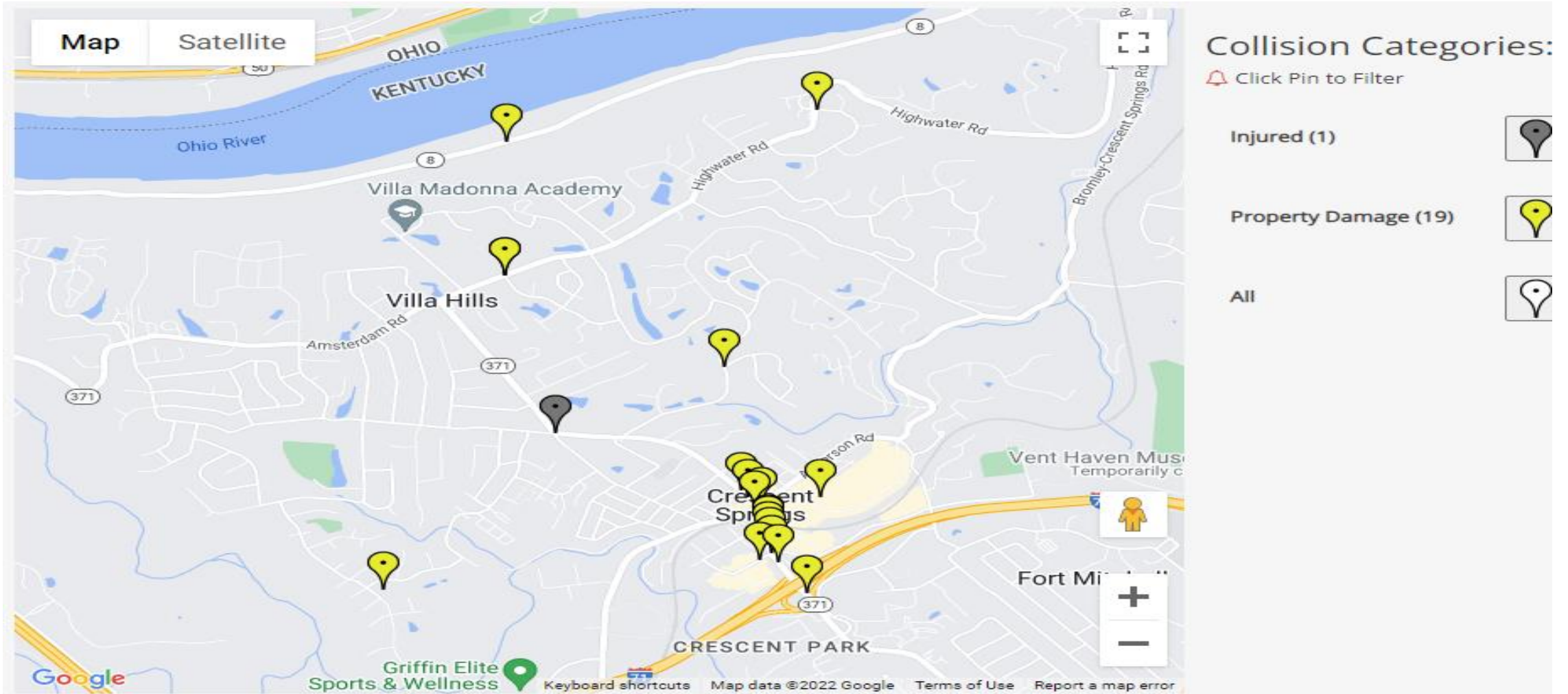
Citations Crescent Springs
