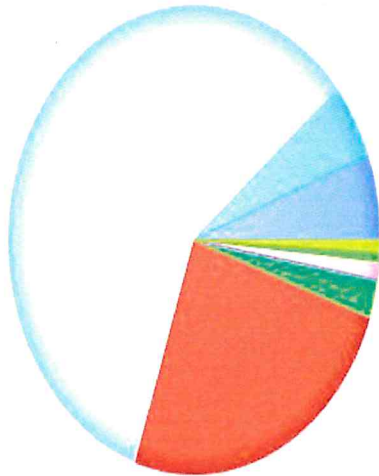
August 2022 Monthly report

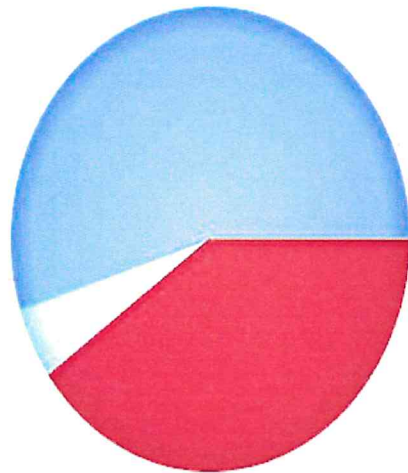

Investigations

- **2022-03506 (Wanton Endangerment 1st, Criminal Mischief)**
- - Waiting on for evidence at the lab.
- -CASE ONGOING
- **2022-03631 (Sex Abuse 1st minor U/12, Prom a minor is sex performance)**
- -Subject confessed and has been in jail since 04/21/22.
- -Pretrial conference for plea or trial determination was set for 07/25/22 but rescheduled to 08/05/22.
- -Commonwealth has said they are going forward with all charges.
- **-08/30/22 GUILTY PLEA, FINAL SENTENCING 10/17/2022**
- **2022-04439 (Rape 1st)**
- - After review of juvenile victim's comments in the CAC interview, the charges were changed to Rape 1st.
- - Snap Chat Warrant received and reviewed.
- - Brought guardian and juvenile victim in for another interview.
- - Interviewed Holy Cross school counselor and Assistant Principle since this was disclosed at school.
- - Located and interviewed/interrogated juvenile suspect with guardians present.
- - When the interrogation process began, guardian advised they wanted a lawyer, interview was stopped.
- -Spoke to Commonwealth about my findings.
- -Once I speak with all involved parties and advise them that the evidence is not there, all charges will be dropped, and case will be CLOSED.
- **- 08/02/2022 CASE CLOSED NO CHARGES PER COMMONWEALTH, VICTIM PHONE RELEASED TO OWNER, ALL PARTIES MADE AWARE OF OUTCOME.**

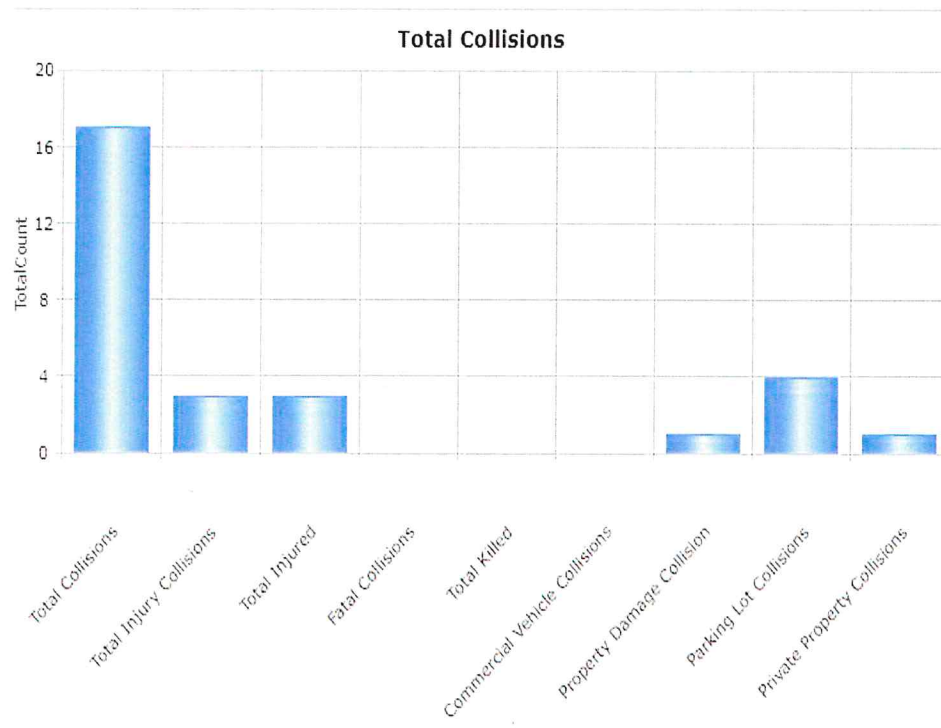
Investigations Cont.

- **2022-04897 (Theft of Firearm)**
- -Spoke with suspect. Has a different story than victim.
- -Attempting to interview victim again, not sure he is telling the truth. His story doesn't add up.
- -Victim has yet to come in for another interview, will keep trying.
- **2022-05785 (TBUT <1,000)**
- -Unknown subject met on Facebook Marketplace to buy an Ipad.
- -Suspect paid 700 dollars with fake money.
- -Suspect used a fake name and fake Facebook pictures.
- -Checked Leads Online multiple times with no success.
- -Case CLOSED, no charges.
- **2022-06558 (Unlawful Transaction w/ a Minor)**
- -Officer Dooley made a traffic stop on a 42-year-old male who is a registered sex offender. He had a 14-year-old female in the vehicle with him. Both subjects advised they met on Snap Chat.
- -Suspect phone sent to FBI Louisville for download. Scheduled pick up is 08/01/2022.
- -CAC interview for victim scheduled for 08/03/2022. Had a previous interview scheduled but it was agreed upon to reschedule due to victim and victim's mother being uncooperative.
- -Mother was brought in and advised about how the man her daughter was with is a sex offender.
- -Mother became cooperative.
- -Sent victim phone to be downloaded. Received downloaded phone.
- -Multiple sexual messages between suspect and victim.
- -Commonwealth is reviewing all evidence; at this point we are looking at Unlawful Transaction with a Minor.
- -Suspect is still in jail.
- **2022-007291 (TBUT >1,000)**
- -TBUT from T-Mobile, three black males entered the store, and one black male took two iPhone 13 Pros.
- -Received video footage from T-Mobile, shows three males walk in seconds after each other.
- -Checked Leads Online multiple times no success.
- -Uploaded suspect photographs from video to SwopIntel with no success in ID'ing suspects.
- -Case Ongoing
- **2022-07365 (TBUT<500, Fraudulent use of credit card, Receiving stolen property, Stolen credit)**
- -Theft of cell phone and wallet from Esporta Fitness.
- -Watched video from Esporta, observed the thefts.
- -Located suspect selling stolen phone on Leads Online.
- -ID'd suspect and matched description from Esporta.
- -Watched video from CVS Pharmacy in Erlanger from stolen credit card use.
- -Same suspect from Esporta and Leads Online.
- -Obtained phone number of suspect tried to set up interview, he declined.
- -Warrant arrest filed and signed.
- -Awaiting arrest.

Investigations cont.

- **2022-08252 (Rape 1st)**
- -Called in due to Rape occurring at 611 Western Reserve Rd in a vehicle.
- -Interviewed victim.
- -Patrol did all the leg work and located a suspect who worked at DHL.
- -Watched all surveillance video.
- -Picked up suspect from DHL w/ Sgt. Brockman
- -Towed vehicle to VHPD lot.
- Interviewed/Interrogated suspect and gained a confession.
- -Arrested for Rape 1st subject still in jail.
- -All evidence logged into evidence room.
- -Speaking with Commonwealth, will add Kidnapping or Unlawful Imprisonment at Grand Jury.
- -Prelim on September 8th
- **REOPENED CASE:**
- **Wong Residence Burglary**
- -Located 4 possible suspects who were involved in a stolen limo from Oriental Wok.
- -Listened to jail calls of suspects, they all speak Spanish.
- -Checked Lead Online multiple times for stolen items with no luck.
- -These leads fell through, will most likely inactivate case this month

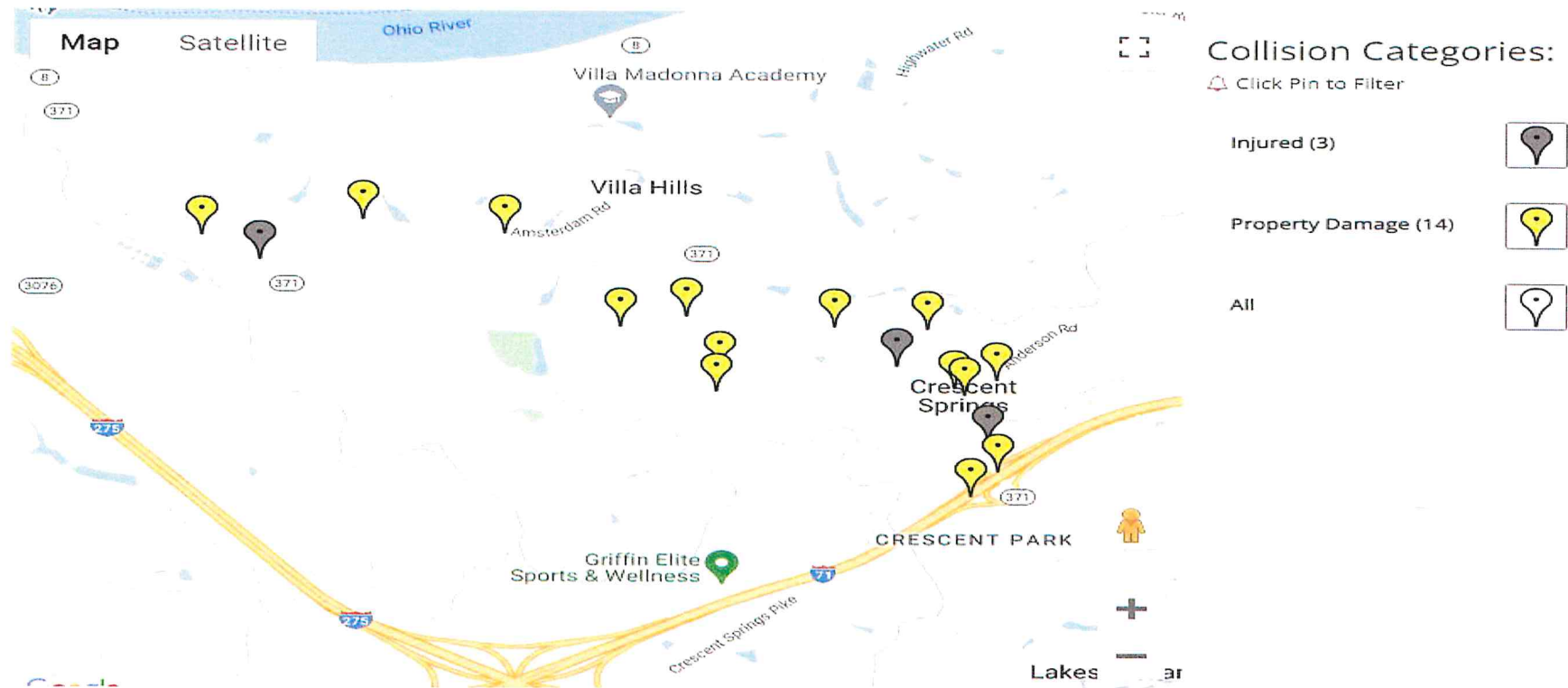
Total Collisions



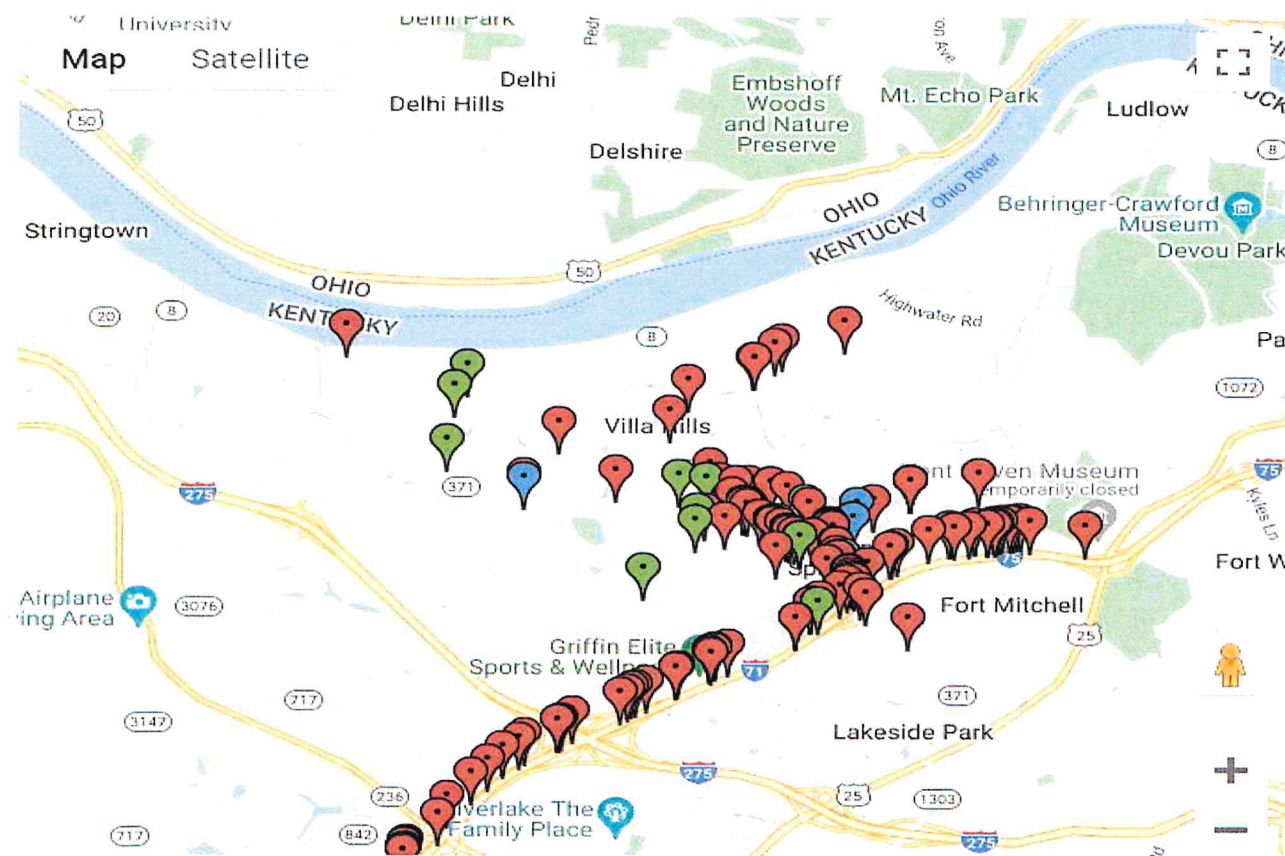

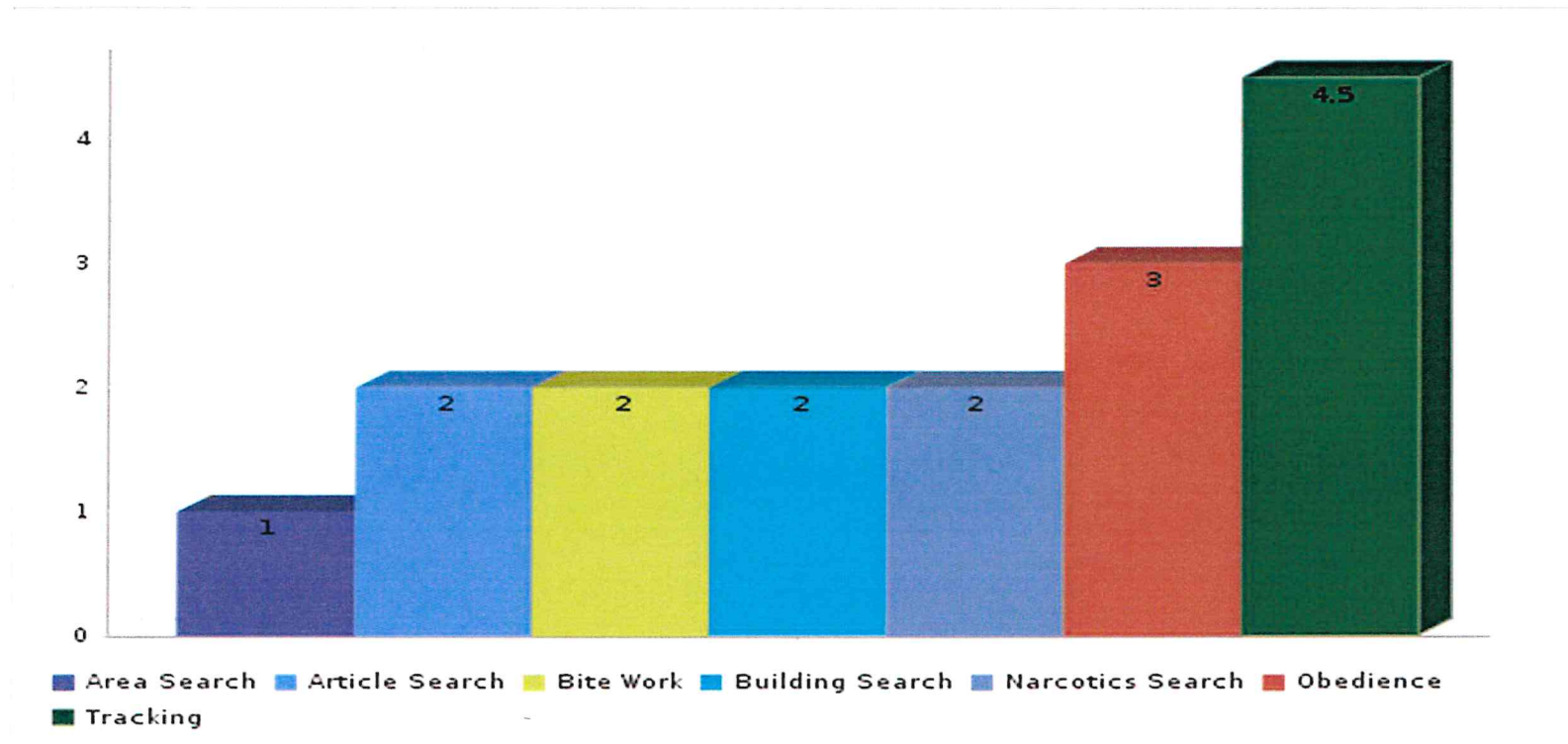
