

## CITY OF VILLA HILLS, KY APPLICATION FOR PEDDLERS, ITINERANT MERCHANTS AND SOLICITORS

Chapter 94, City of Villa Hills Code of Ordinances

All Peddlers, Itinerant Merchants and Solicitors operating within the corporate limits of the City of Villa Hills are required by ordinance to register with the City prior to engaging in solicitation of any resident or business within the City.

Registration requires a completed application and payment of registration fees. Peddlers, Solicitors, and Itinerant Merchants must follow these guidelines:

- Pay a \$20.00 registration fee per application for the calendar year in which it is issued.
- Prominently carry a City License at all times and show license during peddling/soliciting activity.
- Produce a government issued photo ID.
- Restrict hours of solicitation to 10:00 am to sunset but no later than 7:30 pm local time or until dusk, whichever is earlier.
- It shall be illegal for any peddler, solicitor or itinerant merchant to go upon any property that the owner or resident has posted a "No Soliciting" sign or "No Knock" sticker.

## Standards of Issuance

Upon receipt of an application which complies with all requirements of Chapter 94, the City Clerk shall issue a license, identifying each solicitor or peddler by name and address. Peddlers and solicitors shall carry license at all times while peddling or soliciting within the City, and shall show license to residents prior to or simultaneous with any peddling and/or soliciting activities.

A license will be granted unless the City finds that granting such a license will pose a substantial threat to the health, safety, morals or general welfare of the public. Such denials may occur from fraud/misrepresentation, any violation of chapter 94, criminal conviction of any felony, or conviction of any misdemeanor involving moral turpitude, or conducting business in an unlawful manner or in such a way as to constitute a menace to the health, safety, morals or general welfare of the public

I hereby affirm that the submitted information is true and correct and that submitting falsified information in this application will be grounds for denial of the License or immediate revocation. I further understand that I must abide by all of the requirements set forth in Villa Hills City Ordinance Section 94 and any and all other City Ordinances while conducting business within the City.
