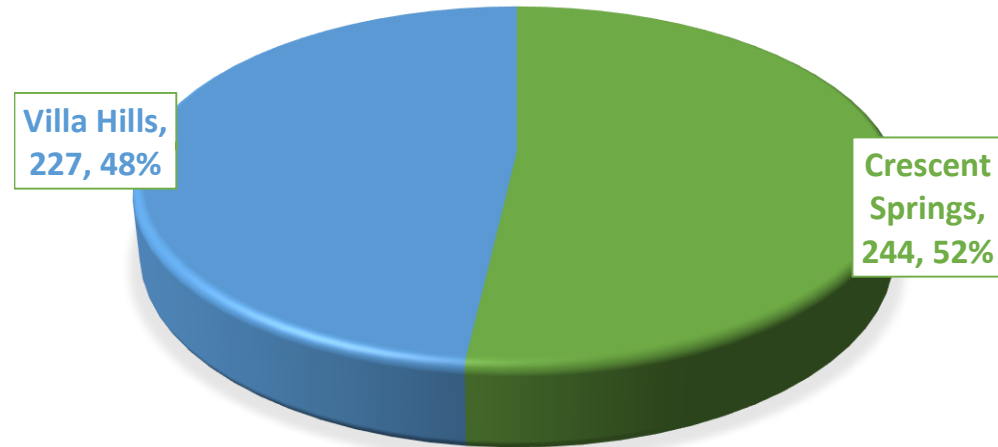

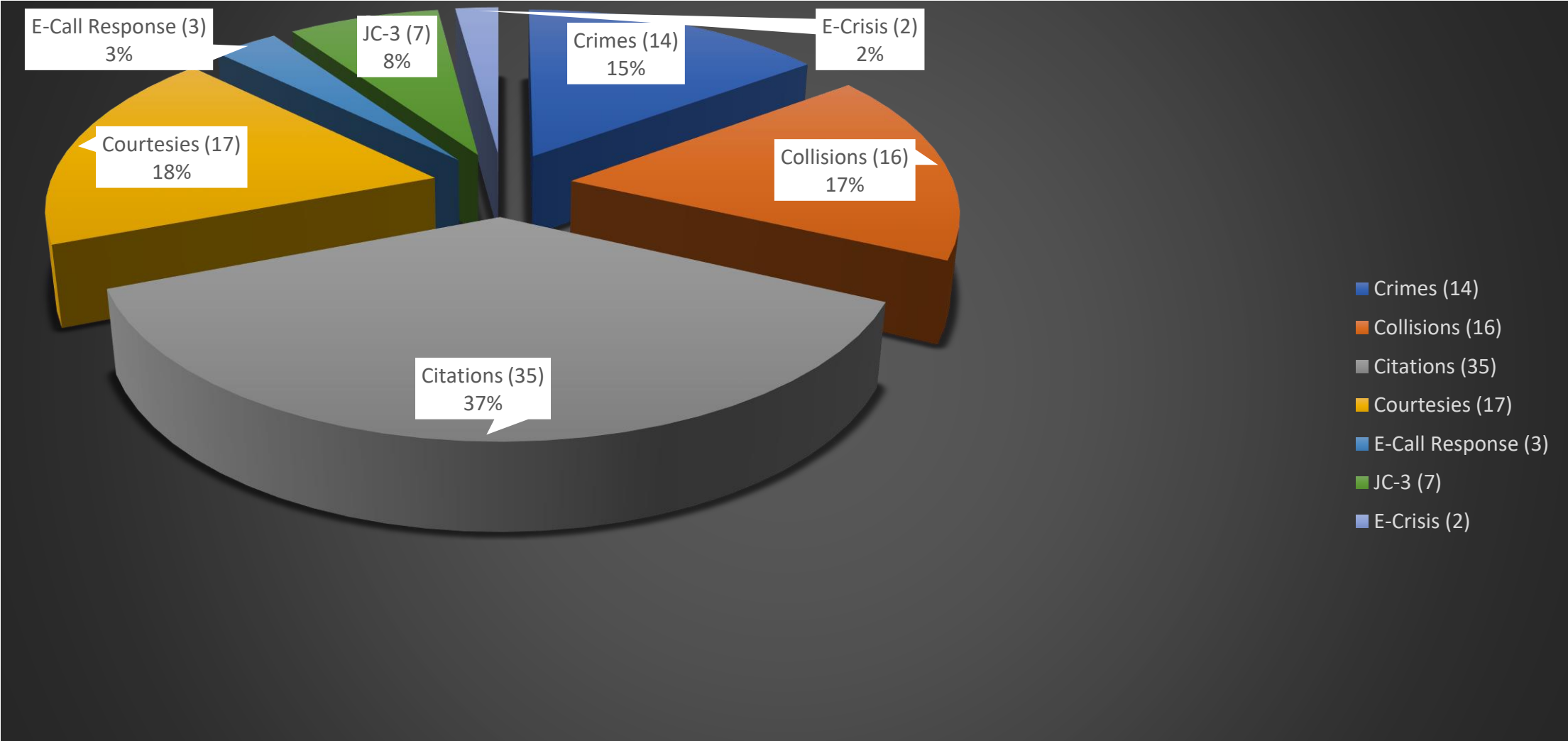

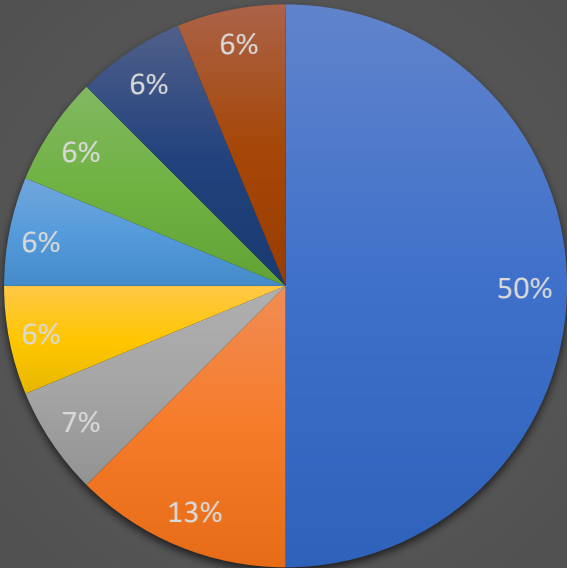

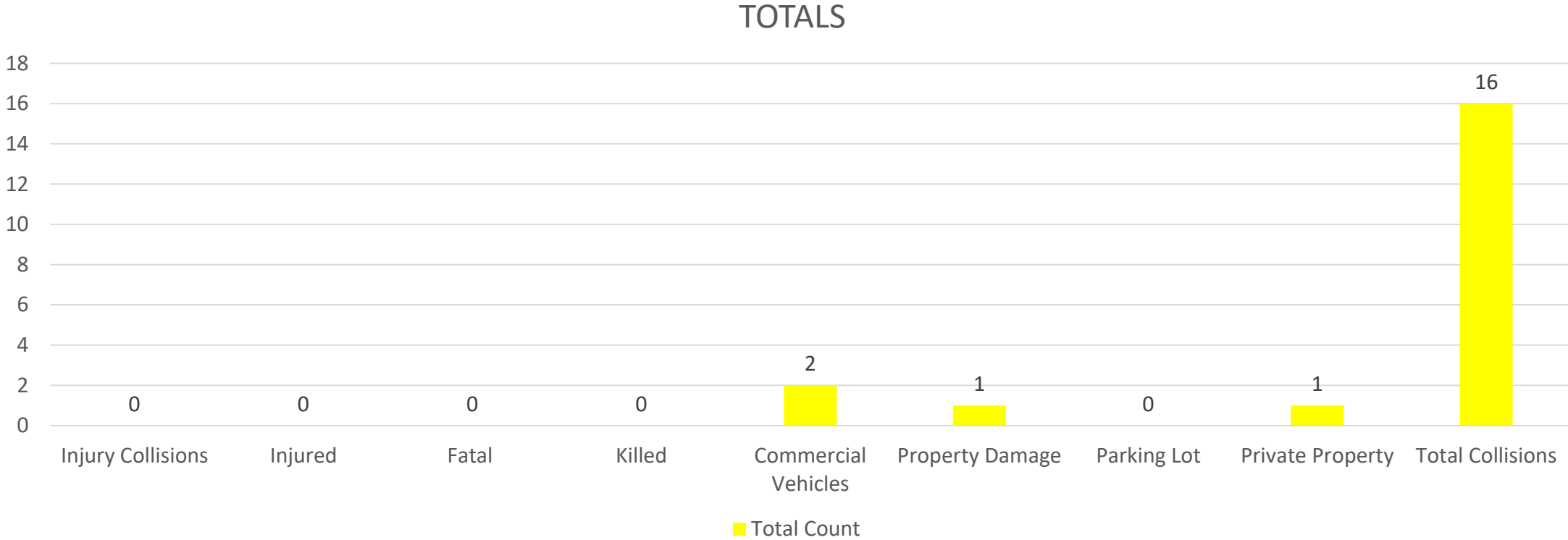
Top Roadway Collisions

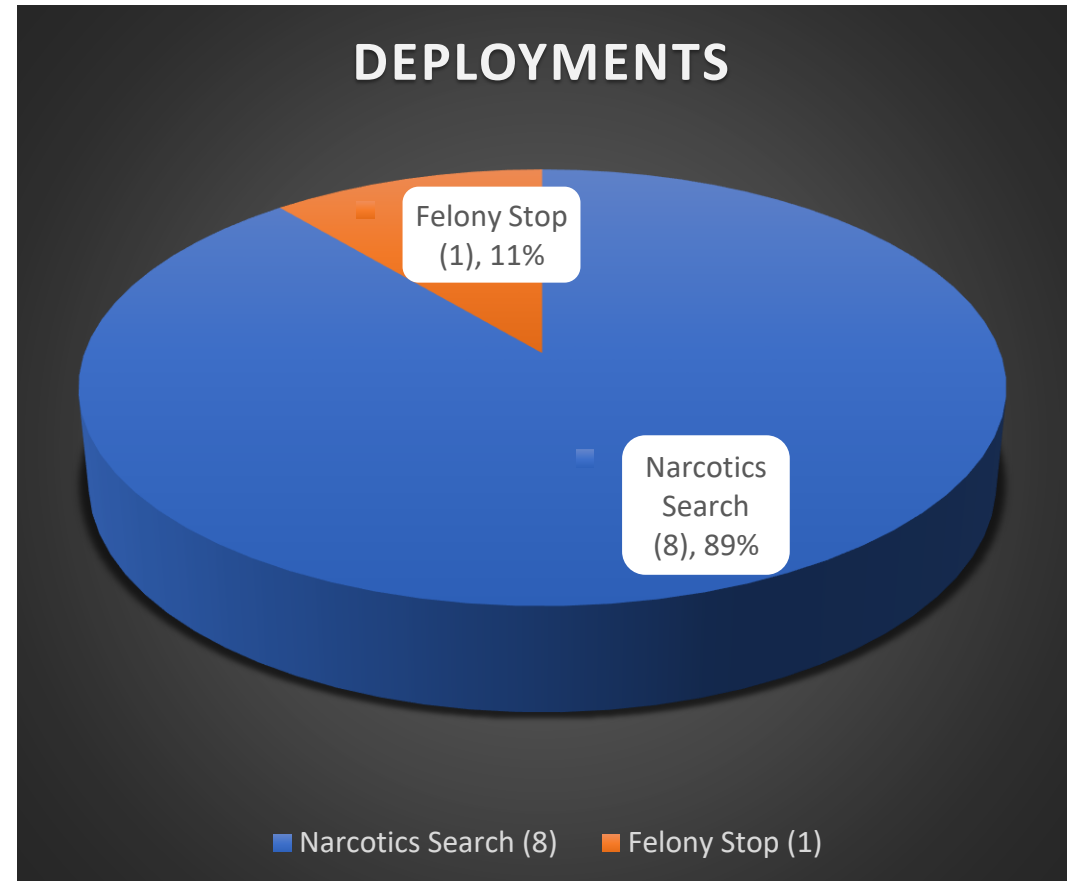

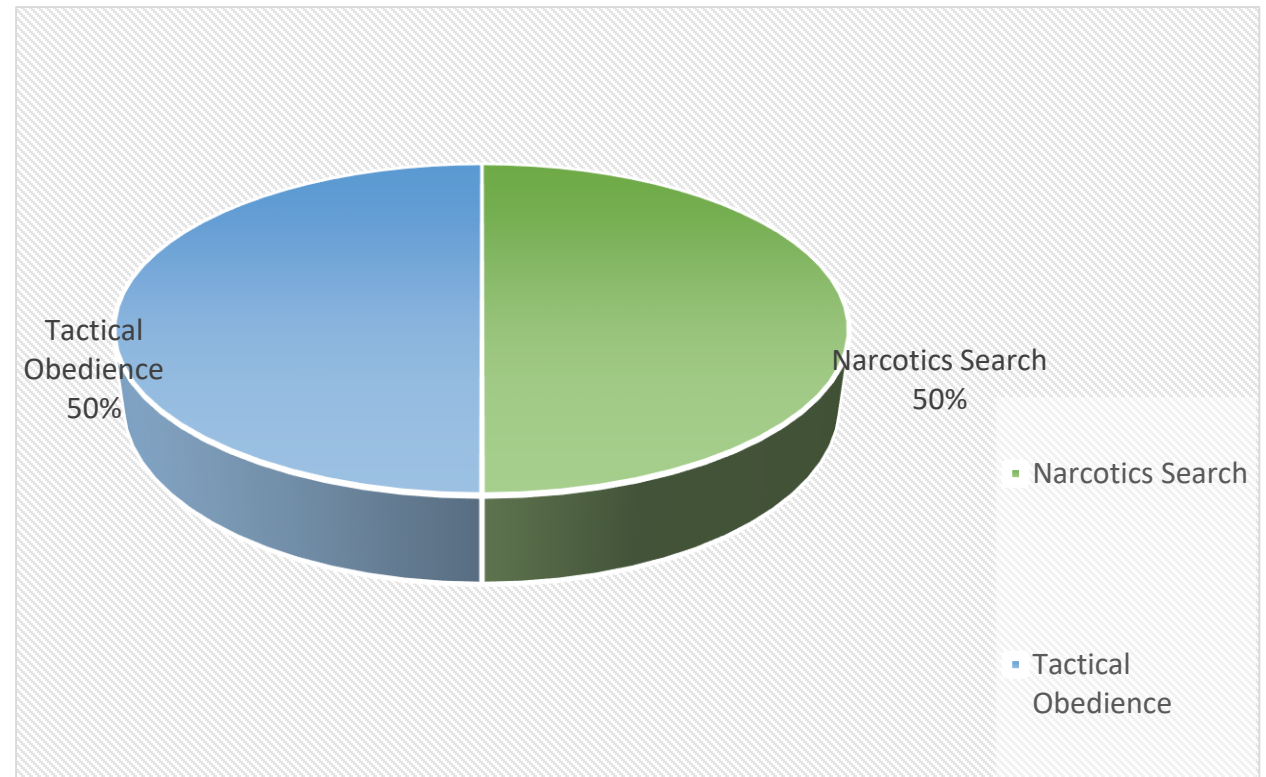

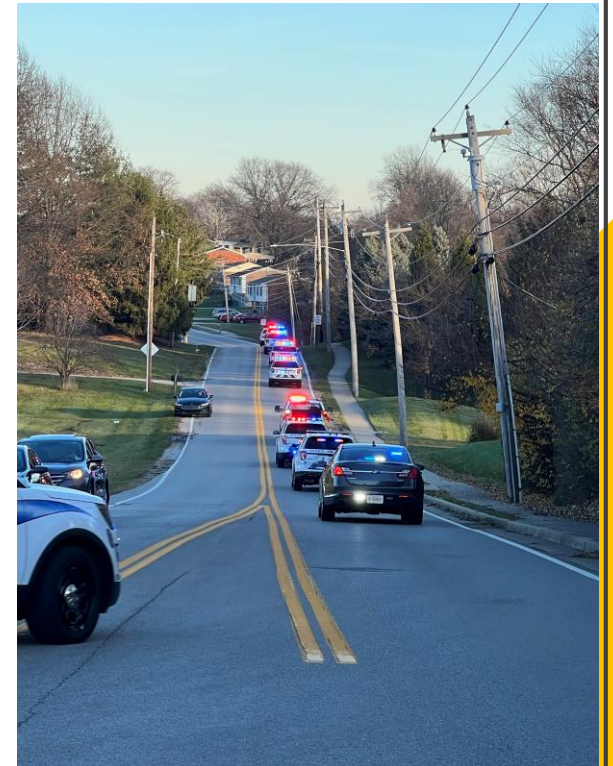
