



# FEBRUARY 2024 CALLS FOR SERVICE BY CITY


**ALL CALLS (INCLUDES SELF-INITIATED)** 

**DISPATCHED CALLS (EXCLUDES ALL OTHERS)** 











# CITATIONS by type


