As your Chief of Police, it is my goal to continue this honored tradition while utilizing the latest methods, technology, and theories in law enforcement to garner and propagate the expectation of excellence and distinction while advancing the public trust.

The Villa Hills Police Department proudly and honorably serves the communities of Villa Hills and Crescent Springs, as well as the citizens of Kenton County. Villa Hills is a community located within the northwestern portion of Kenton County. The Villa Hills community is approximately 4.35 square miles. Our small bedroom community is nestled in the hills of Northern Kentucky, above the Ohio River, and only 15 minutes from downtown Cincinnati, Ohio. We are conveniently located a short distance of 1.1 miles from the Interstate, which gives our residents easy access to entertainment, major sporting events, and hundreds of options for shopping and places for a night out. Our family-focused community boasts five (5) community parks, a responsive and efficient public works department, and a full-time, professional police department. Villa Hills is consistently ranked among the top 10 safest places to live in Kentucky, making it a special place to live.

The Villa Hills Police Department has entered into an interlocal agreement with the City of Crescent Springs to provide police services to all the residents, businesses, stakeholders, and visitors of Crescent Springs. Crescent Springs is located east of Villa Hills and is approximately 1.5 square miles with an estimated 4,100 residents. The community is comprised of residential, rental, retail, and office space. Crescent Springs is conveniently located along Interstate 75 making it the city “at the heart of it all.”

POLICE CONTRACT

As mentioned previously, the Villa Hills Police Department entered into an interlocal agreement in 2018 for contractual police services to the City of Crescent Springs. The partnership has been extremely successful for both cities with regards to the police services provided, response to calls for service, community outreach, and the overall quality of life for the residents. According to New Home Source in “Top 10 Safest Cities in Kentucky,” the city of Villa Hills was ranked as # 1 on the safest city in Kentucky for 2024. The current contract has been extended through 2030, however, a new addendum to the ILA starting in July of 2024 is that the cost paid from the City of Crescent Springs will be based on a list of factors (calls for service, population, property value assessments, etc.) and that translates to a corresponding percentage for the costs. This was agreed upon by both city councils to enable a fair and impartial payment for the services provided.

PERSONELL

The Villa Hills Police Department continues to evolve and utilize the assortment of abilities and training that the officers have received and will continue to receive. The police department utilizes a community-based approach to policing as well as an advanced intelligence-led philosophy. To increase the effectiveness and efficiency of the agency, trends and location crime hot spots are addressed and patrolled coupled with randomization of patrolling units. The police department is a total of fifteen (15) officers when fully staffed. This includes a Chief of Police, a vacant Lieutenant's position, two sergeants, one school resource officer, one full-time detective, a K-9 officer, with the remaining officers assigned to patrol.

GRANT FUNDING

The Villa Hills Police Department has received two separate grants from the Office of Highway Safety for traffic enforcement. The police department is part of a multi-agency traffic enforcement corridor grant for the I-75 and I-275 highway stretches from Covington through Erlanger.

- Office of Highway Safety General Traffic Enforcement Grant - \$10,000.00
- NHTSA I-75 Highway Safety Corridor Grant - \$17,000.00
- AED Grant for the City of Crescent Springs Administration Office - \$2,500.00

A grant for the potential addition of a drone unit has been applied for with the hopes of implementation in the next fiscal year.

CANINE (K-9) PROGRAM

The canine program consists of one K-9 officer coupled with his partner, Onexx. Officer Dooley is assigned as the handler and provides a great asset to the residents and is considered as one of the highest rated K-9 Teams in the northern Kentucky region as well as the State of Kentucky. The canine unit received its annual recertification through NAPWDA and attended the Ark Encounter Conference where he was rated as the top canine performer. Officer Dooley and K-9 Onexx transitioned from the FBI Safe Streets Task Force in the early months of 2023 to a part-time position with the Northern Kentucky Drug Strike Force. The canine unit is credited with seizing over 35,000 grams of marijuana, over 40 grams of cocaine, 2,602 grams of methamphetamine, several other variations of narcotics, and over \$50,000 in U.S. currency.

THREE YEAR PLAN

Kentucky Association of Chiefs of Police Accreditation

The Villa Hills Police Department will continue the process for Accreditation which is due for renewal in June 2024. The police department purchased new PM/AM HCM software for policies and procedures input and comparison to the standards associated with accreditation.

Property and Evidence Room Management

In July of 2023 the police department purchased a new Evidence Room Management System through Tracker Products. The SAFE System is a cloud-based software system that utilizes the newest technology for inputting, inventory, and processing property and evidence. A complete audit of all items in the property and evidence room is expected to be completed by May 2024.

Canine K-9 Unit Future

K-9 Onexx will celebrate his 7th birthday in 2024. The general expectation for working dogs in law enforcement is between 7-10 years of service and as such, Onexx is in the latter stages of his career. Nevertheless, Onexx continues to excel and perform at the highest level. The police department will begin assessing the future purchase of a new canine in the fiscal year 2025-2026, ultimately starting to budget savings for the procurement of a new canine officer. A selection process for a new handler will be established through testing, interviews, and assessment.

Vehicle and Fleet Procurement

Through a variety of issues correlated to COVID and the auto industry, the availability of Ford Explorers for law enforcement became an issue in the years past. Due to a diminishing fleet through expensive repairs and vehicular collisions, the department has purchased four (4) Dodge Durangos for the vehicle fleet. All four vehicles have been purchased and outfitted and are currently in service. Upcoming costs will dictate the vehicle type for the fleet as the police department will ultimately be the most fiscally responsible.

Axon Fleet Cameras, Tasers, and Body Cameras, Firearms

All patrol vehicles will have the newest Axon Fleet cameras installed in the vehicles by April 2024. This is a 10-year service contract that will extend to the year 2034 with hardware and software updates every five (5) years. The current body camera contract is up for renewal in 2026. A proposed new contract to include the purchase of fifteen (15) Taser 10s from Axon along with

renewal of the body cameras has received a positive outlook and will hopefully be included in the FY 2024-2025 annual budget. This is another 10-year service contract that extends until 2034.

The police department currently utilizes the Glock 17 9MM service weapon as its primary weapon. These weapons are 4th generation Glocks and almost 10 years old. The department will utilize asset forfeiture to purchase new weapons and weapon-mounted optics to improve shot efficiency and accuracy. The Villa Hills Police Department will be at the forefront of advanced technology when it comes to firearms.

Criminal Investigations

Detective Lucas currently is assigned as a full-time investigator and is assigned to the Kenton County Arson Task Force. Detective Lucas is slated to attend the 10-week Criminalistics Academy offered through the Department of Criminal Justice and Training. Detective Lucas will be the Villa Hills Police Department's first graduate of the Criminalistics Academy.

Health and Wellness

Sergeant Brockman is a member of the KYPCIS (Post Critical Incident Seminar) and is also a member of the newest Peer Support Group in Northern Kentucky. The Chief of Police provides each officer a subscription (at his costs) the BCPS Lighthouse App to offer 24/7 assistance, self-assessments, peer support and more. The police department provides physical fitness training equipment that is located at the new Crescent Springs Villa Hills Fire Department for use 24/7.

Supervisor Development

There is a current vacancy for the Lieutenant's position which is a position that was created to support and assist the Chief of Police in matters of administrative necessity as well as a dayshift supervisor role. Chief Hall was previously the Lieutenant before the appointment to the Chief of Police in January 2023. The department will continue to foster internal growth and leadership with the command staff to be able to better prepare and test for that position when it becomes available in the next couple of years. Requirements of that position are set forth in policy as well as standards by the Mayor and City Administrator to include completion in an Executive Command School.

Sergeant Brockman completed the 3-week Academy of Police Supervision at DOCJT. Sergeant Black is scheduled for his attendance to the course in 2024. Sergeant Brockman continued his education and training with the completion of Values Based Leadership. Sergeants will continue their development with courses through DOCJT, the FBI LEETA courses as well as the future attendance to either the FBI National Academy, Northwestern Command School, or the University of Louisville's Southern Police Institute (SPI) Administrative Officers Course.

Chief Hall completed the Orientation of New Police Chiefs and Sheriff's course in 2023 and is scheduled to attend the 2024 Session of Police Executive Command Course. Chief Hall is being nominated by Crescent Springs City Administrator Mike Daly and Villa Hills City Administrator Craig Bohman for attendance to the Northern Kentucky Chamber of Commerce Leadership Northern Kentucky Class of 2025.

New Police Department Building

The Villa Hills Police Department has quickly outgrown the building that it currently utilizes. There are potential structural and flooding hazards that have been noted in the past. The space has served the community for decades with numerous and repeated upgrades over the years to accommodate the needs of the agency. Early discussions and ideas will hopefully take root in the next few years to develop and either build, raise, or upgrade a newer police department that will ultimately provide the highest level of security, technology, and improve the effectiveness of the police department to maintain the highest level of professionalism and to continue excellence.



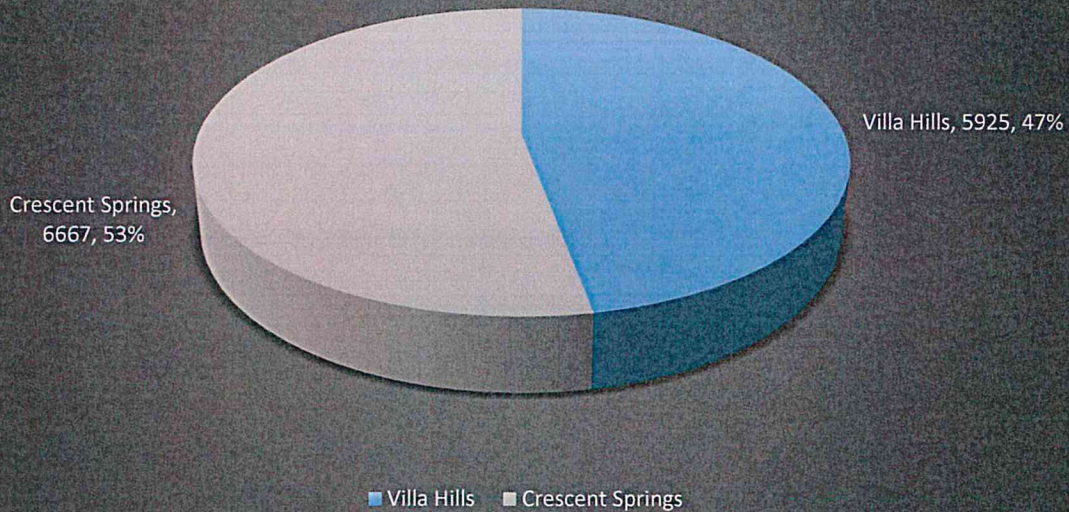

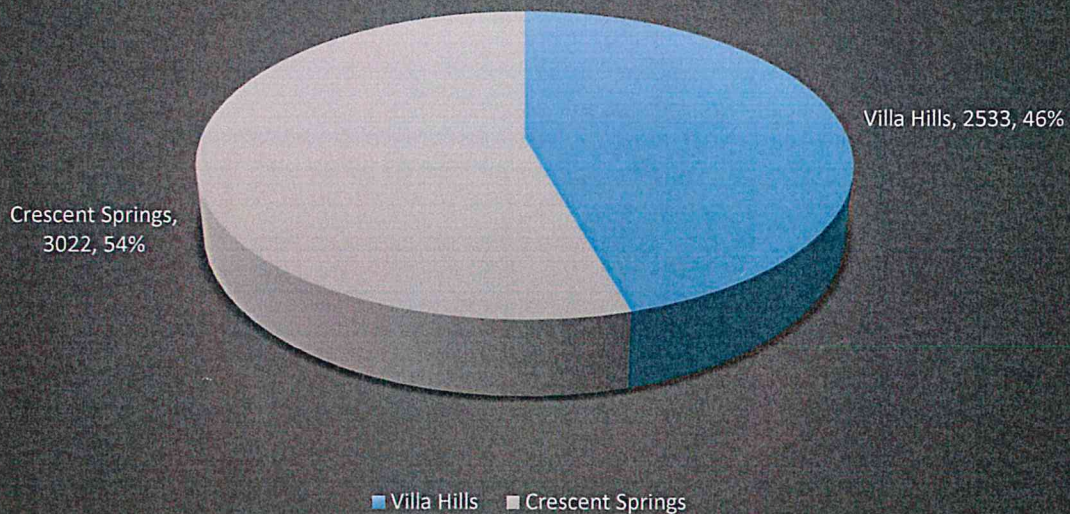

Criminal Investigation Unit 2023 Yearly Report

Detective Lucas completed his first full year as the Detective for the City of Villa Hills. Detective Lucas investigated roughly 55 cases for the City of Villa Hills, 10 cases for the Kenton County Fire Investigation Team, 4 surrounding agency assists, and 3 new hire background investigations. A breakdown of each case outcome is below.

Open Cases Investigated From 2022:

2022-03506 (Wanton Endangerment 1st, Criminal Mischief): Case Closed, Prosecutor did not pursue charges.

2022-11625 (Arson 1st): Case Closed, suspect did not confess and no other evidence was located.

Cases Investigated 2023:

2023-00138 (TBUT <500): Case Closed, the suspect could not be identified.

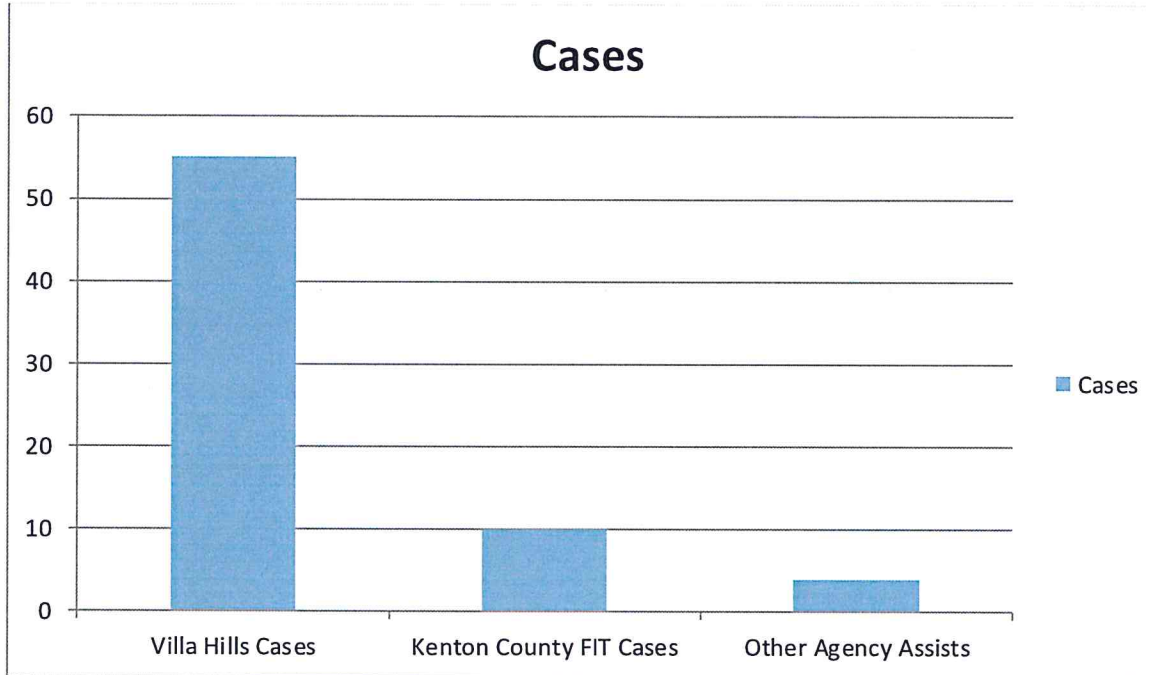
