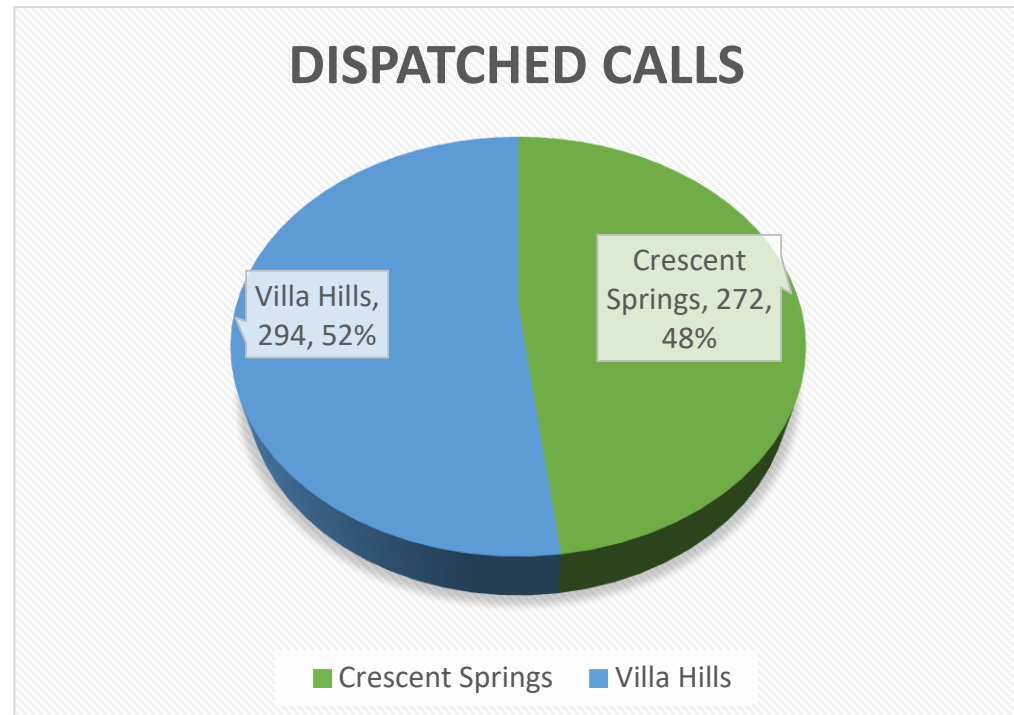

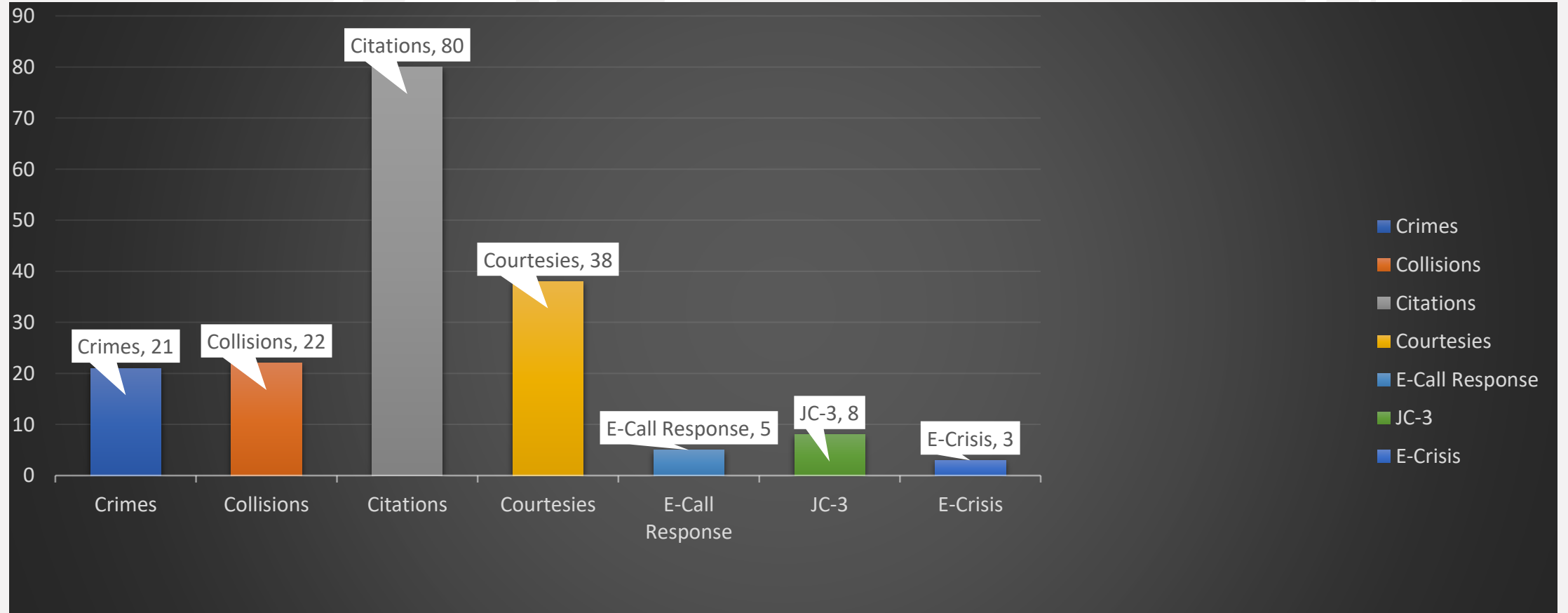
APRIL 2024 CALLS FOR SERVICE BY CITY

DISPATCHED CALLS (EXCLUDES ALL OTHERS)

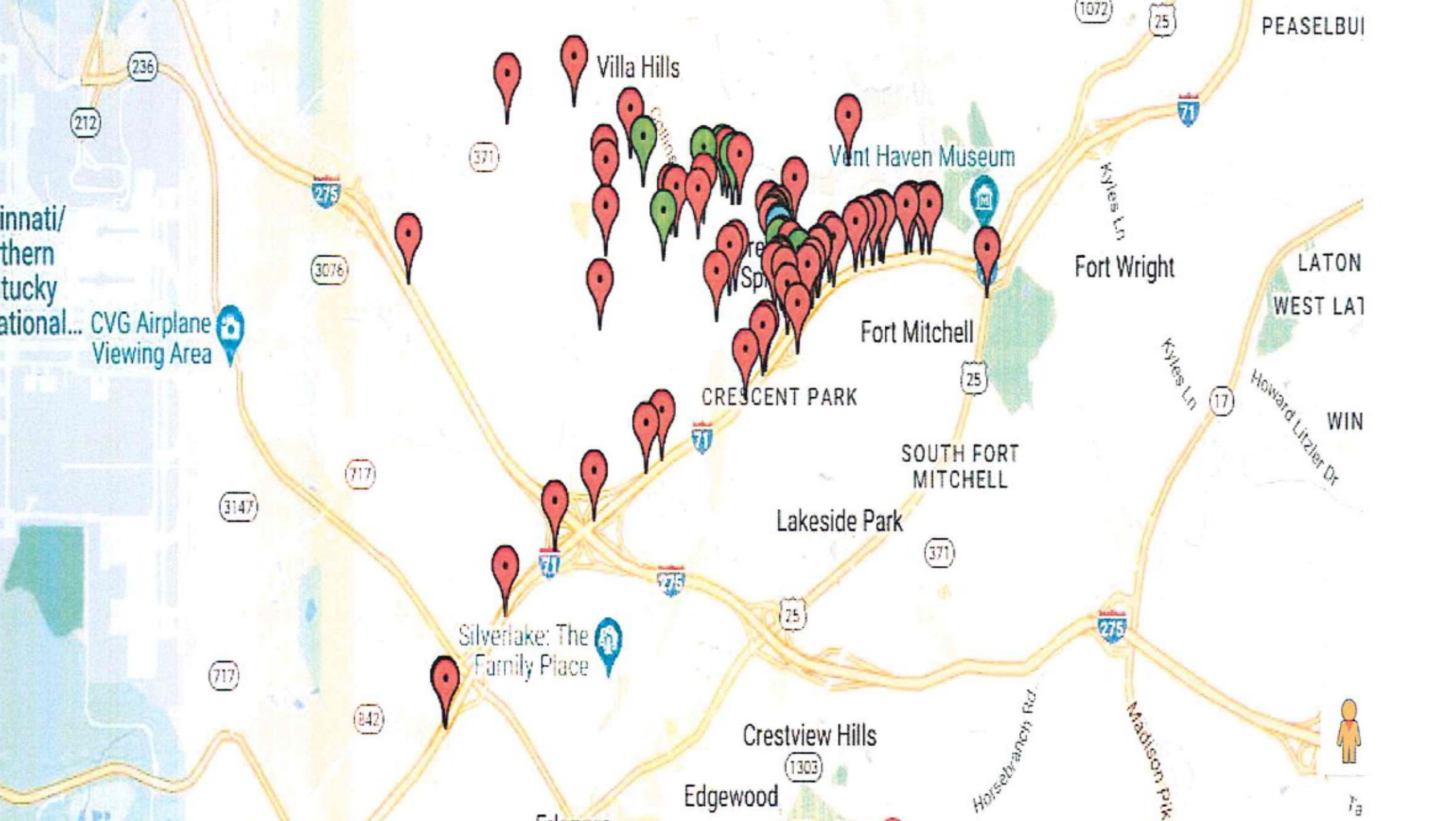

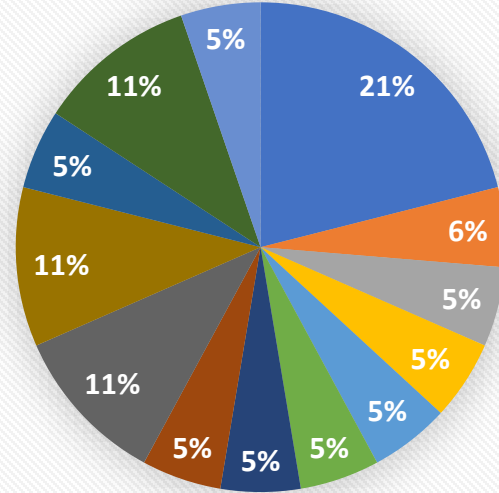


CITATIONS BY TYPE



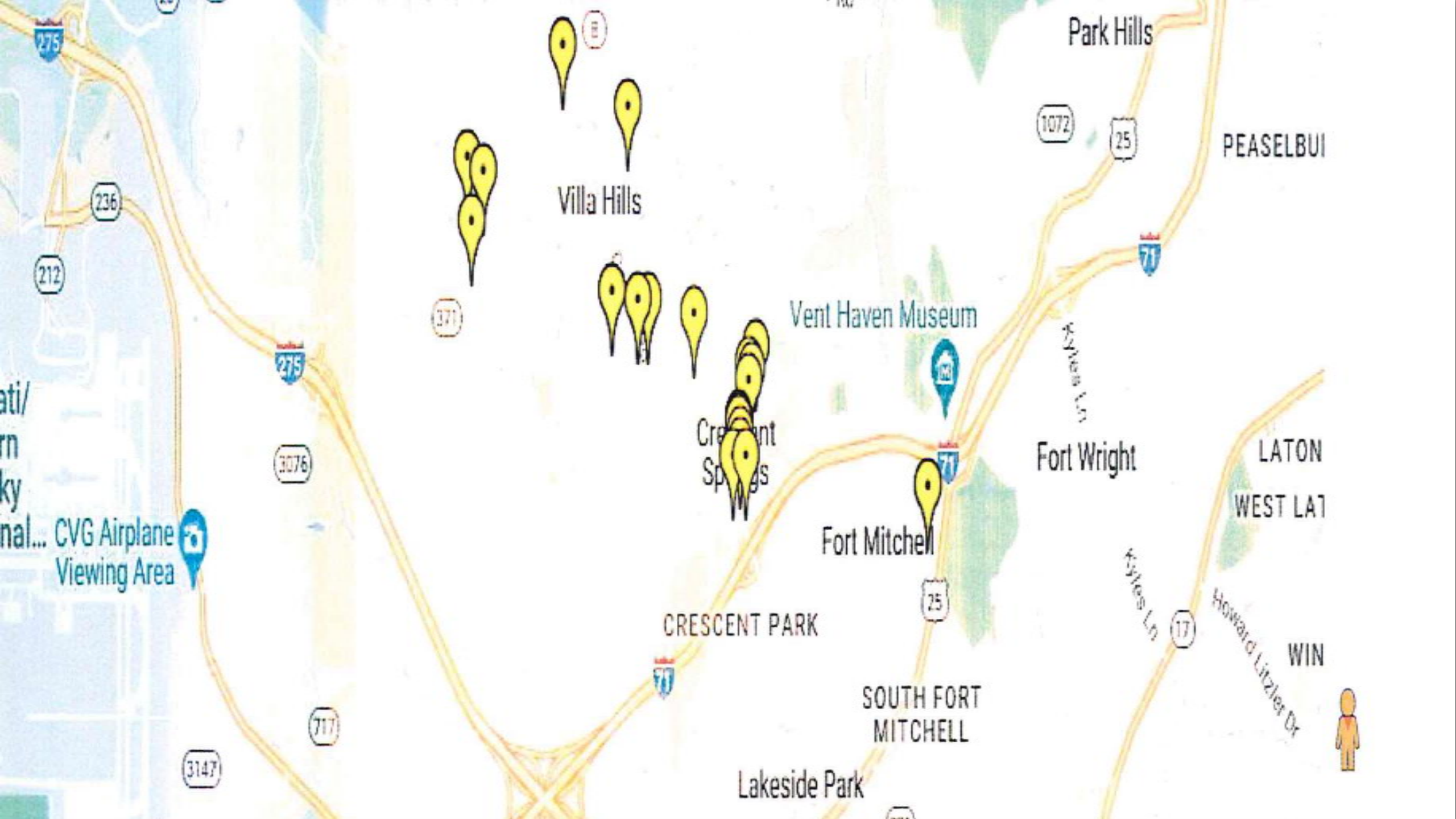

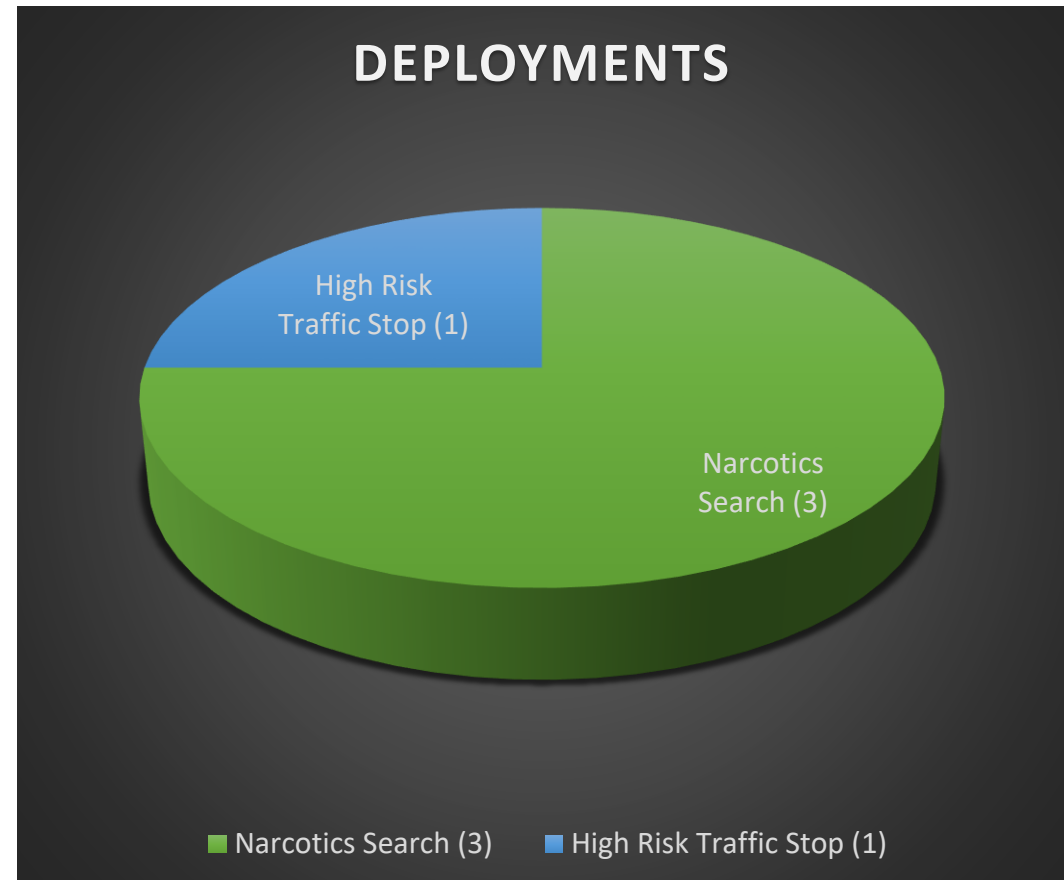

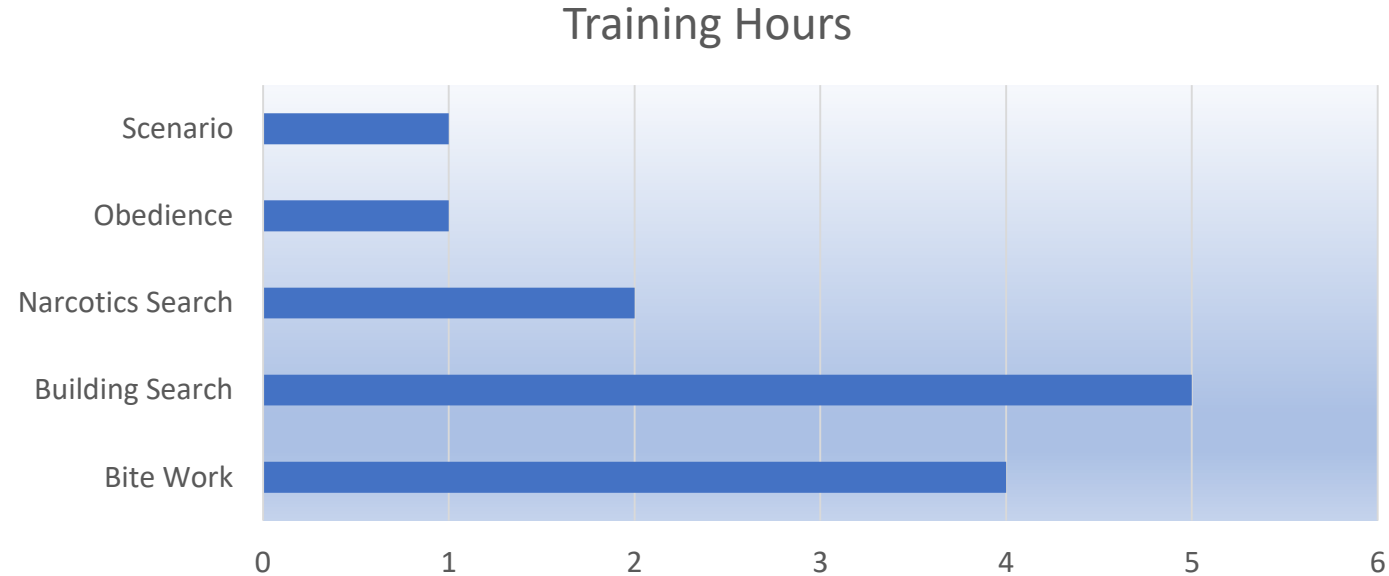
