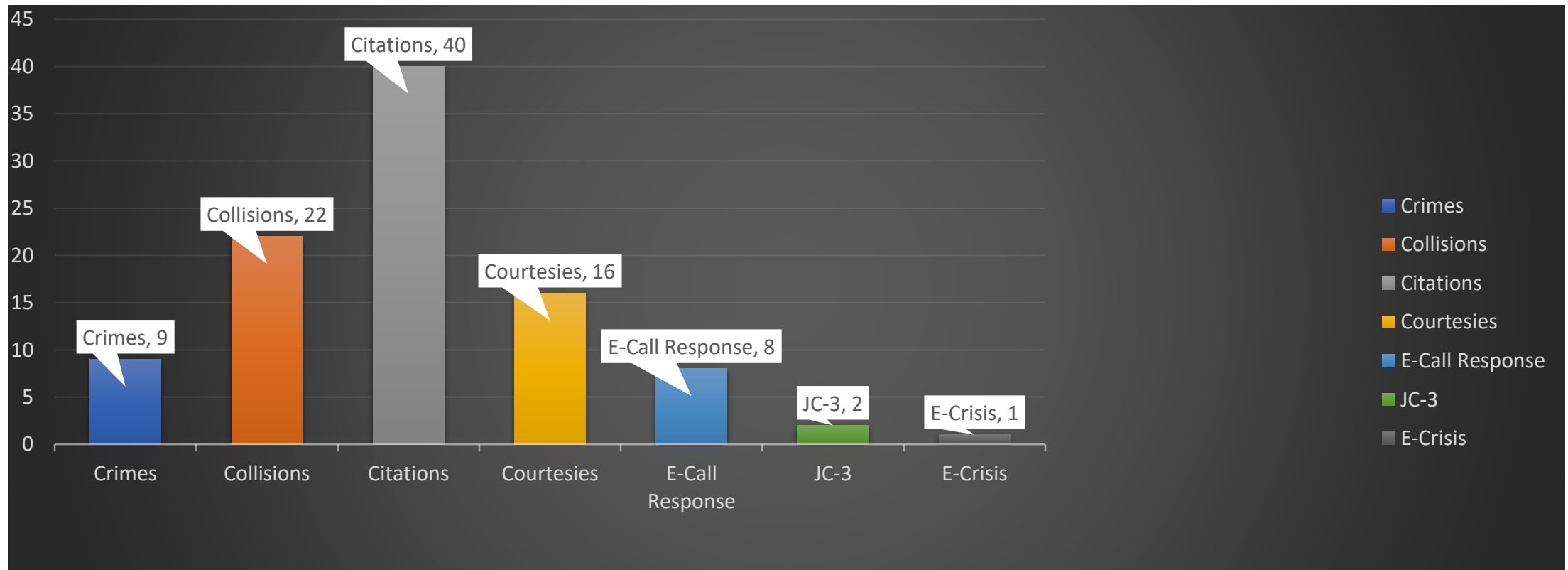
# JULY 2024 CALLS FOR SERVICE BY CITY

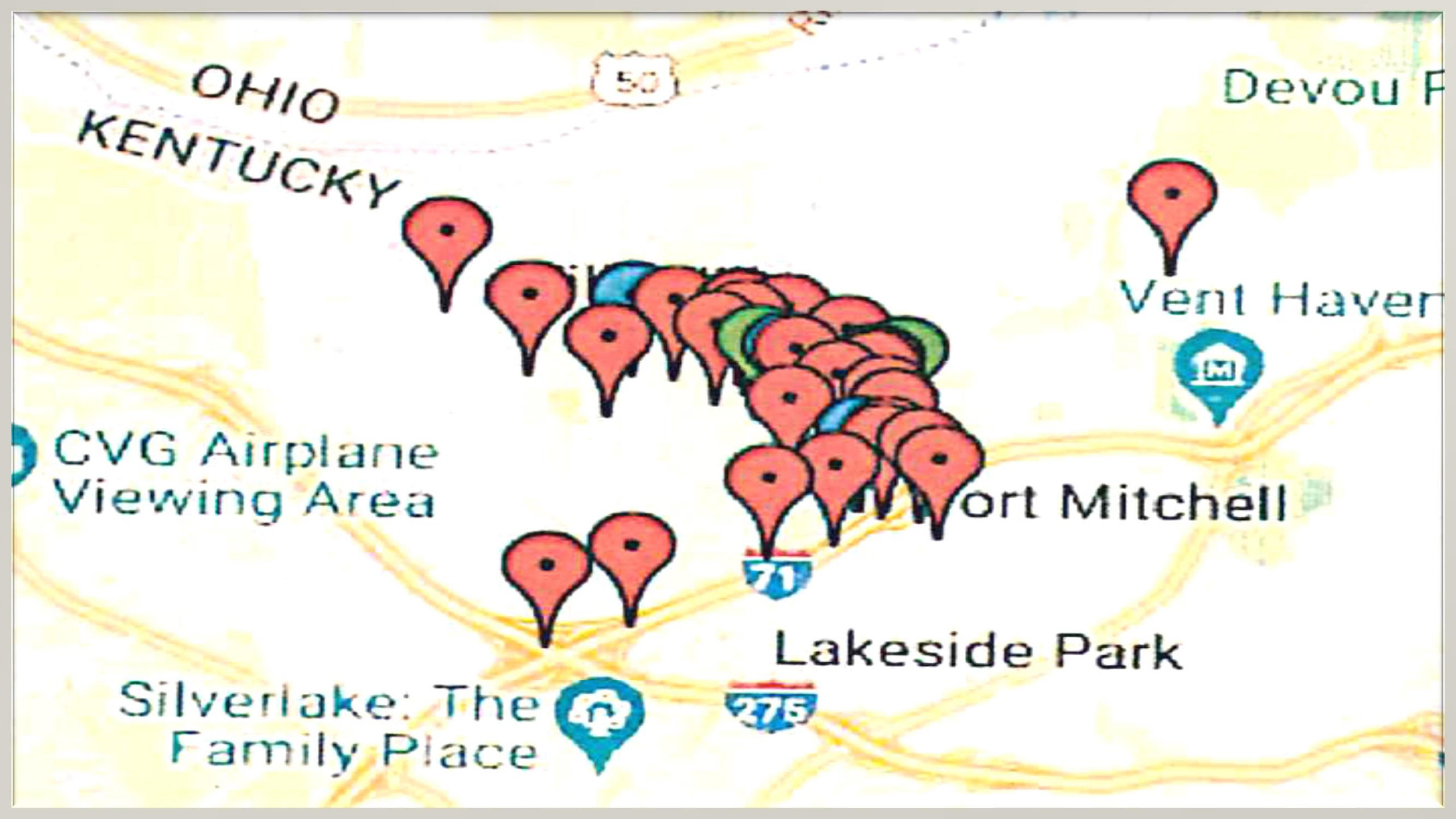

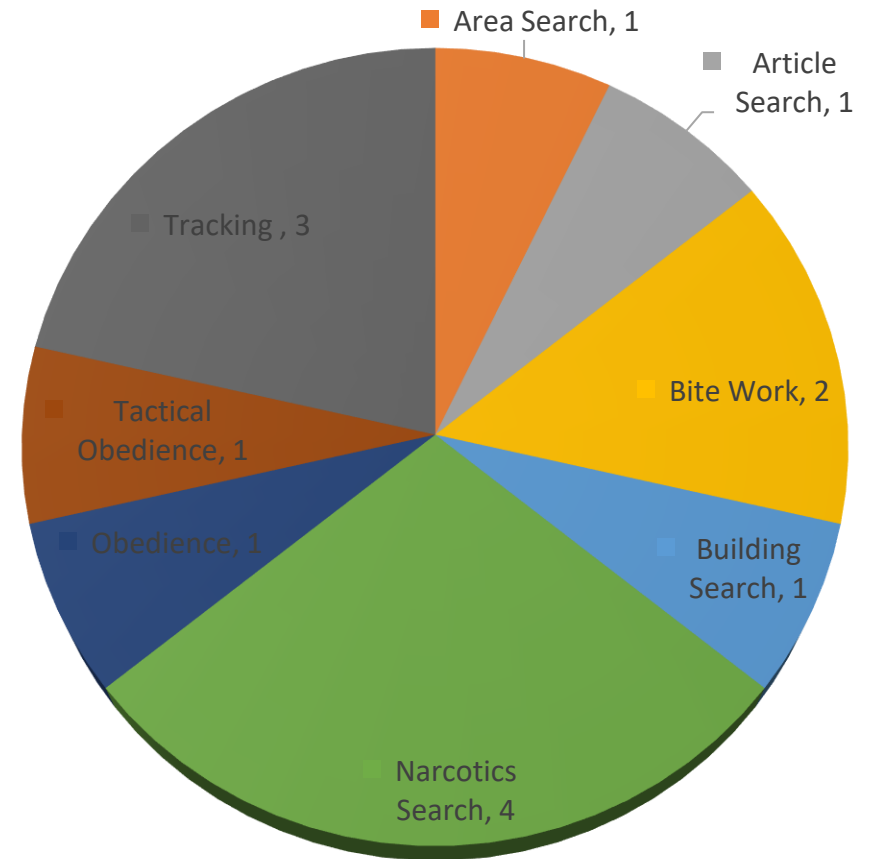
