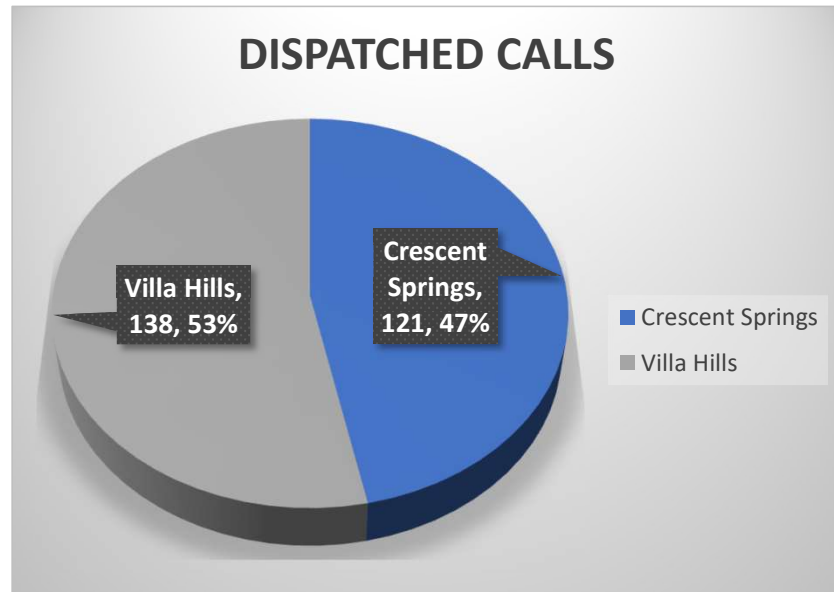
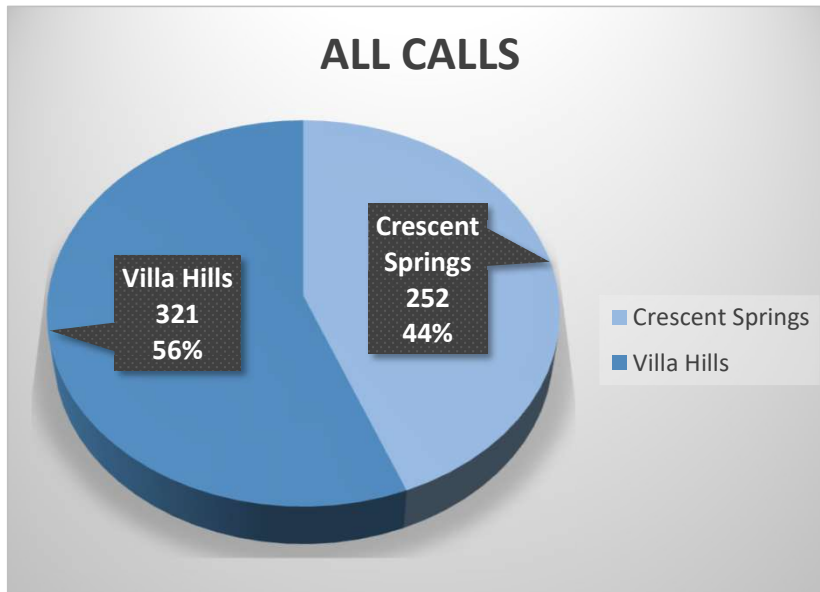




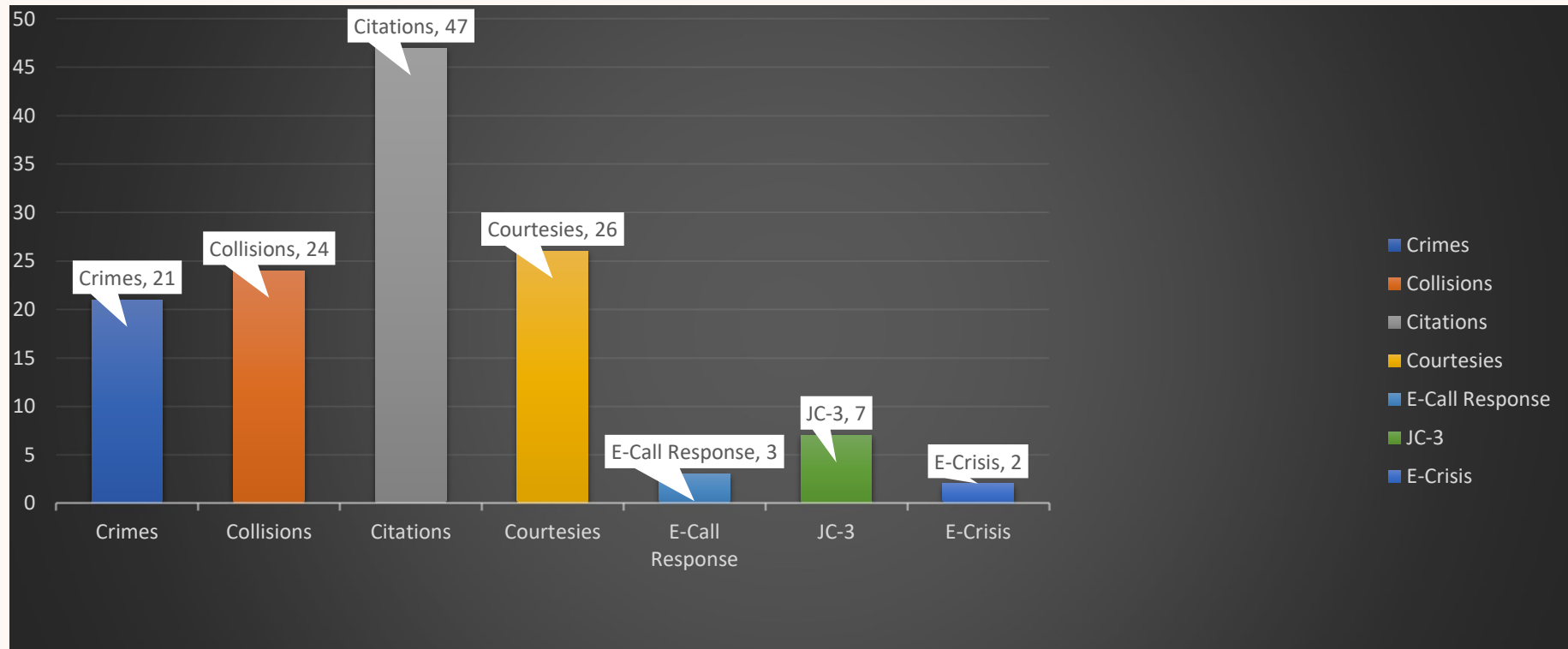
# NOVEMBER 2024 CALLS FOR SERVICE BY CITY

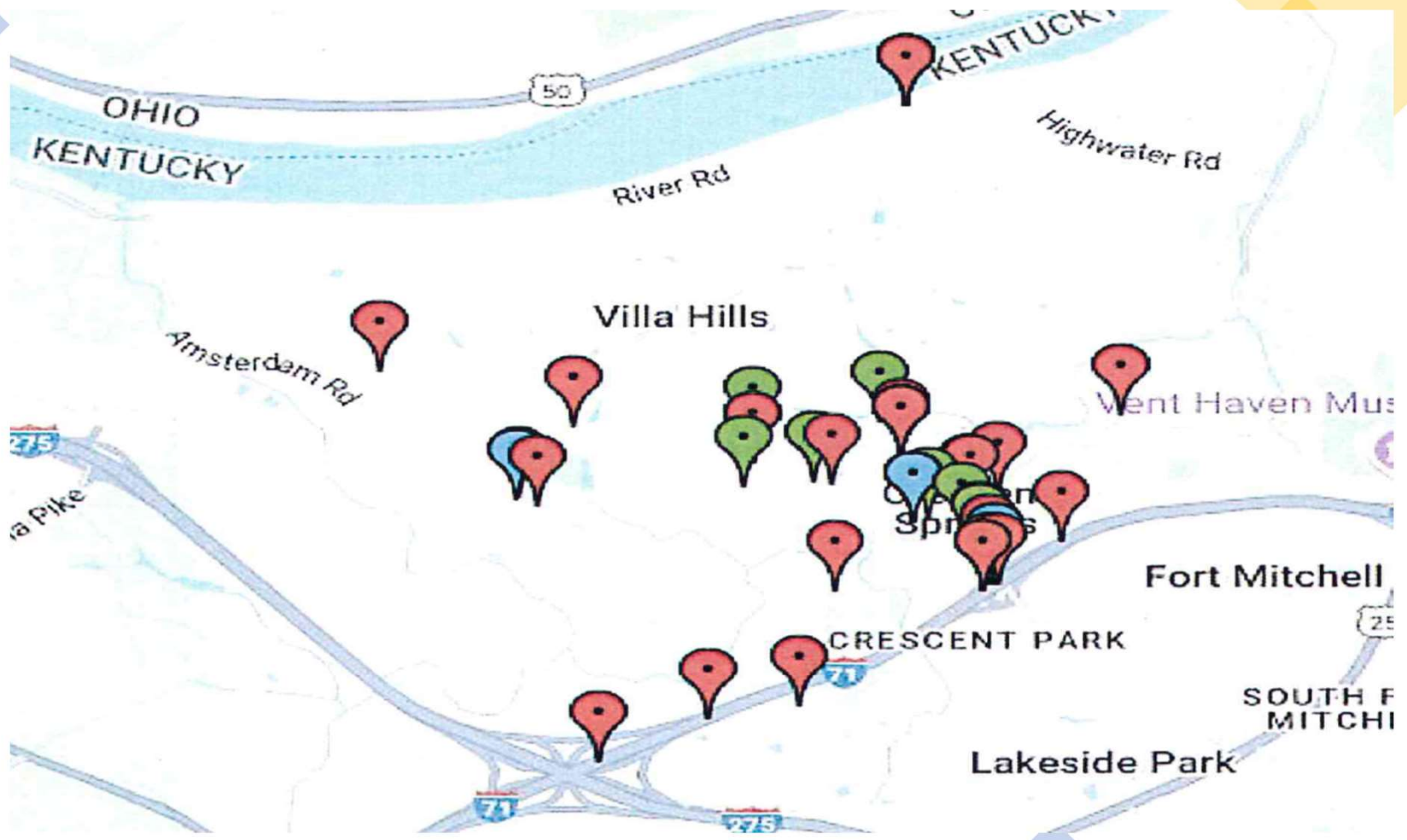

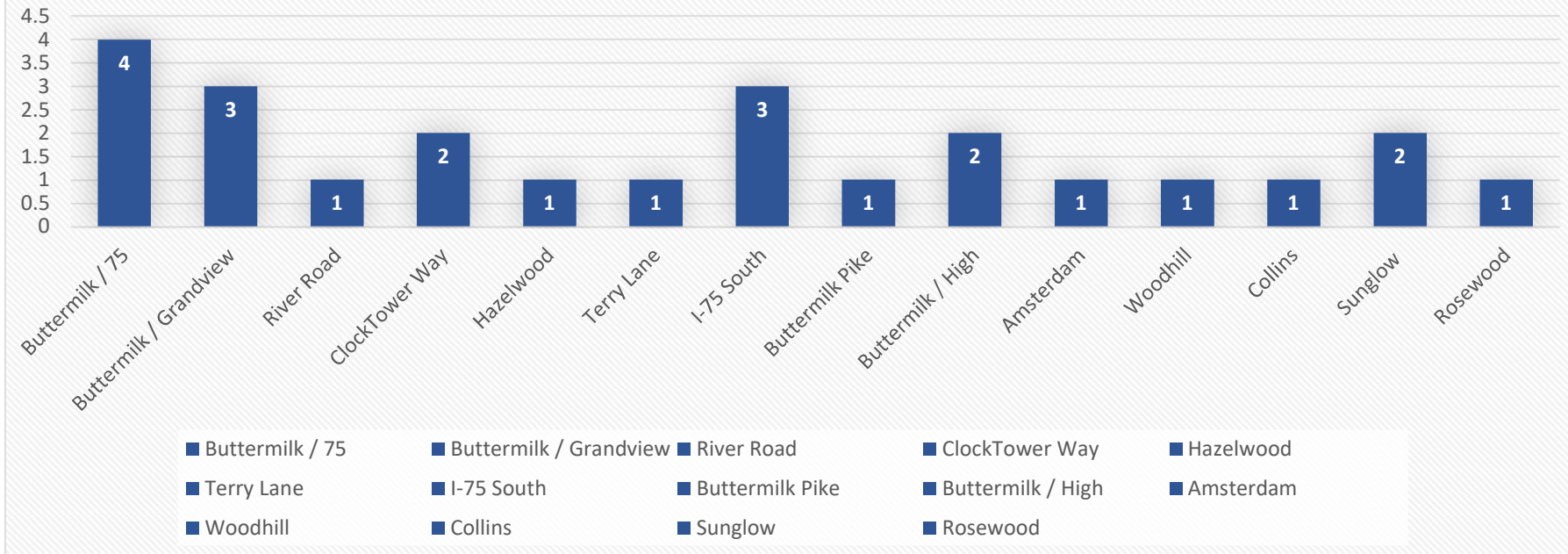

- 2021-10321 (Rape 1<sup>st</sup>) – Case under review by Commonwealth Attorney. (No Update) Still Under Review.
- 2024-07928 (Sexual Assault Juvenile) – CAC Interview conducted. Case file sent to Commonwealth for review. More information requested for Commonwealth.
- 2024-08436 (Sexual Assault Juvenile) – CAC interview conducted. Investigation continues. Lab results pending. Still waiting for results.
- 2024-09208 (Fraud/Theft) – Bitcoin scam. Search warrant and subpoenas sent. Search warrants sent.

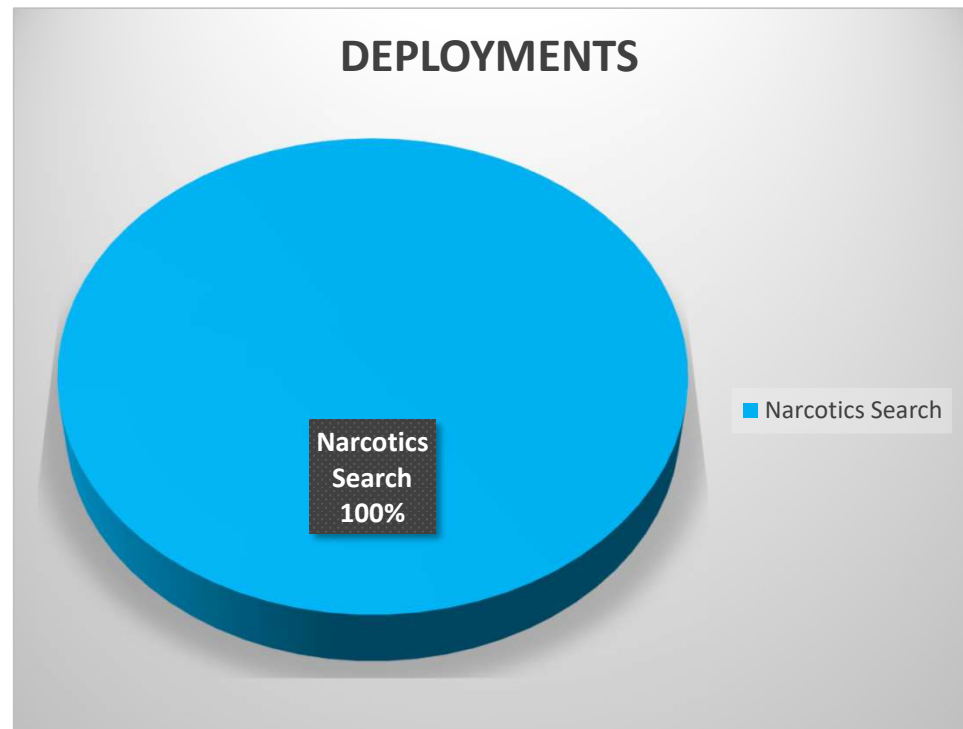

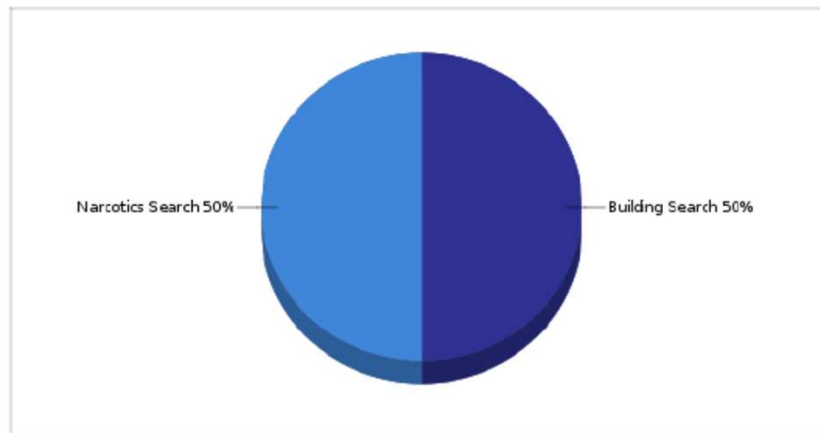
