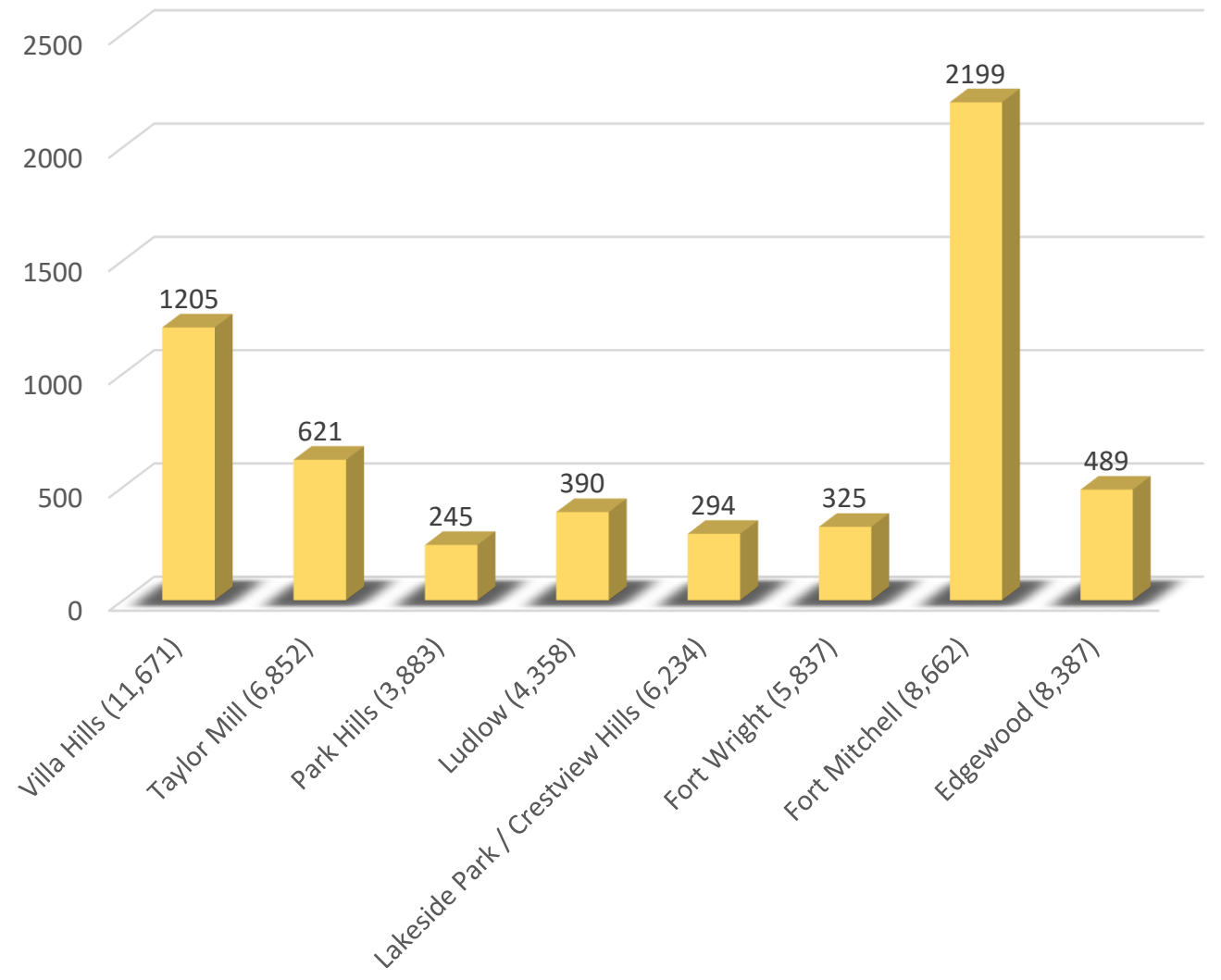

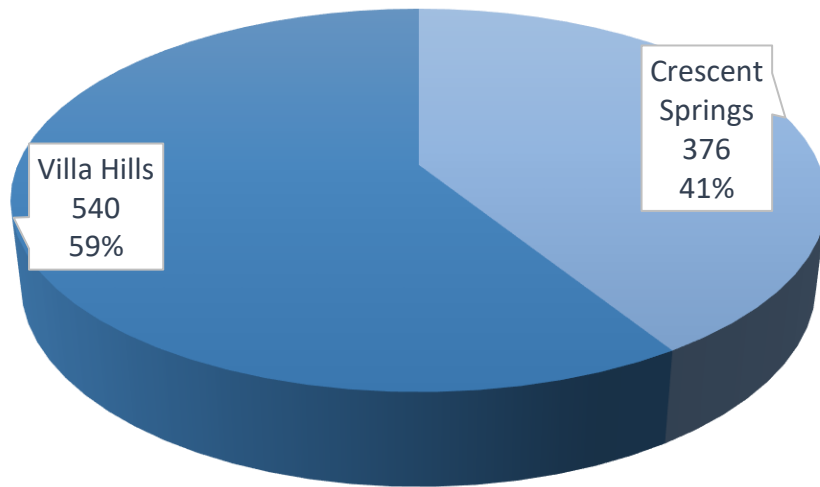


OCTOBER 2024 CALLS FOR SERVICE BY CITY

ALL CALLS (INCLUDES SELF-INITIATED)

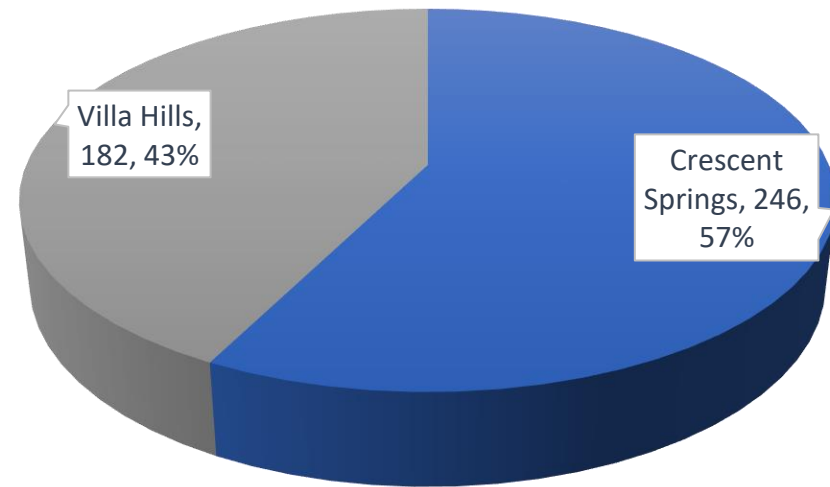

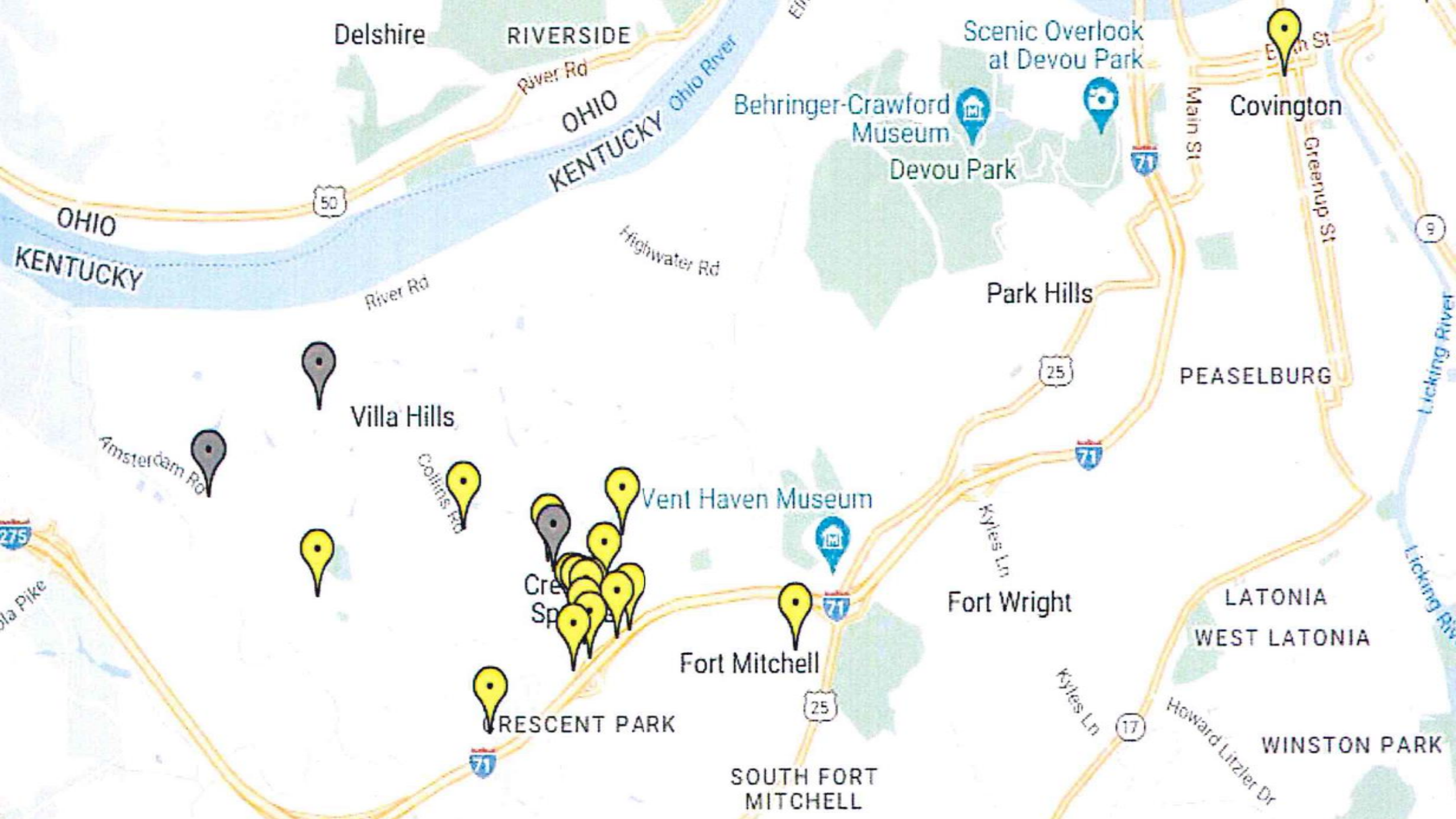

CRIMINAL INVESTIGATIONS REPORT

- 2024-07408 (Theft >\$10,000) – Bank fraud. Working with FBI and Cincinnati Police. Subpoenas to be returned. Photos sent to FBI for facial recognition. Waiting for return information.
- 2021-10321 (Rape 1st) – Case under review by Commonwealth Attorney. (No Update) Still Under Review.
- 2024-07928 (Sexual Assault Juvenile) – CAC Interview conducted. Case file sent to Commonwealth for review.
- 2024-08436 (Sexual Assault Juvenile) – CAC interview conducted. Investigation continues. Lab results pending. Still waiting for results.
- 2024-08539 (Fraud/Theft) – No further evidence. Case is Inactive/Closed.
- 2024-09208 (Fraud/Theft) – Bitcoin scam. Search warrant and subpoenas sent. More search warrants being drafted.
- 2024-09387 (Fraud/Theft) – Bitcoin scam. No further leads. Case moved to Inactive/Closed.
- 2024-10073 (Possession of Forged Instrument 2nd) – Suspect identified. Criminal complaint signed. Suspect not located.
- 2024-11203 (Fraud/Scam) – Attempted bitcoin scam. No money transferred.
- 2024-11753 (Sexual Assault 1st) – Interviews conducted. No further evidence. Case moved to Inactive/Closed.
- 2024-12485 (Fraud / Exploitation) – Victim scammed out of \$7,100 while assisting subjects that were dntrodden. Case Open.

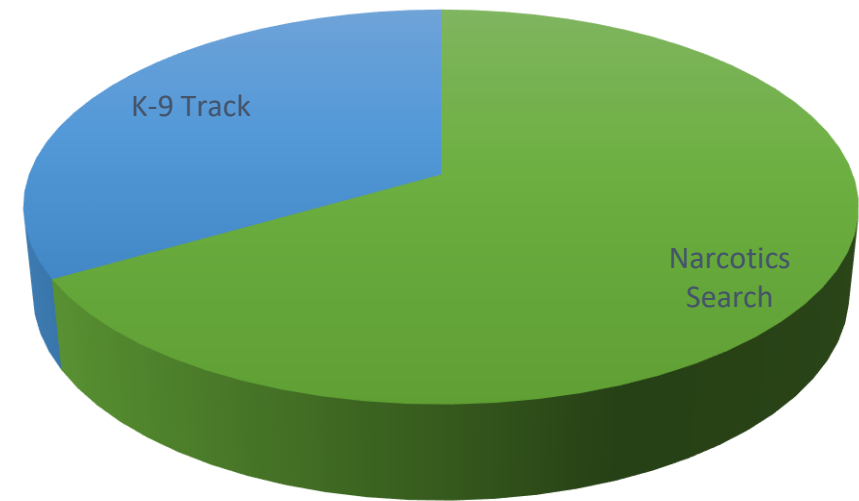

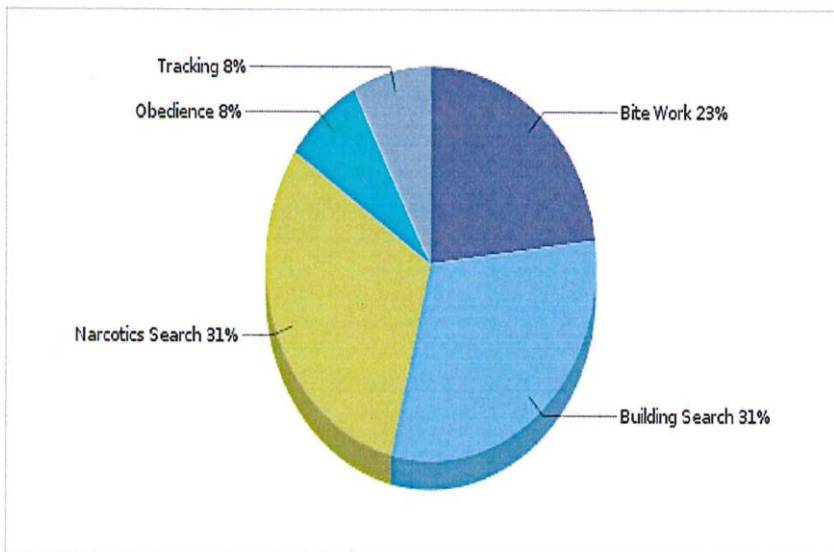
