

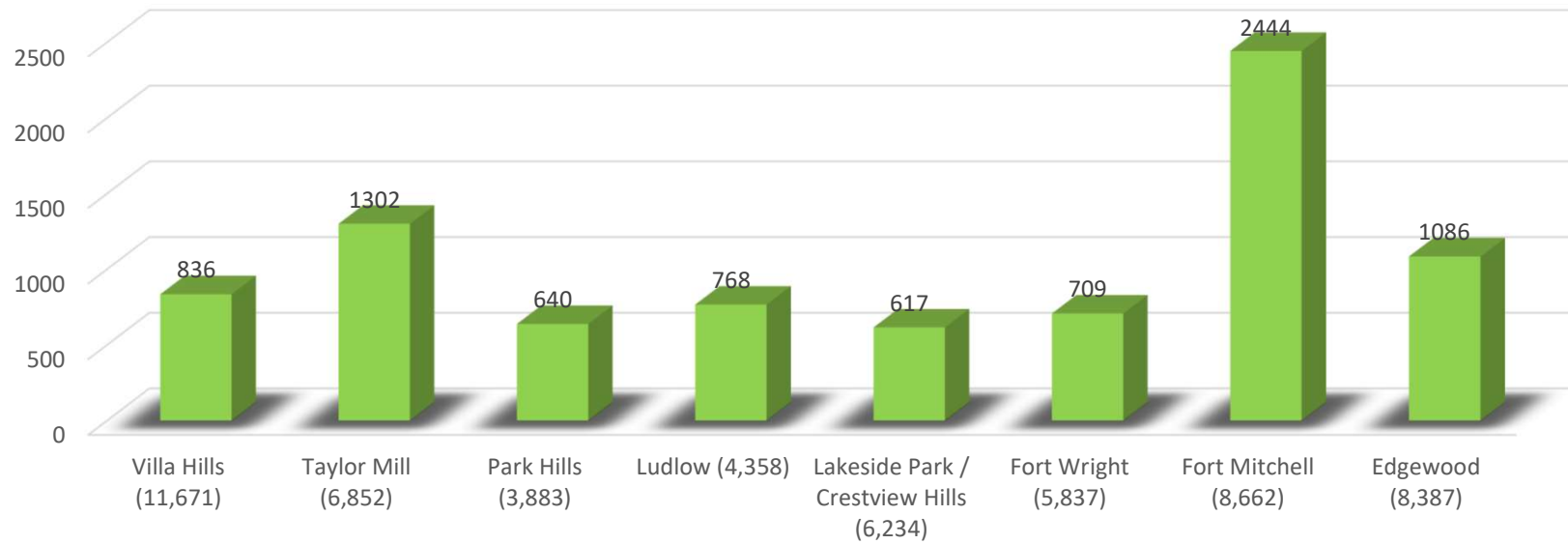

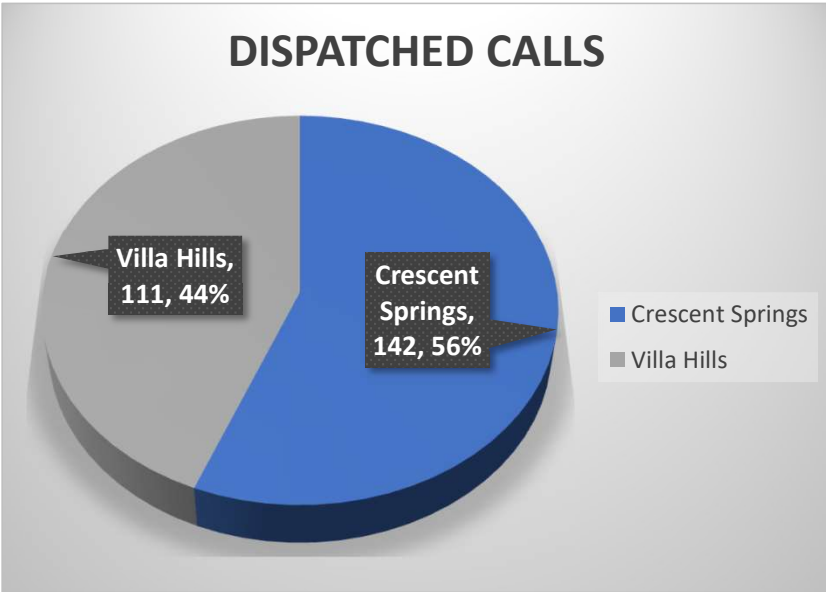
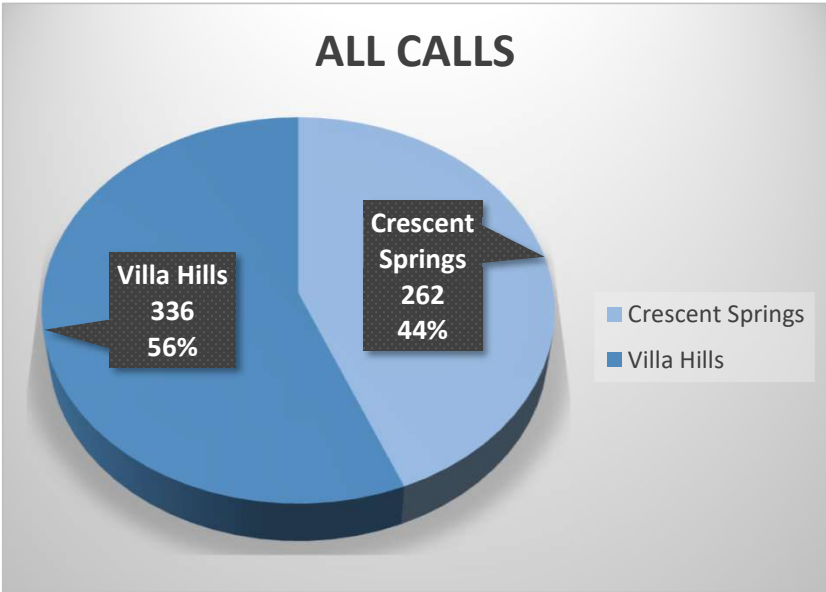


# DECEMBER 2024 CALLS FOR SERVICE BY CITY

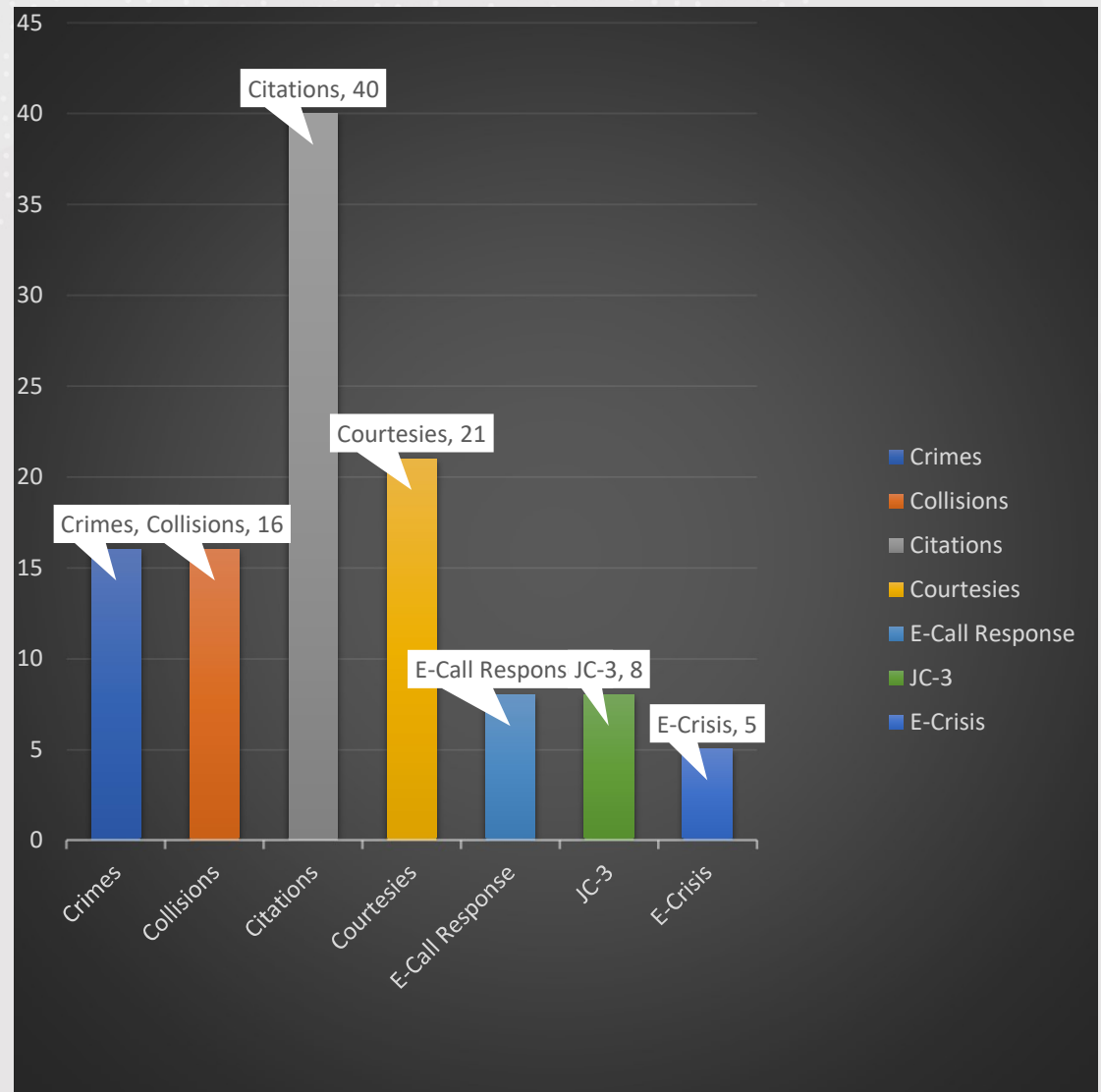


ALL CALLS (INCLUDES SELF-INITIATED)

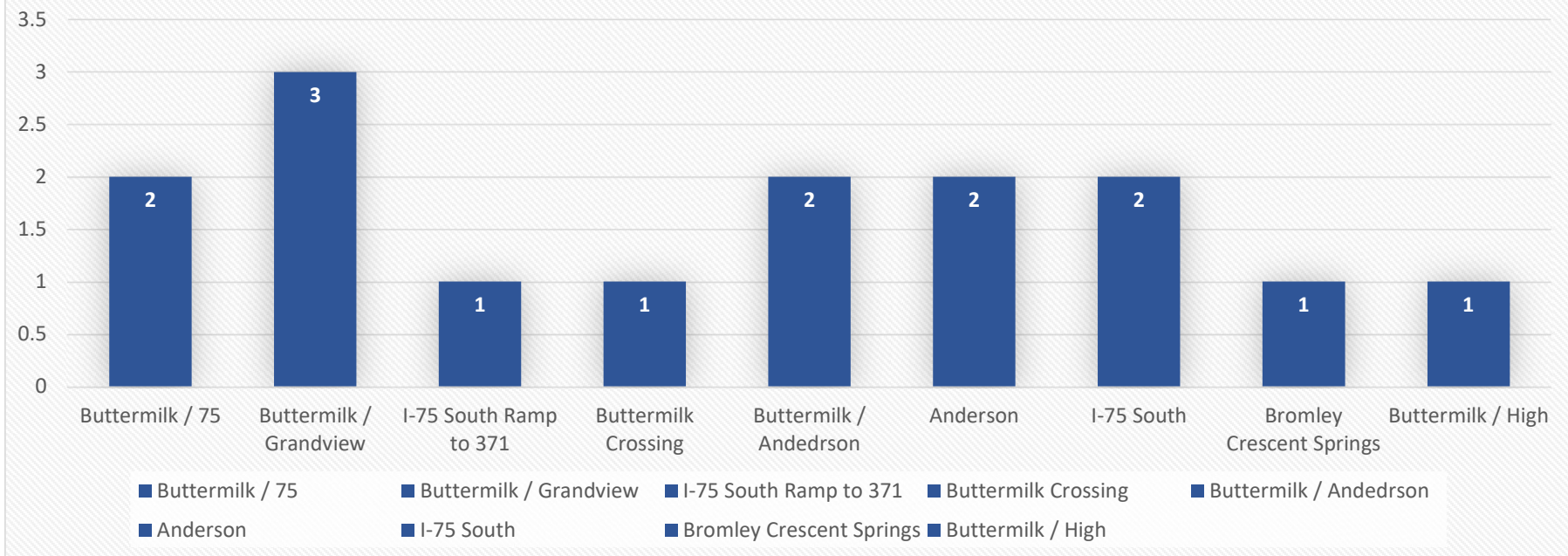

# CRIMINAL INVESTIGATIONS REPORT

2024-07408 (Theft >\$10,000) – Bank fraud. Working with FBI and Cincinnati Police. Moved to Inactive until leads develop.

2021-10321 (Rape 1<sup>st</sup>) – Case under review by Commonwealth Attorney. (No Update) Still Under Review.

2024-07928 (Sexual Assault Juvenile) – CAC Interview conducted. Case file sent to Commonwealth for review. More information requested for Commonwealth.

2024-08436 (Sexual Assault Juvenile) – CAC interview conducted. Investigation continues. Lab results pending. Still waiting for results.

2024-12485 (Fraud / Exploitation) – Victim scammed out of \$7,100 while assisting subjects that were downtrodden. Moved to Inactive. Victim not cooperating.

2024-12794 (Unlawful Transaction 3<sup>rd</sup>) – ICAC case. Investigation continues. Waiting for search warrant returns.

2024-13717 (Theft of Identity) – Credit cards opened in victim's name. Case Continues.

2024-13894 (Death Investigation)- Investigation continues.

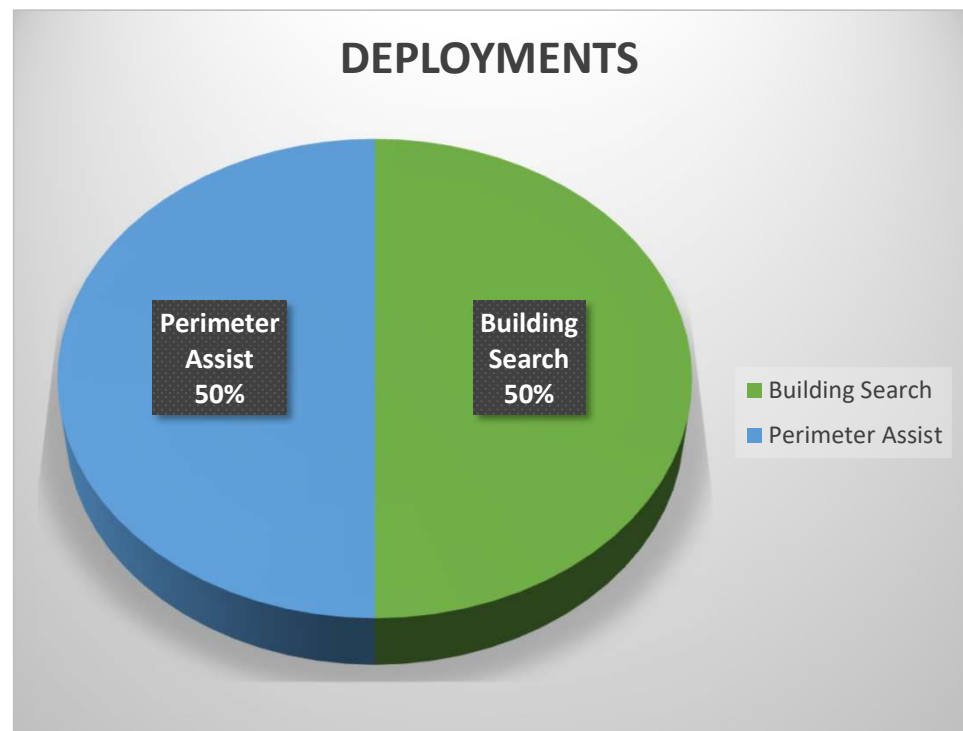

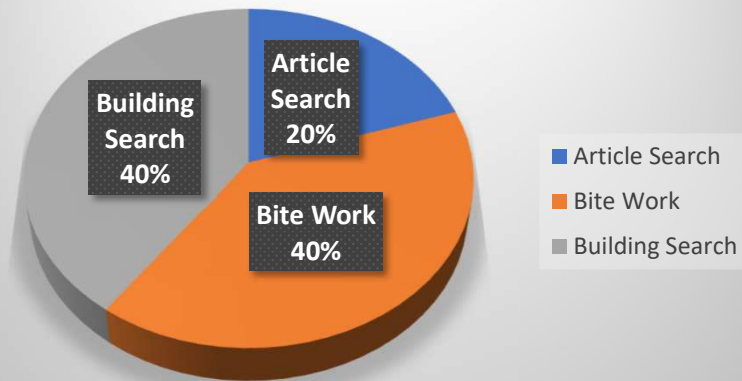
