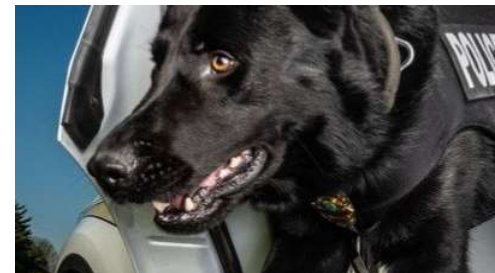
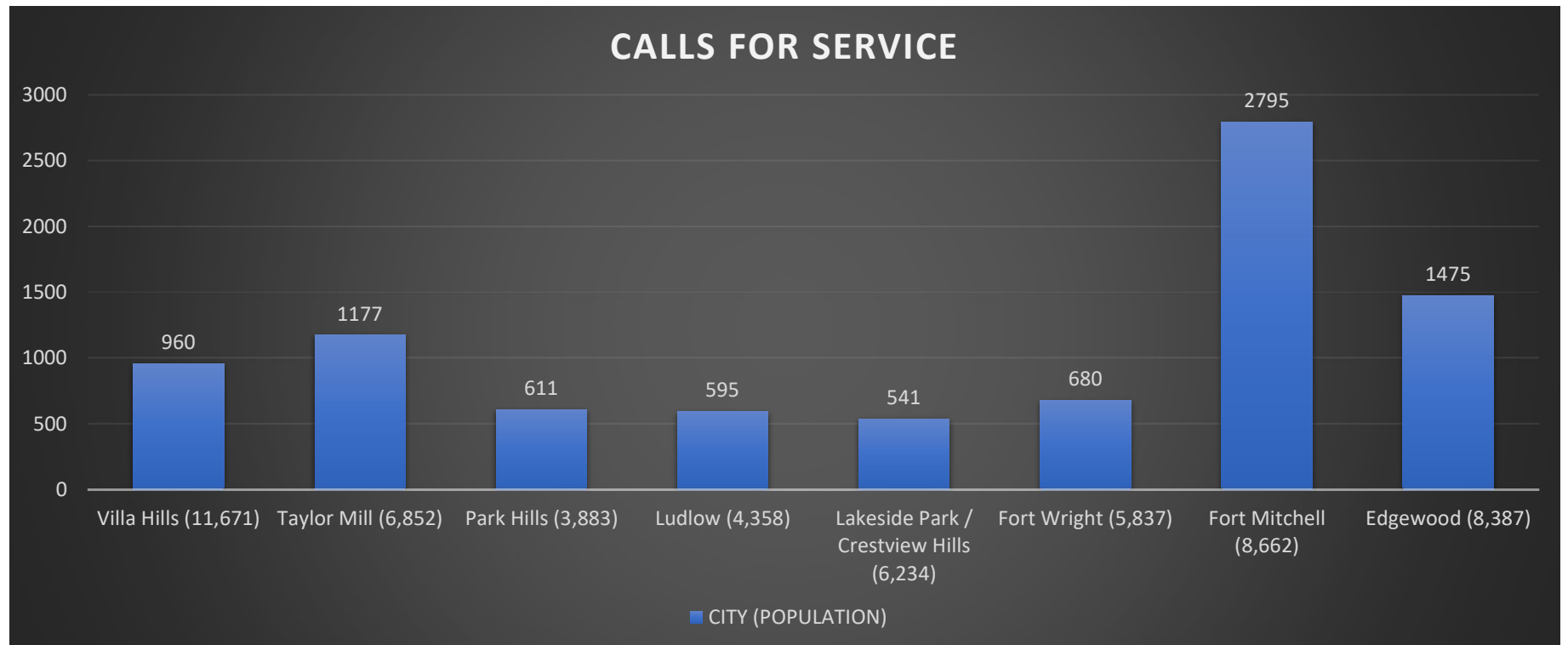

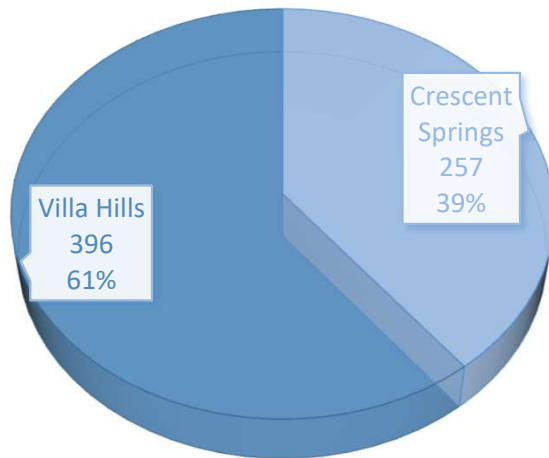


# FEBRUARY 2025 CALLS FOR SERVICE BY CITY

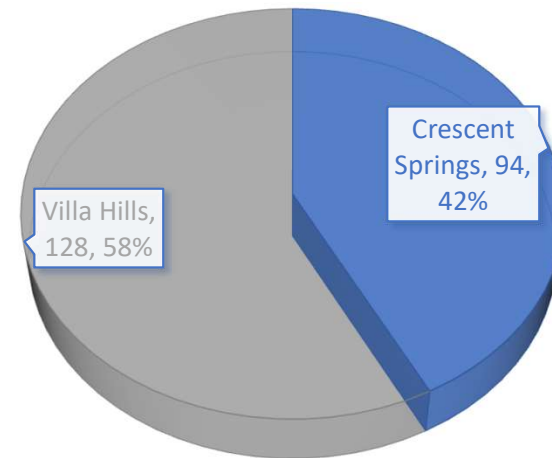

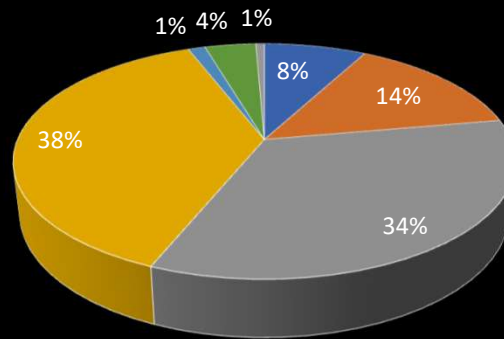

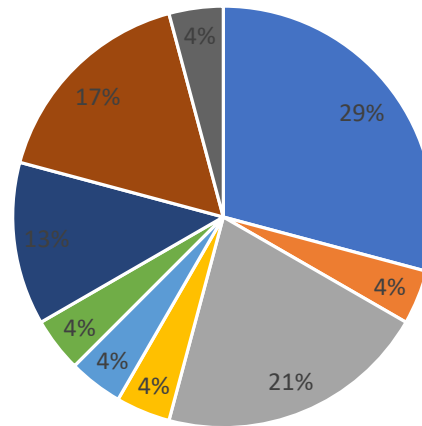

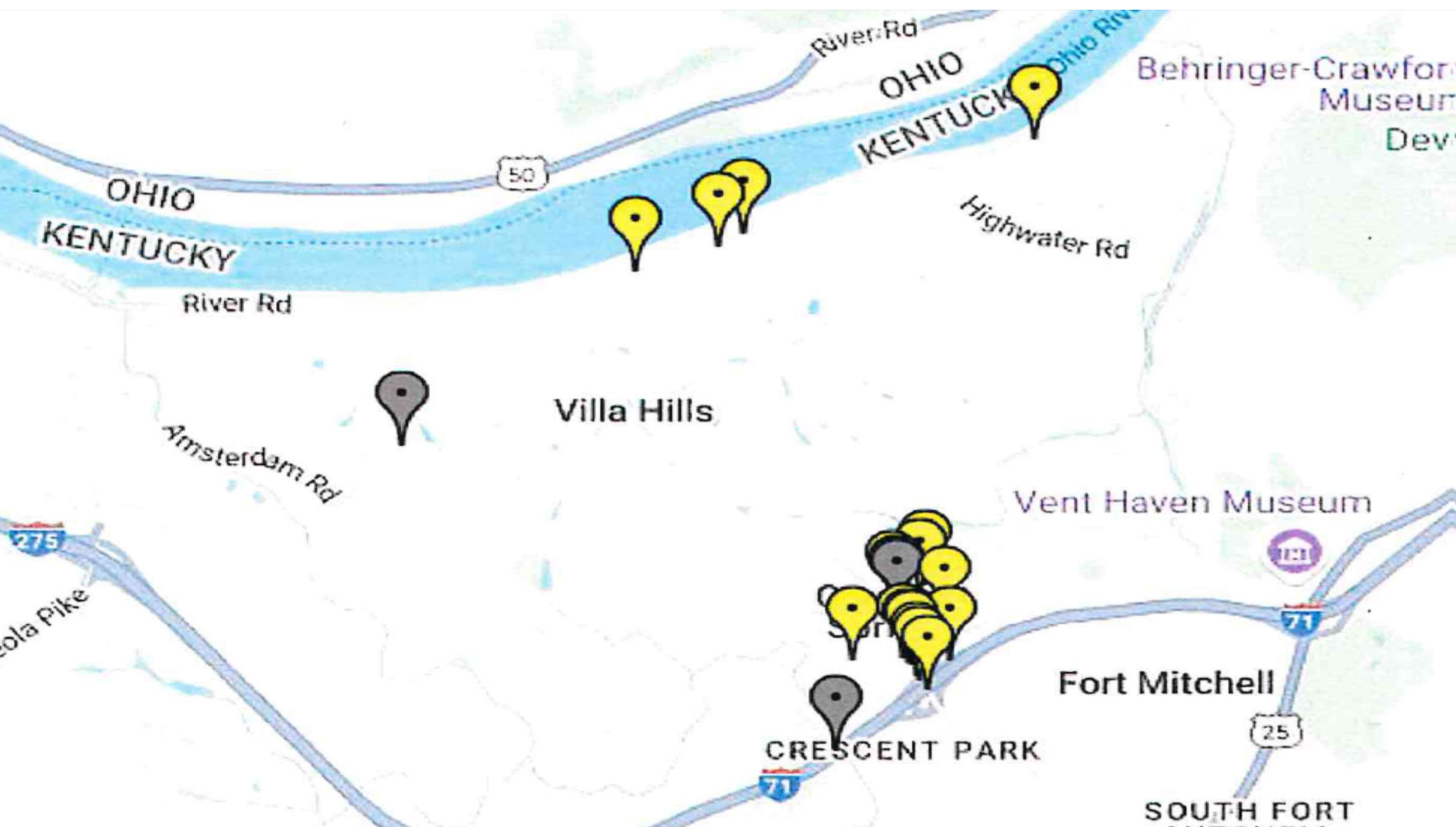
