

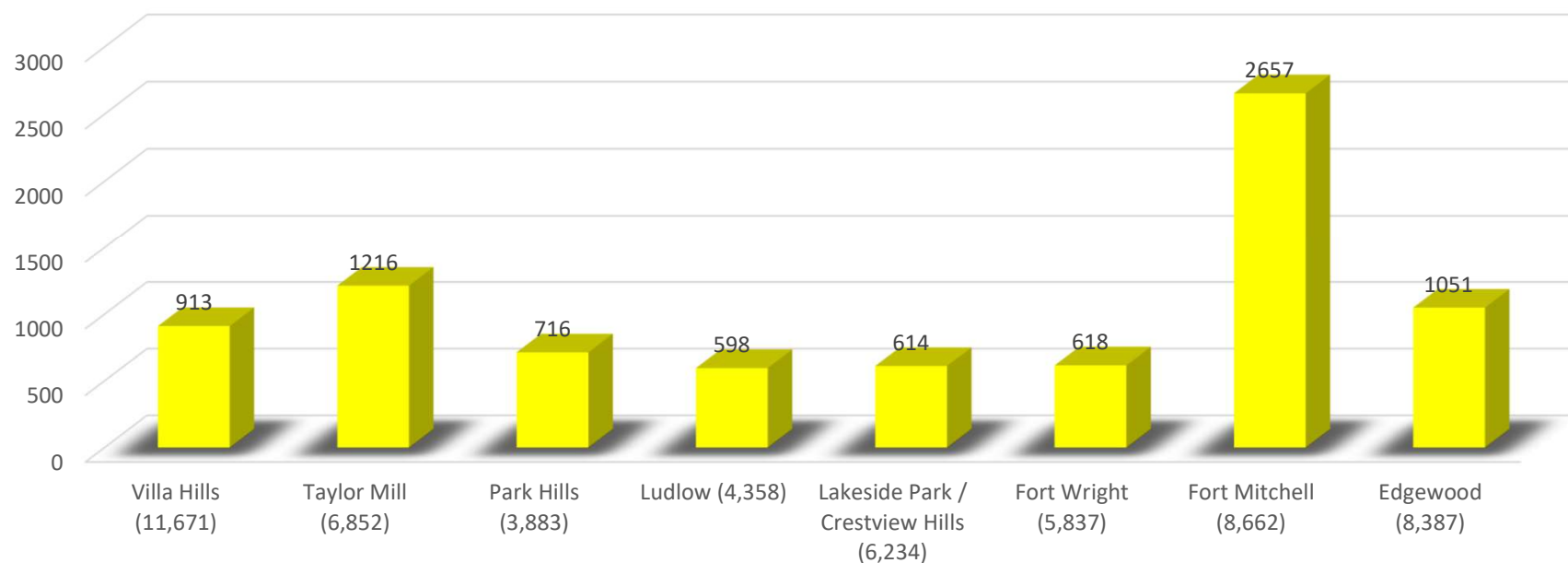

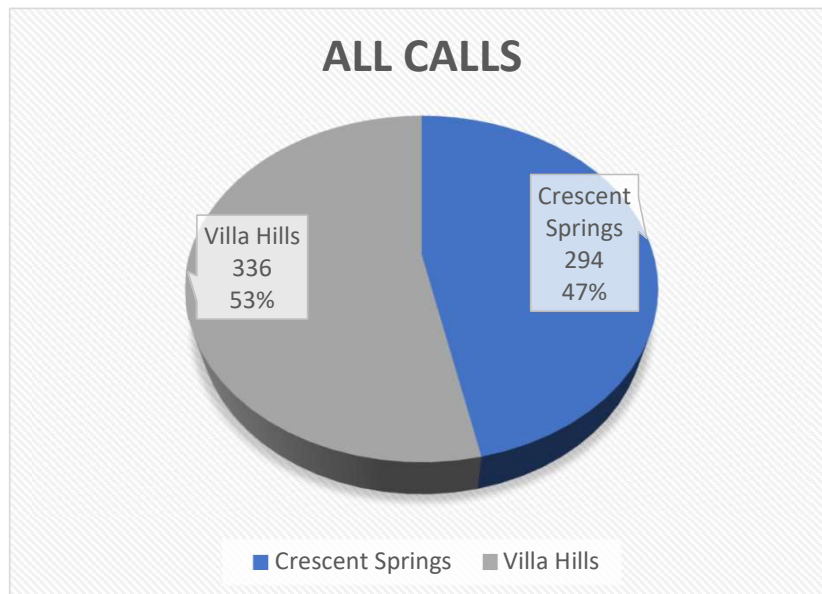

## CALLS FOR SERVICE

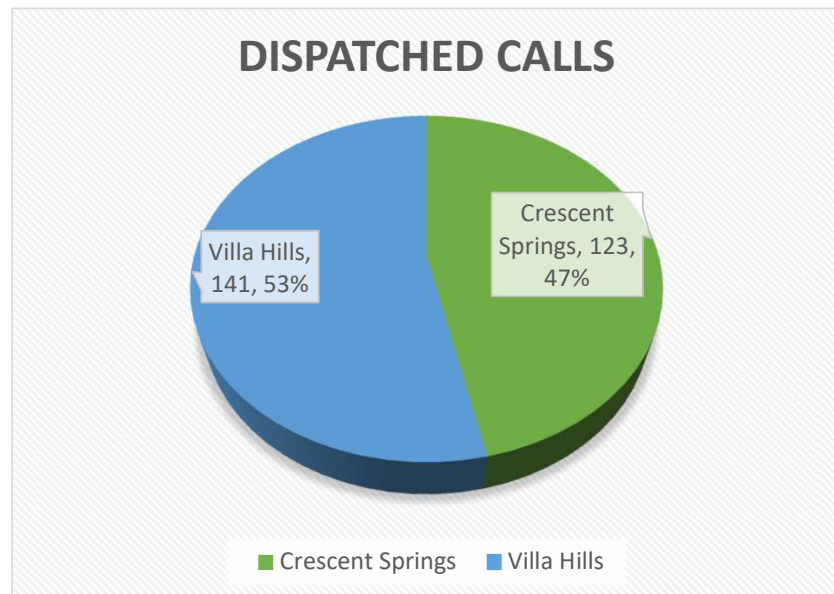


# APRIL 2025 CALLS FOR SERVICE BY CITY

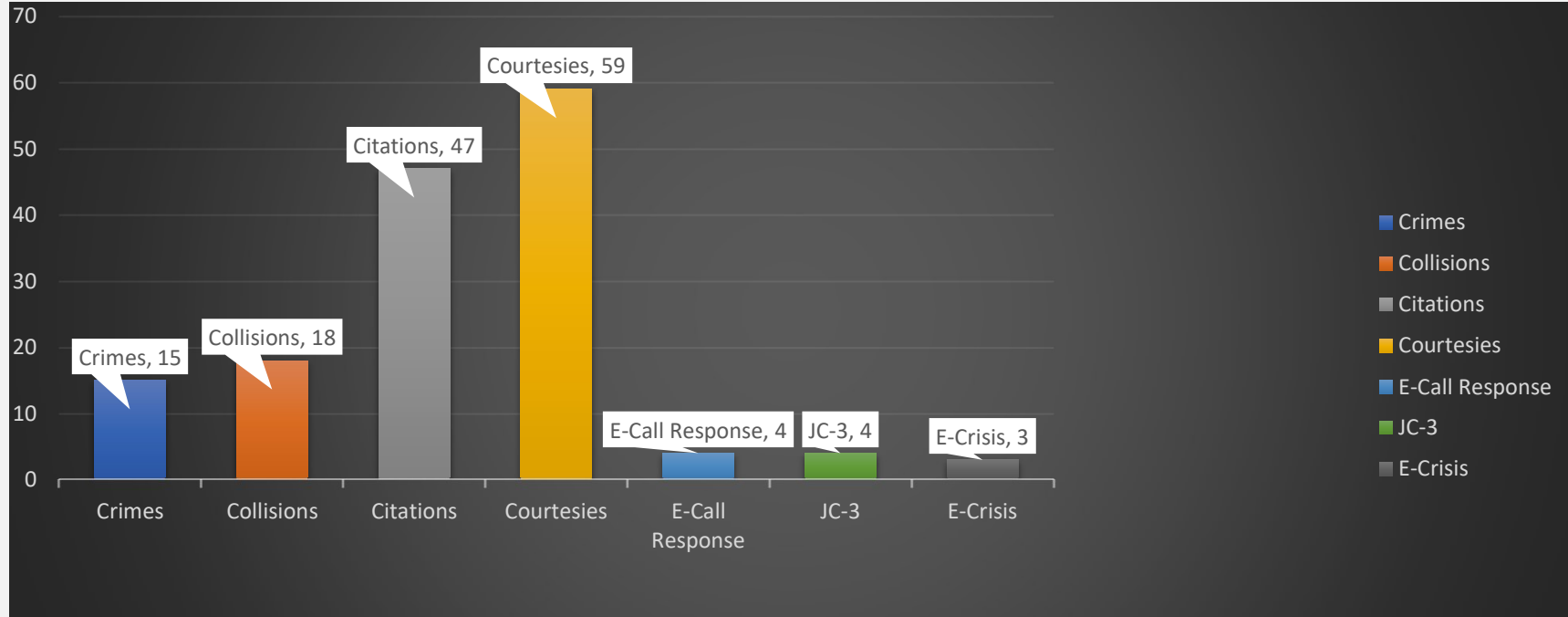
ALL CALLS (INCLUDES SELF-INITIATED)

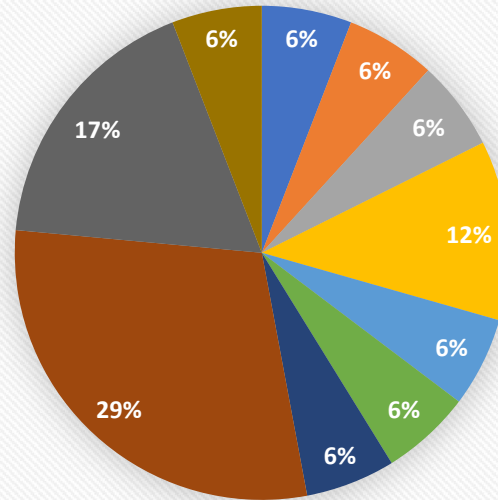

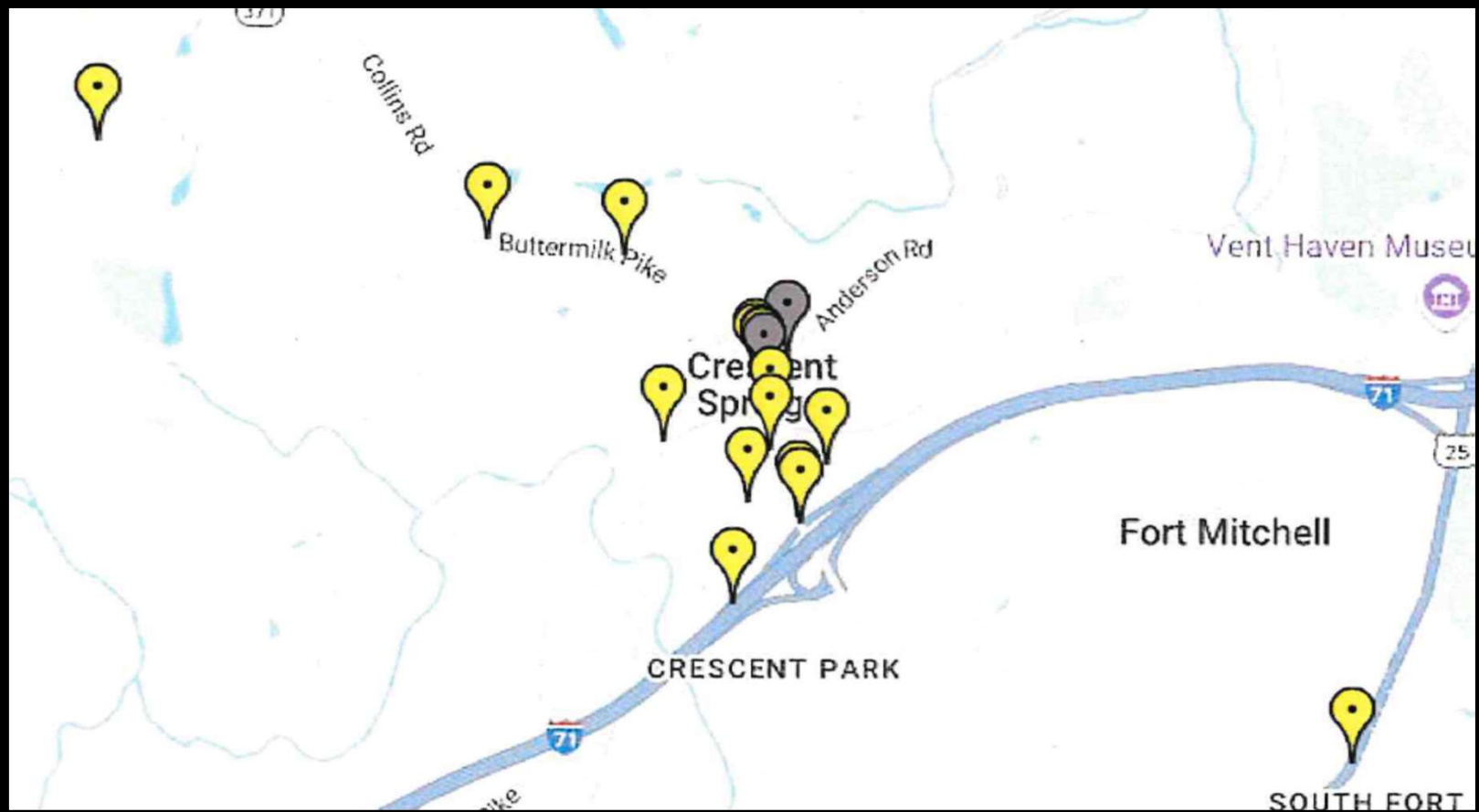
## Top Roadway Collisions

## ACTIVE CASES

**2024-12794**

- (Rape 1<sup>st</sup>) - Suspect has been arrested. Case remains open for court purposes.

**2025-02217**

- (Stolen Credit Card) – Video surveillance recovered. Attempting to identify suspect.

- (Forgery 2nd) – Identify of suspect not confirmed. Case continues.

**2025-03219**

- (TBUT <\$10,000)- Video footage obtained. Working with other agencies for similar thefts.

- Assisted Erlanger. Confession gained by juvenile who started fire accidentally.

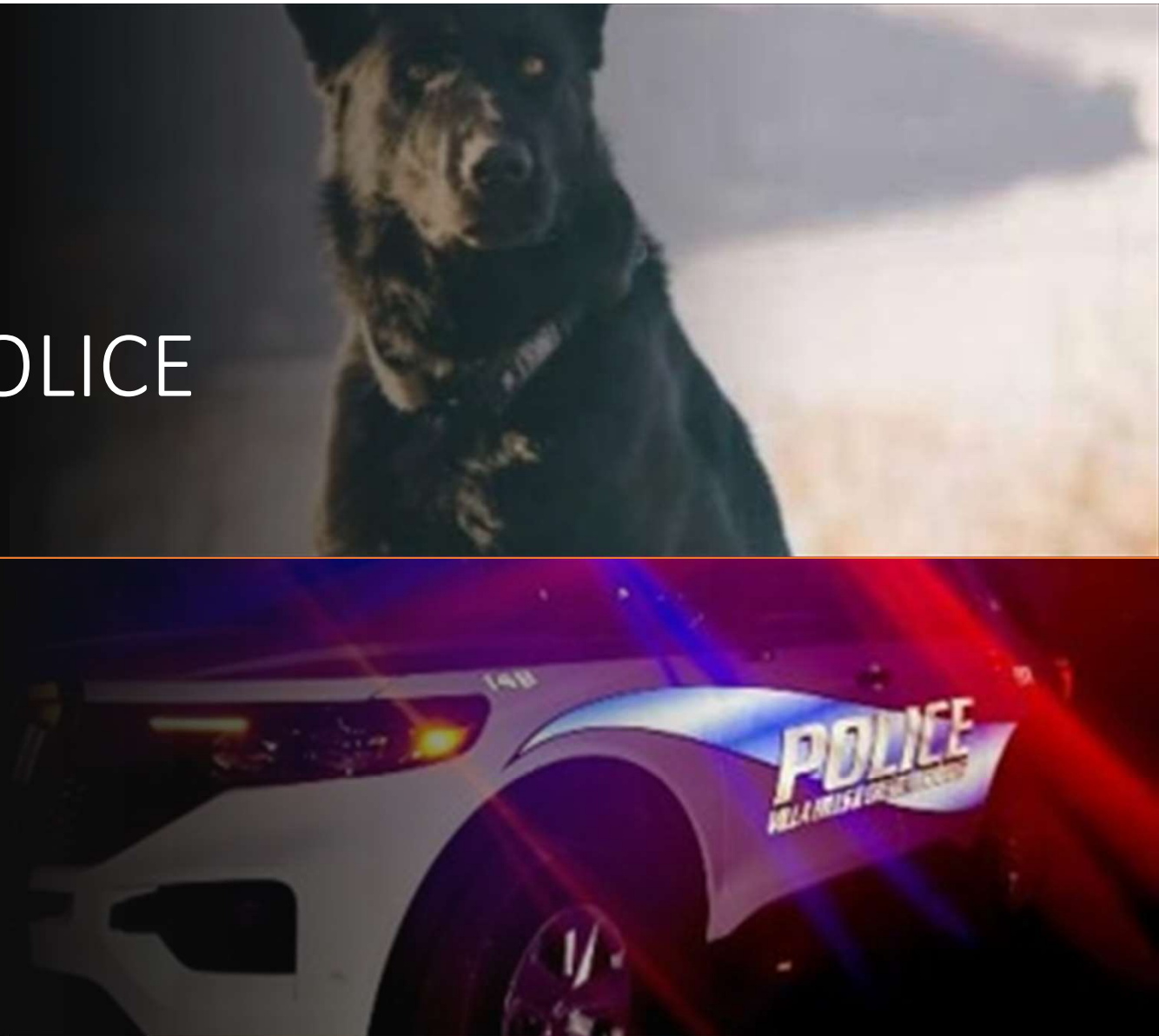

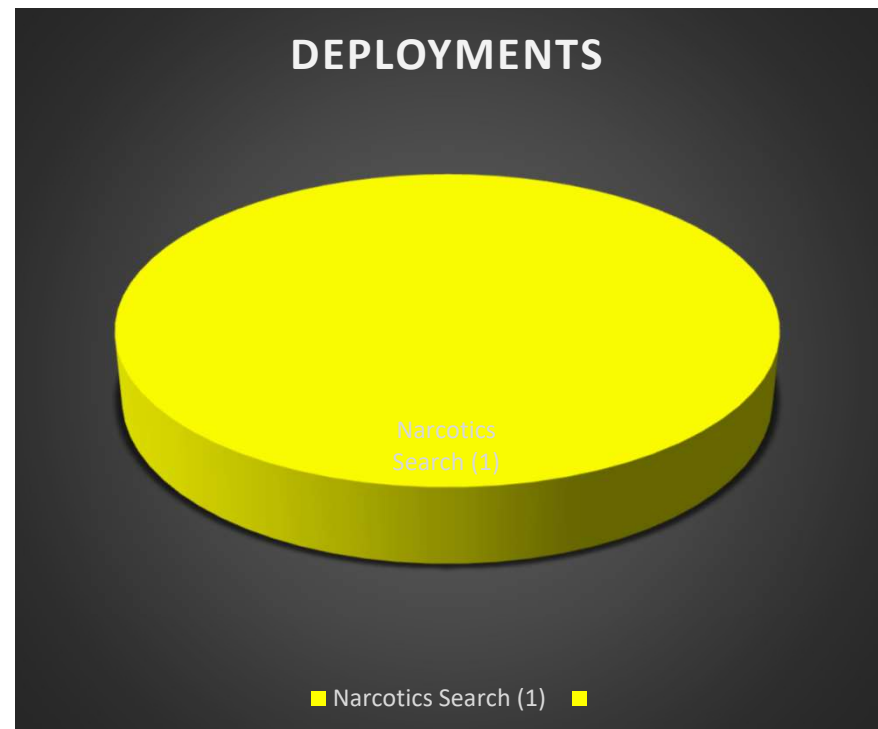
