

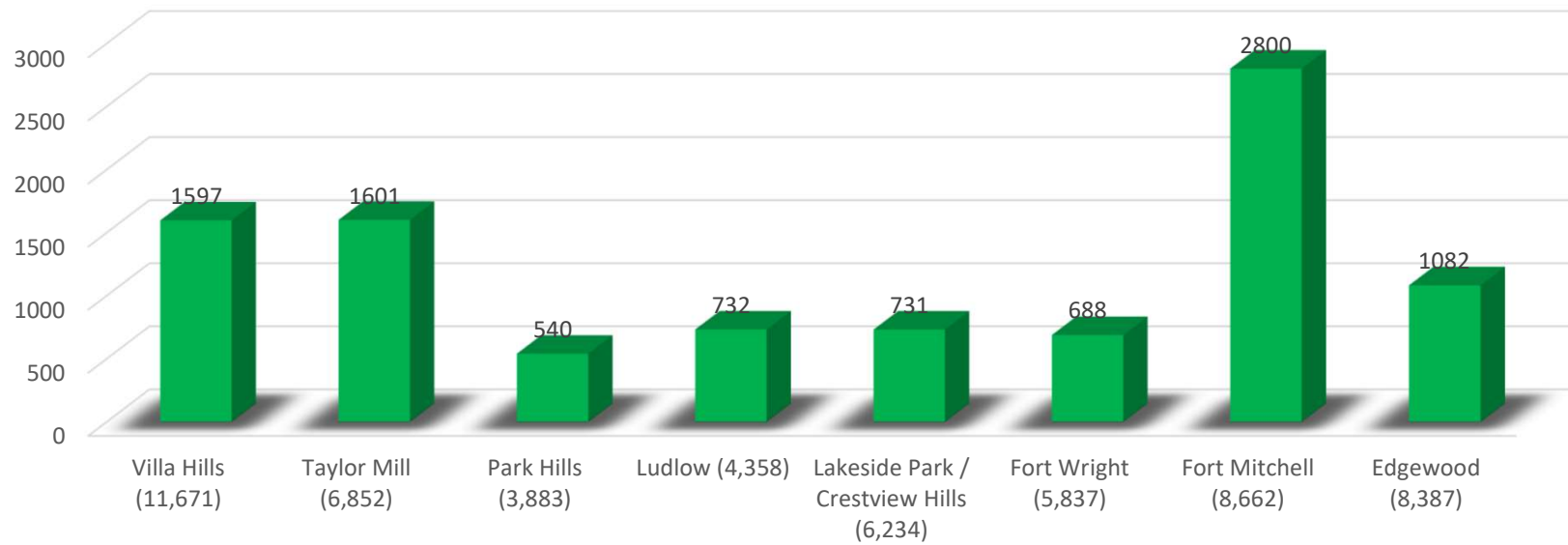

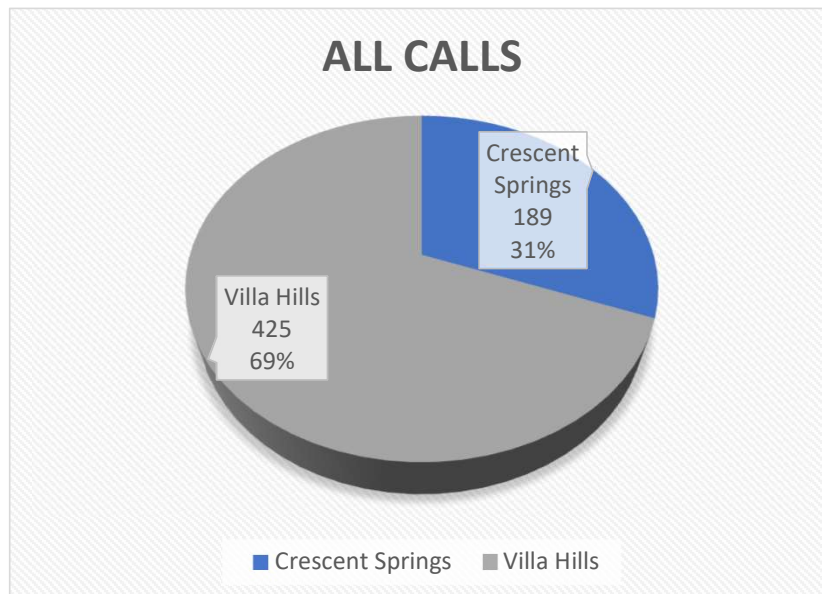

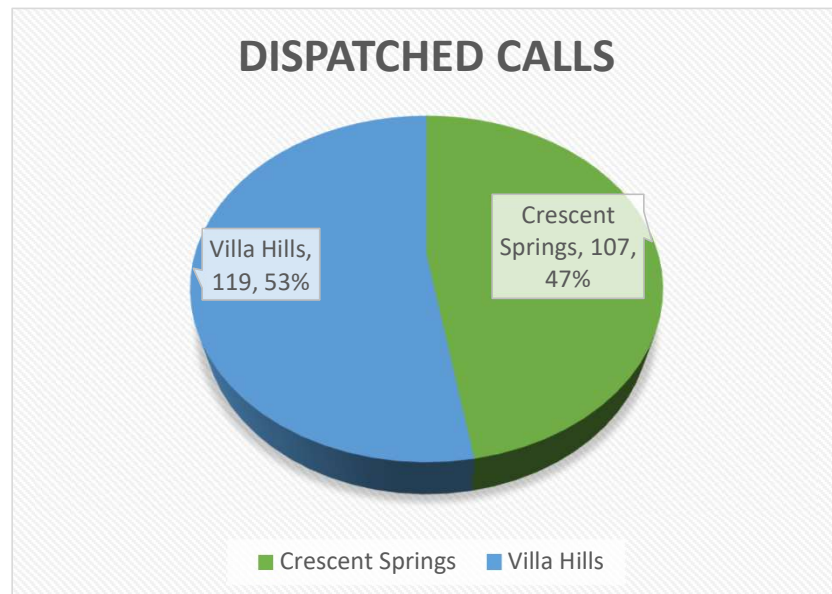


JULY 2025 CALLS FOR SERVICE BY CITY

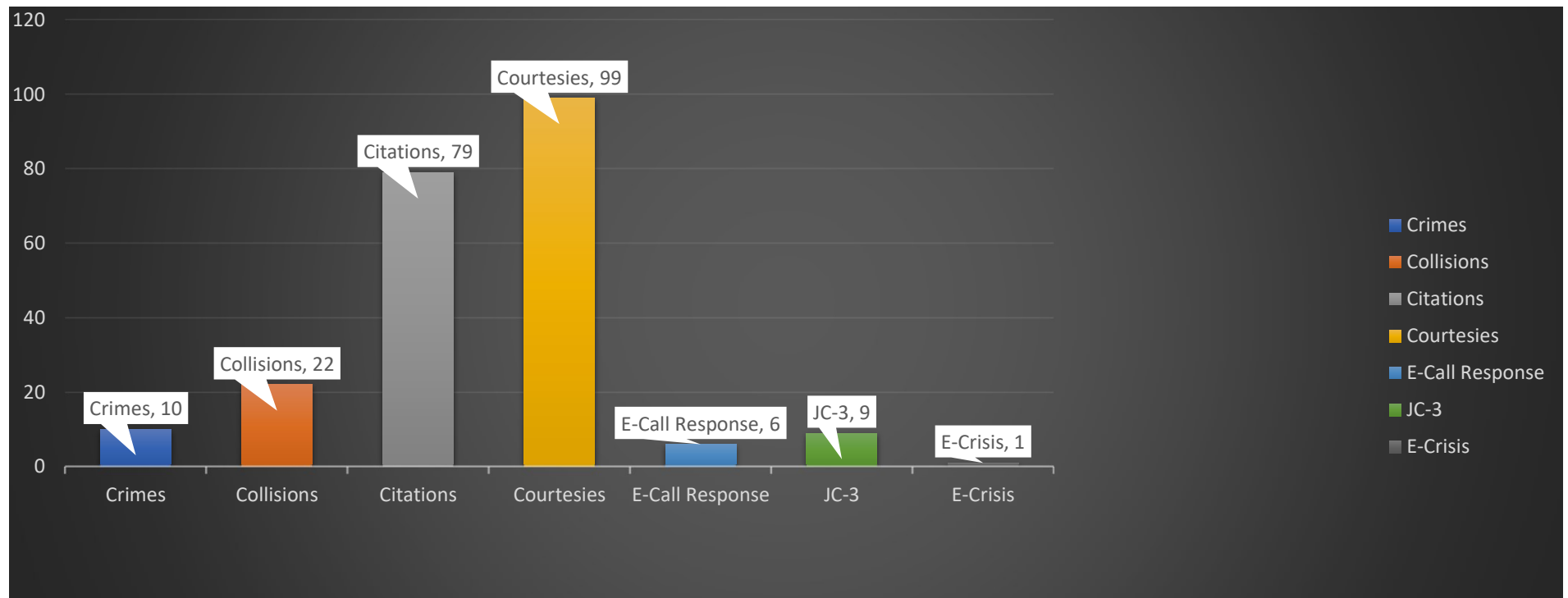
ALL CALLS (INCLUDES SELF-INITIATED)

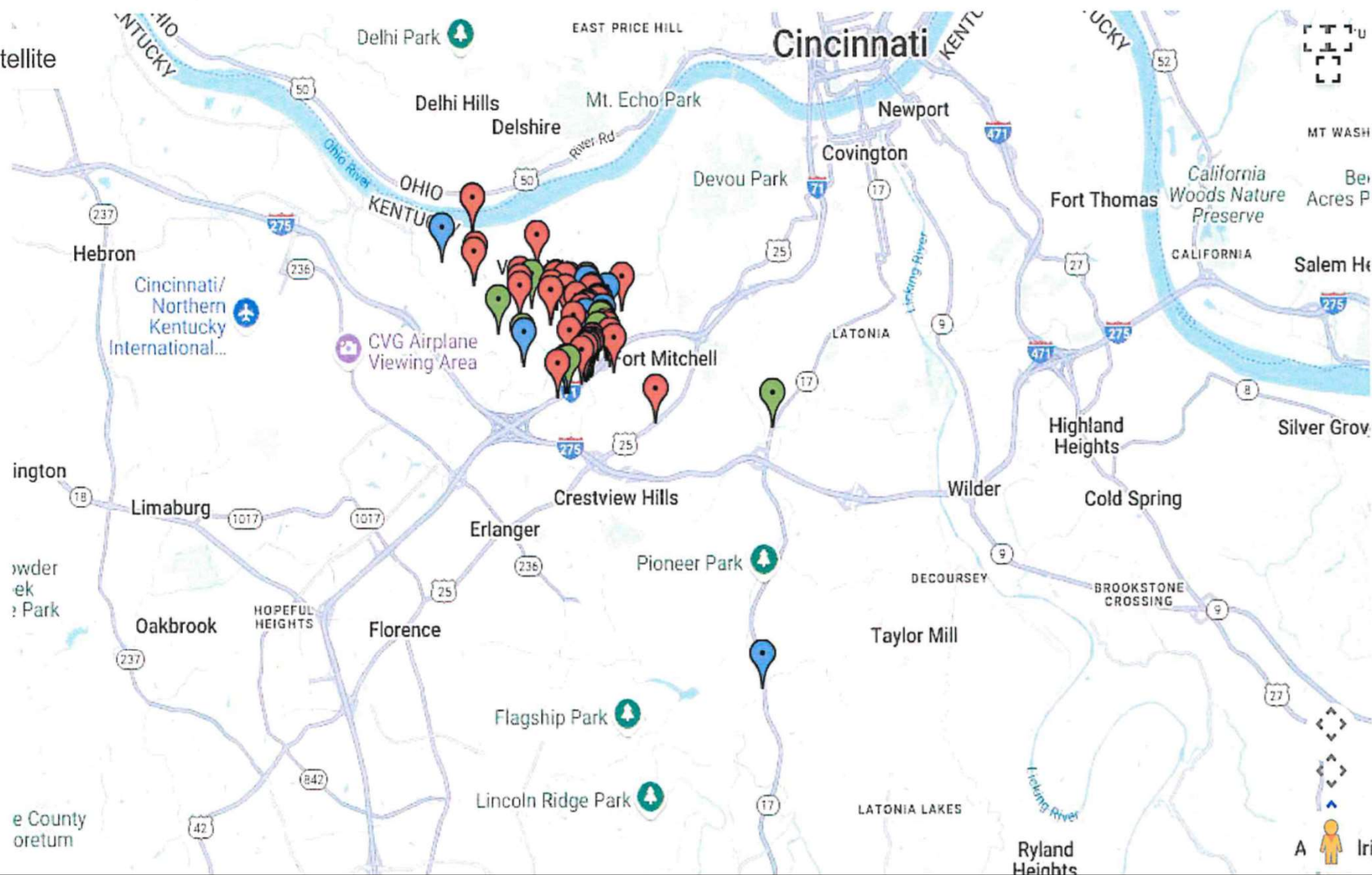

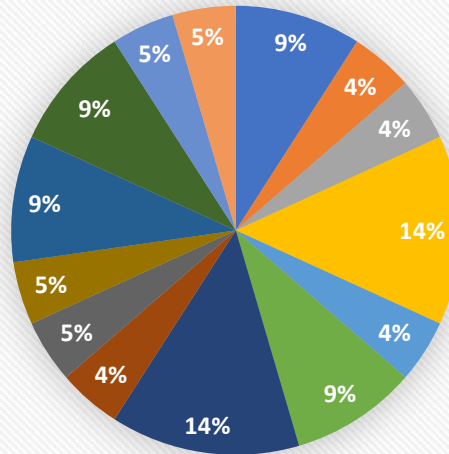

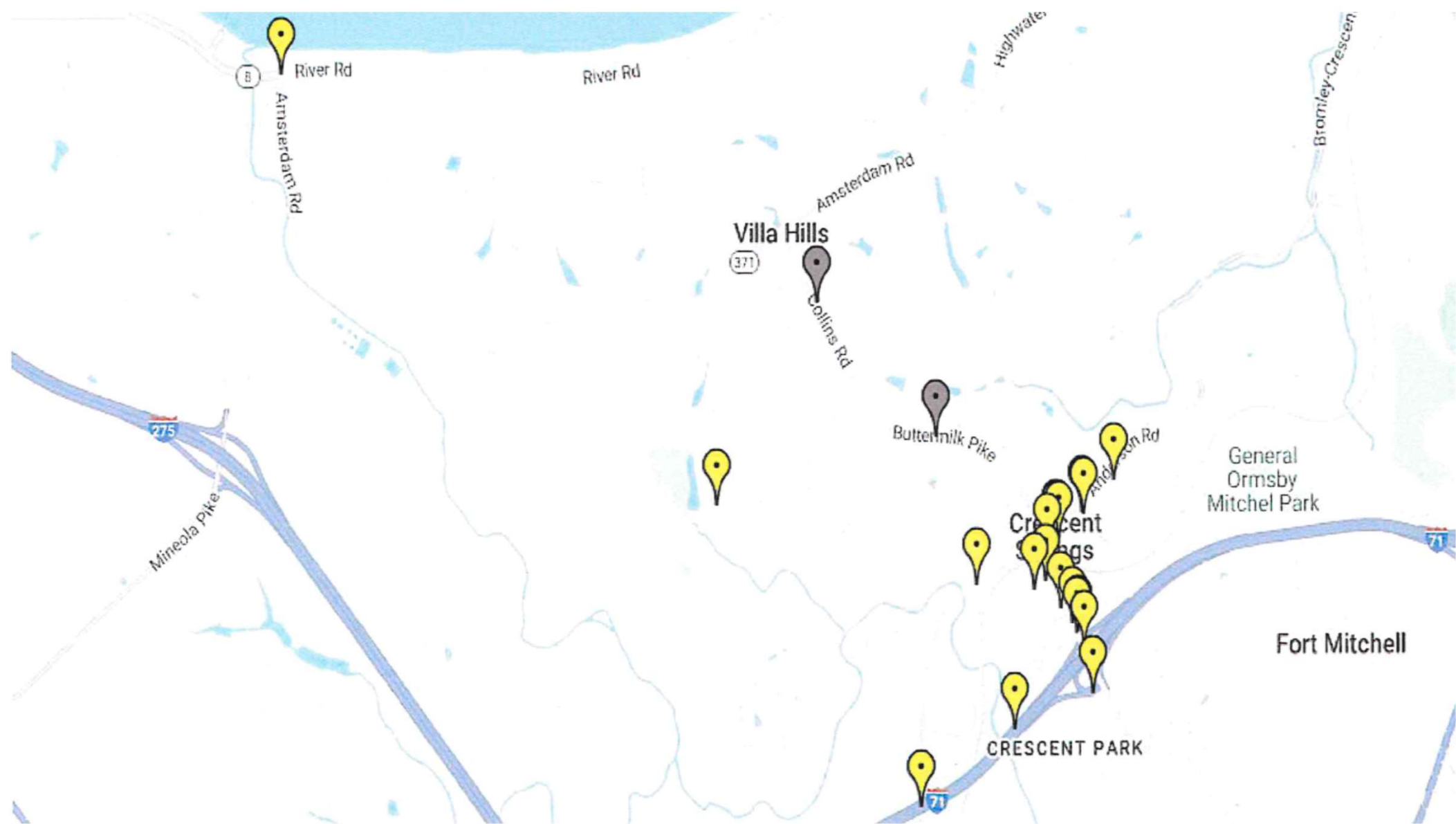


Top Roadway Collisions

CRIMINAL INVESTIGATIONS REPORT

2024-12794 (CSAM) – Waiting for search warrant return. Another preservation letter sent to carrier.

2024-13717 (Theft of Identification)- Suspect images submitted for possible ID. No ID yet, working Florence PD.

2025-00589 (Theft Identity)- Case continues. Difficulty in contacting victim. Subpoenas returned and under review.

2025-02035 (Rape 1st)- Case open for Court Purposes

2025-02217 (Stolen Credit Card)- Video footage not helpful. The case remains open.

2025-02596 (Forgery 2nd)- Possible ID on suspect. More subpoenas sent. Criminal Complaint sent.

2025-03219 (Theft under \$10,000)- No ID on two suspects.

2025-04138 (Sexual Misconduct)- Investigation continues. No disclosure. Case is CLOSED.

2025-04160 (Death Investigation- Overdose)- One suspect arrested for Trafficking and Importing Fentanyl. Second dealer arrested. Case open for Court.

2025-04368 (Theft)- Case continues. Arrest warrant issued.

2025-04412 (Death Investigation- Overdose)- Case closed. NKDSF adopting case.

2025-04594 (Receiving Stolen Property- Vehicle)- Stolen vehicle recovered. Investigation Continues. Open for Court purposes.

2025-04654 (Rape 3rd) – Investigation Continues. Interviews conducted. Case sent to Commonwealth for review.

2025-05181 (Theft of Firearm) – Firearm entered into NCIC/LINK.

2025-05869 (Theft) – Theft of lottery tickets. Suspect identified and warrant signed and active.

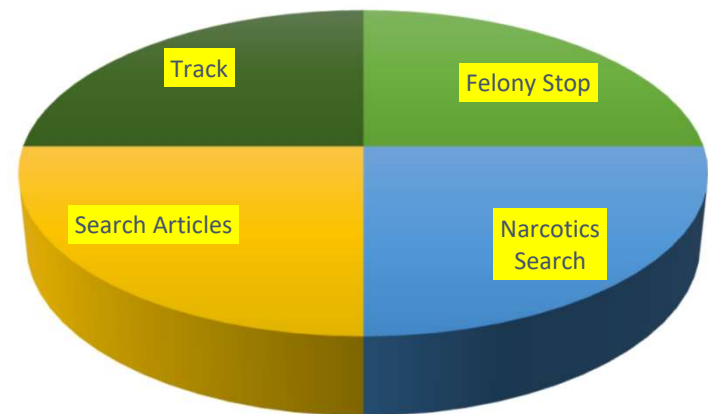

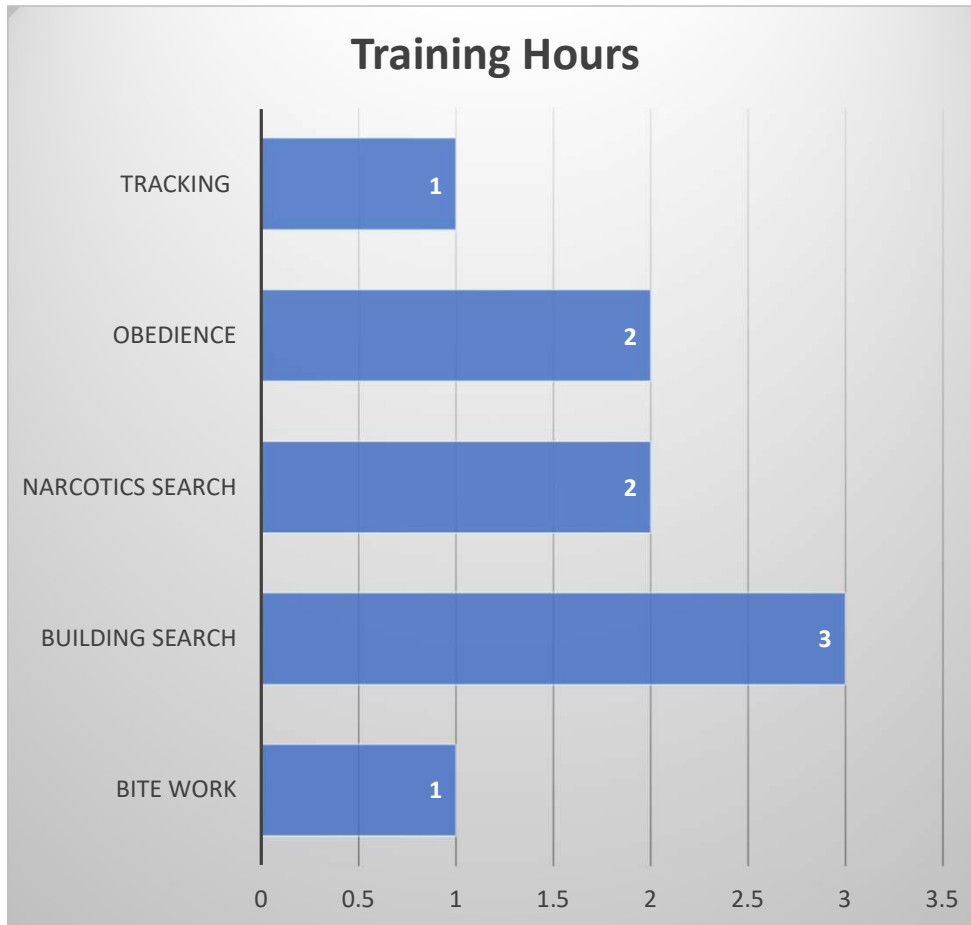

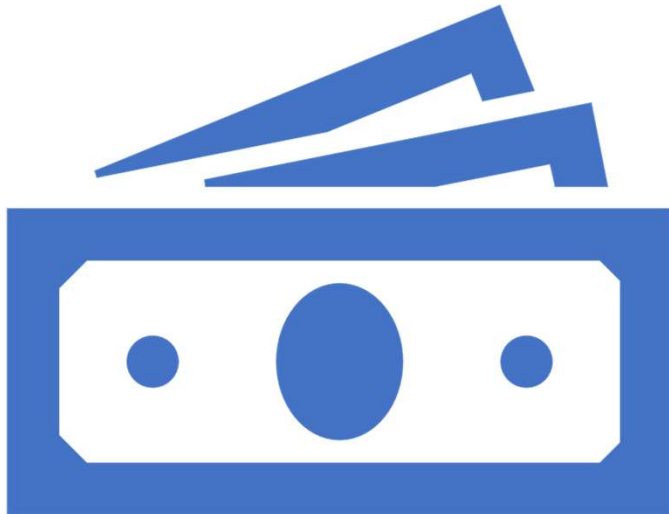
