

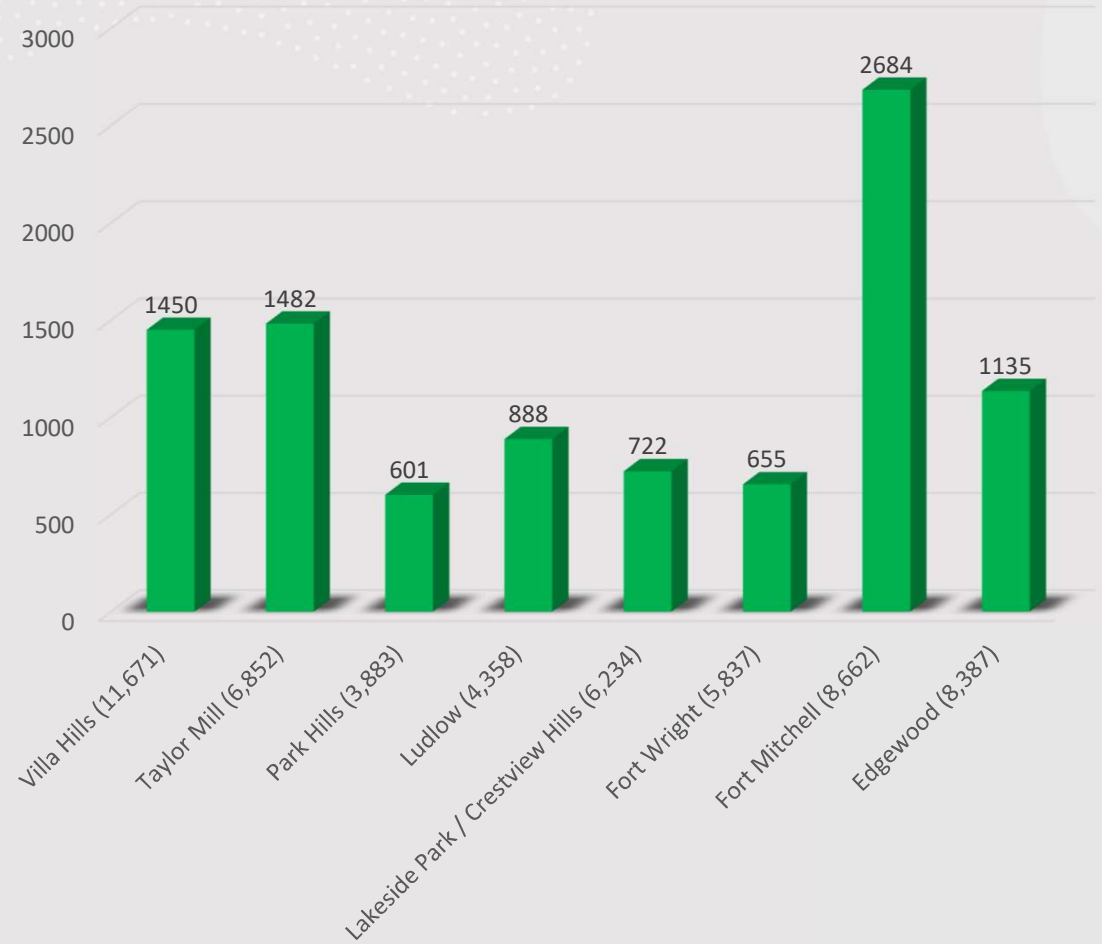

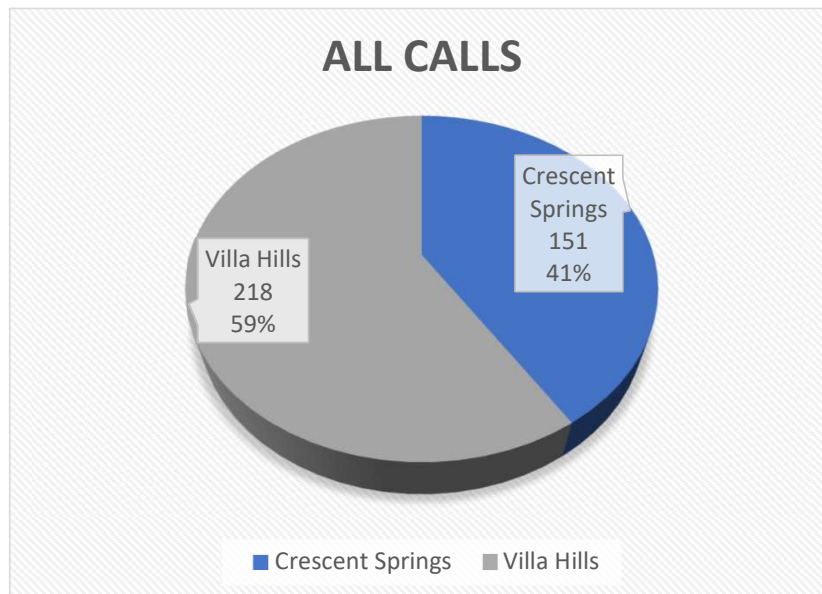

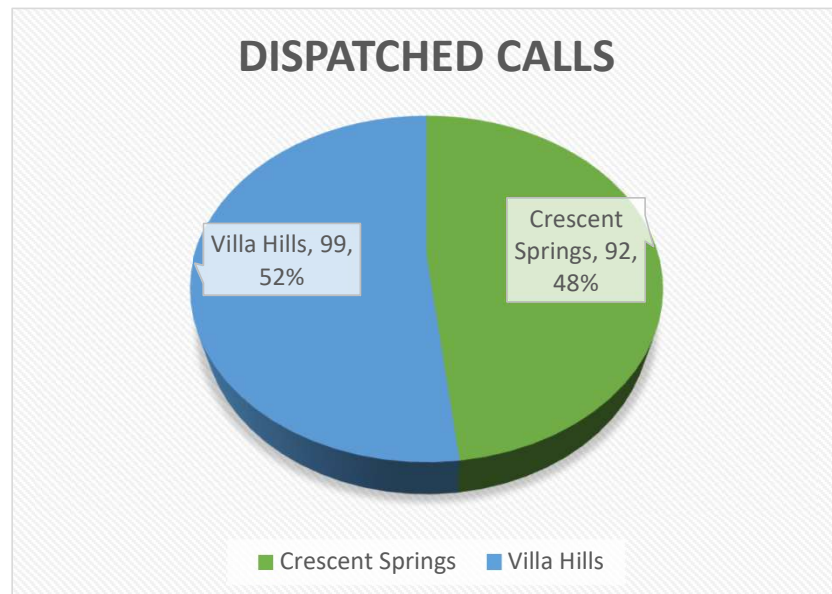


AUGUST 2025 CALLS FOR SERVICE BY CITY

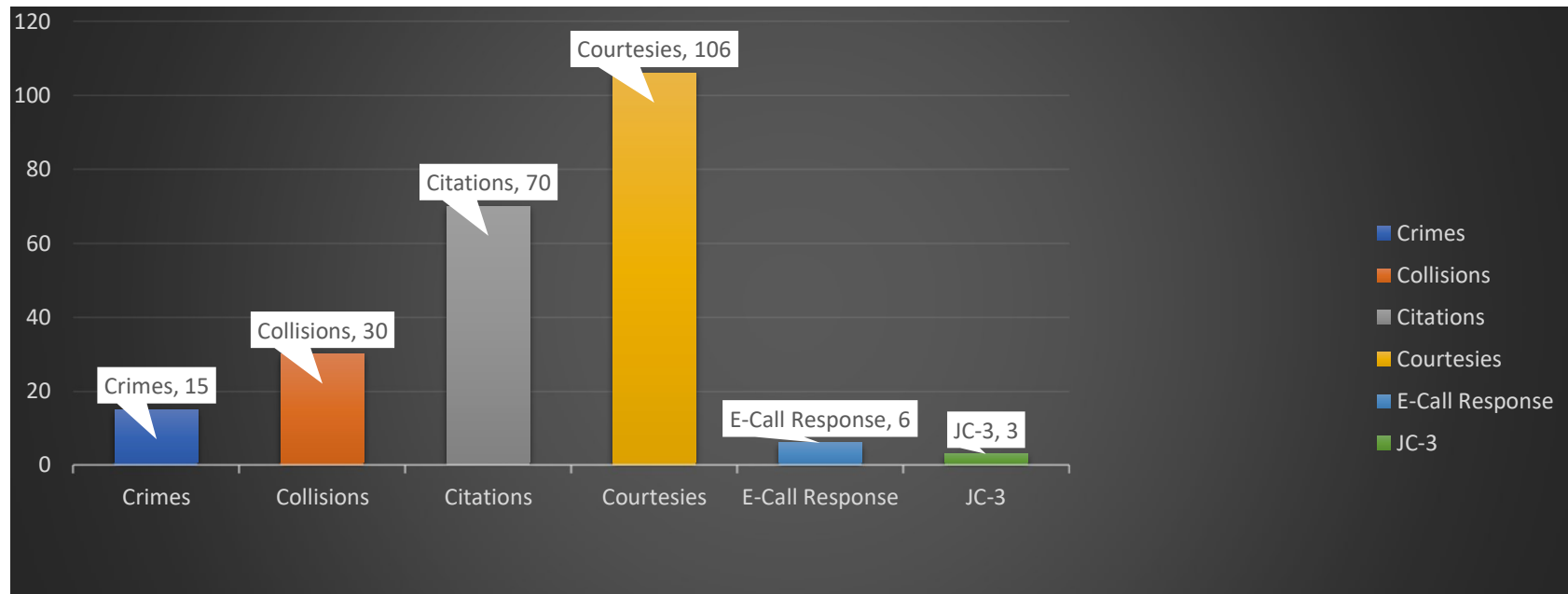
ALL CALLS (INCLUDES SELF-INITIATED)

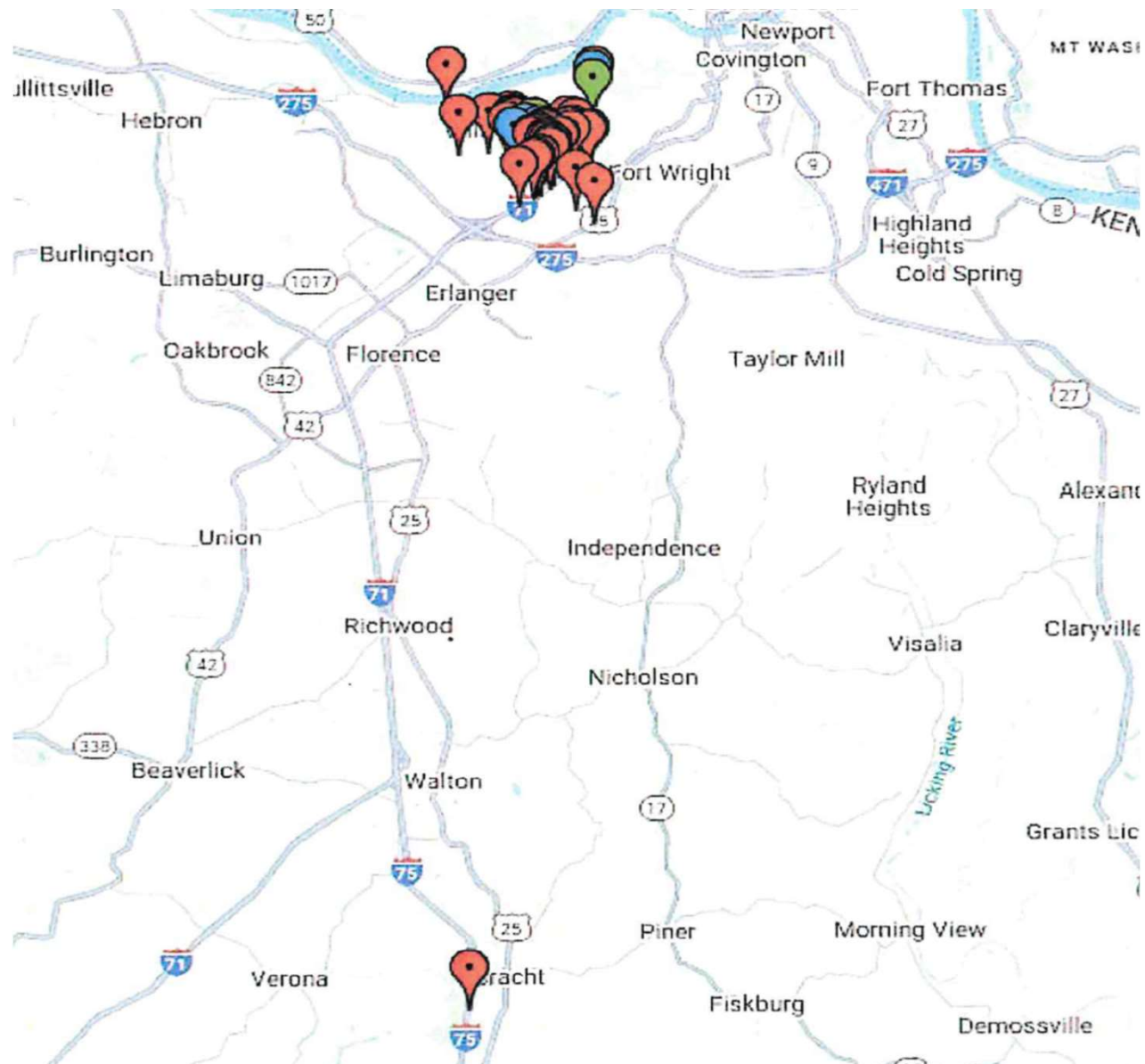

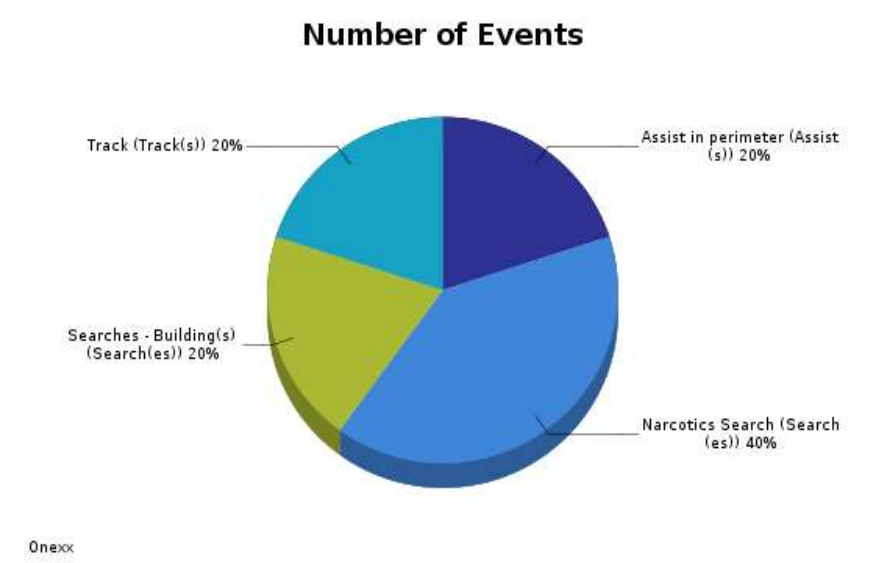
