AN ORDINANCE OF THE CITY OF VILLA HILLS IN KENTON COUNTY, KENTUCKY AMENDING TABLE 4.04 OF THE VILLA HILLS ZONING CODE.

WHEREAS, Kentucky Revised Statutes (KRS) 100.203 authorizes legislative bodies to provide text for zoning; and

WHEREAS, The City of Villa Hills desires to update various sections of the zoning code for clarity and to correct typos; and

WHEREAS, The City desires to amend its regulations regarding solar panels and fencing; and

WHEREAS, the Kenton County Planning Commission, after holding a public hearing on the application (PC-25-0007-TX) on September 4, 2025 at 6:15 P.M. pursuant to the requirements of KRS 100.211, voted to recommend approval of the proposed text amendment updating Table 4.04 of the Villa Hills Zoning Code; now therefore

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF VILLA HILLS, KENTON COUNTY, KENTUCKY.

Section I Amendment

That Table 4.04 of the City of Villa Hills, Kentucky Official Zoning Code, as adopted by Ordinance 2021-2 and amended, is hereby amended as found attached hereto and incorporated by reference and is adopted consistent with the findings and recommendations, and additional information, of the Kenton County Planning Commission, Number PC-25-0007-TX, which is attached hereto and incorporated by reference as exhibit A.

Section II - Provisions Severable

The provisions of this ordinance are severable; and the invalidity of any provision of this ordinance shall not affect the validity of any other provision thereof; and such other provisions shall remain in full force and effect as long as they remain valid in the absence of those provisions determined to be invalid.

Section III - Conflicting Ordinances Repealed

All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed to the extent of such conflict.

Section IV - Effective Date

This ordinance shall be effective as soon as possible according to law.

Section V – Publication

This ordinance shall be published in summary pursuant to KRS 83A.060 (9).

The City of Villa Hills per Craig T. Bohman, City Administrator, HAS SUBMITTED AN APPLICATION REQUESTING THE KENTON COUNTY PLANNING COMMISSION TO REVIEW AND MAKE RECOMMENDATIONS ON: Proposed text amendments to the Villa Hills Zoning Ordinance to permit Residential Care Facilities in all residential and riverfront development districts; AND

KCPC RECOMMENDATION - VILLA HILLS ZONING ORDINANCE:

Favorable recommendation on the proposed text amendments to the Villa Hills Zoning Ordinance to permit Residential Care Facilities in all residential and riverfront development districts.

SUPPORTING INFORMATION/BASES FOR KCPC RECOMMENDATION:

- 1. The proposed text amendments are authorized to be included in the text of the zoning ordinance per KRS 100.203 (See Attachment A)
- 2. The proposed text amendments are appropriate and reasonable. KRS 100.984 states that no conditional use permit not otherwise required for other residences within a zone or land use category shall be required for the operation of a residential care facility. The changes will bring the Villa Hills Zoning Ordinance into greater compliance with the requirements of KRS 100.984. Existing state laws referenced in the Villa Hills Zoning Ordinance provide specific standards for the operation of these facilities including 902 KAR 20:078 which states that the residence shall have the style and appearance of neighborhood houses and the residence shall house no less than four and no more than eight residents.
