








# NOVEMBER 2025 CALLS FOR SERVICE BY CITY


ALL CALLS (INCLUDES SELF-INITIATED)







# CRIMINAL INVESTIGATIONS REPORT

**2024-12794** (CSAM) – Waiting for search warrant return. Another preservation letter sent to carrier. Sent for review.

**2025-07611** (Death Investigation) – Non-criminal death.

**2025-07762** (Theft by Deception) – Suspect identified. Attempting to locate for interview.

**2025-02035** (Rape 1<sup>st</sup>)- Case open for Court Purposes. Victim died from injuries. Manslaughter charges being reviewed.

**2025-02217** (Stolen Credit Card)- Video footage not helpful. The case remains open.- Moved to Inactive

**2025-02596** (Forgery 2<sup>nd</sup>)- Possible ID on suspect. More subpoenas sent. Criminal Complaint sent. Active Warrant for Suspect.

Theft from vehicles- Esporta- several vehicles. No video surveillance. Case continues.

**2025-07889** (Sexual Abuse 1<sup>st</sup>)- Investigation Continues.

**2025-04160** (Death Investigation- Overdose)- One suspect arrested for Trafficking and Importing Fentanyl. Second dealer arrested. Case open for Court.


