

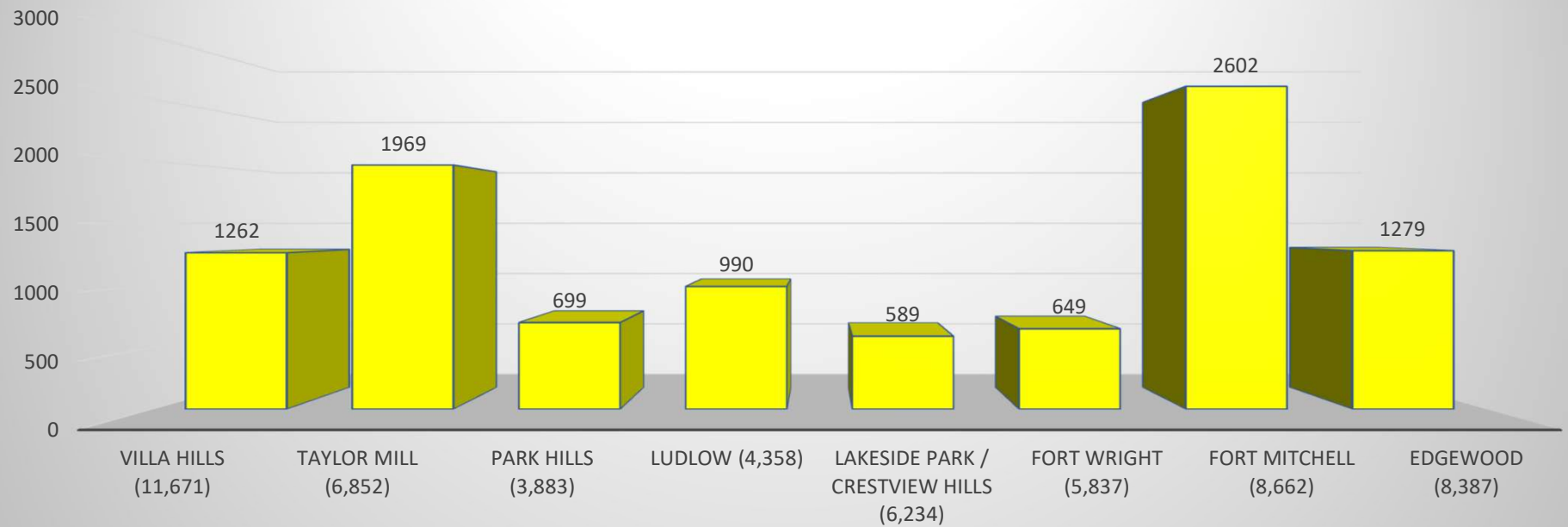

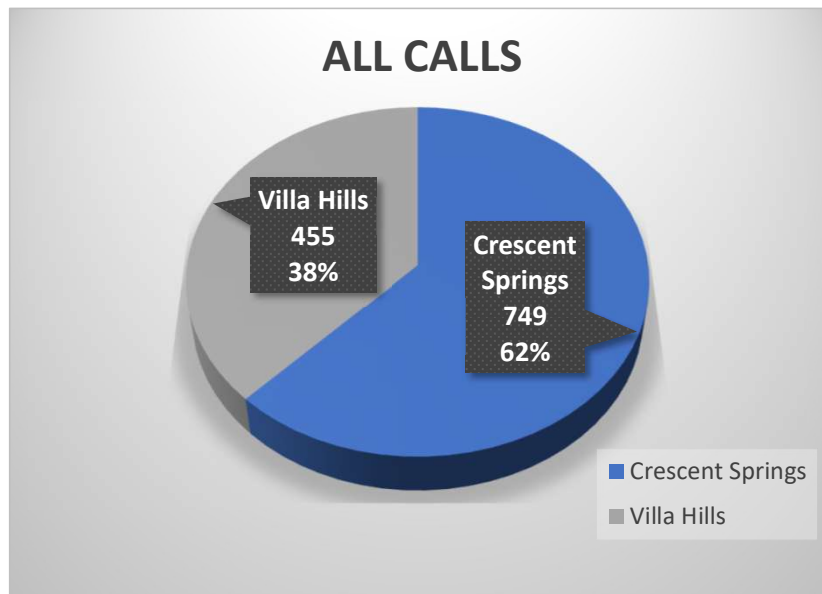

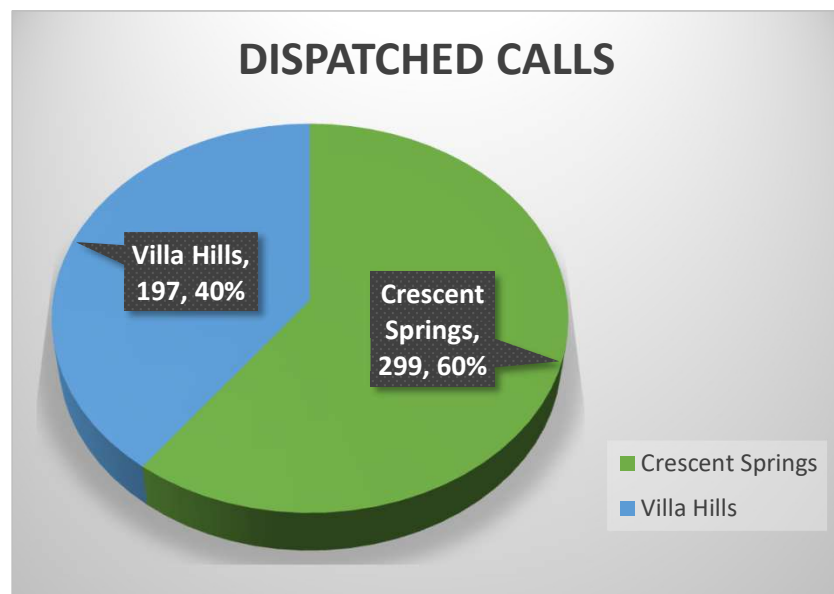


MARCH 2026 CALLS FOR SERVICE BY CITY

ALL CALLS (INCLUDES SELF-INITIATED)

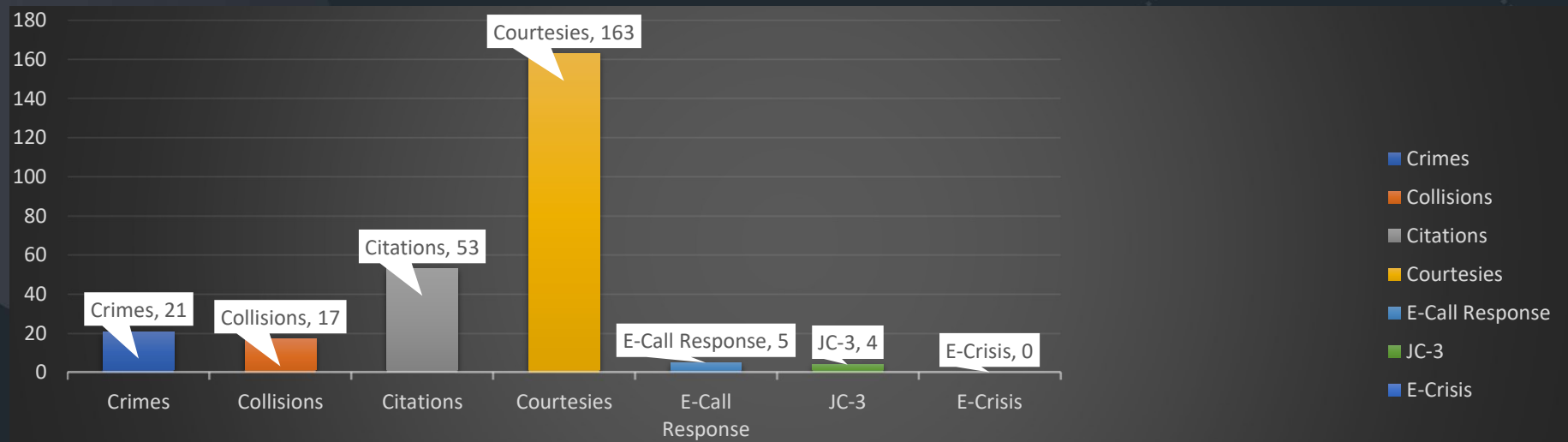


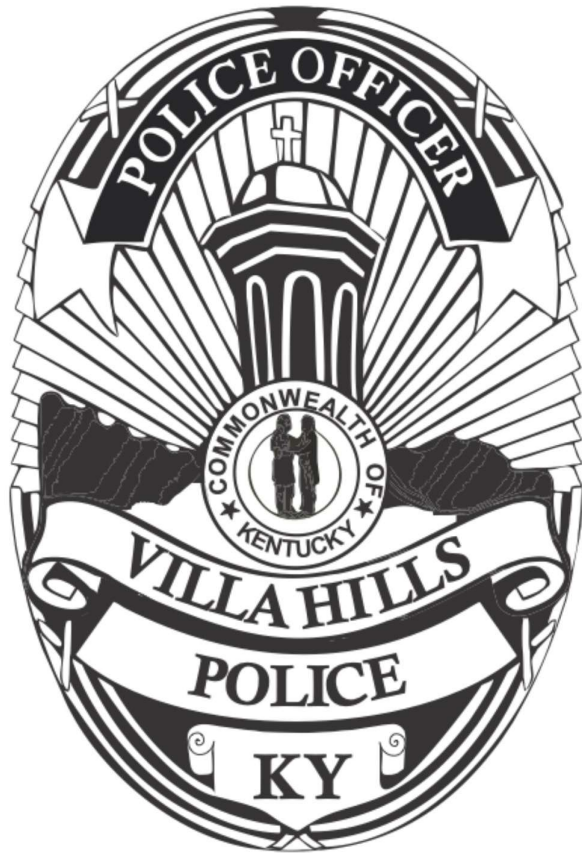
DISPATCHED CALLS (EXCLUDES ALL OTHERS)

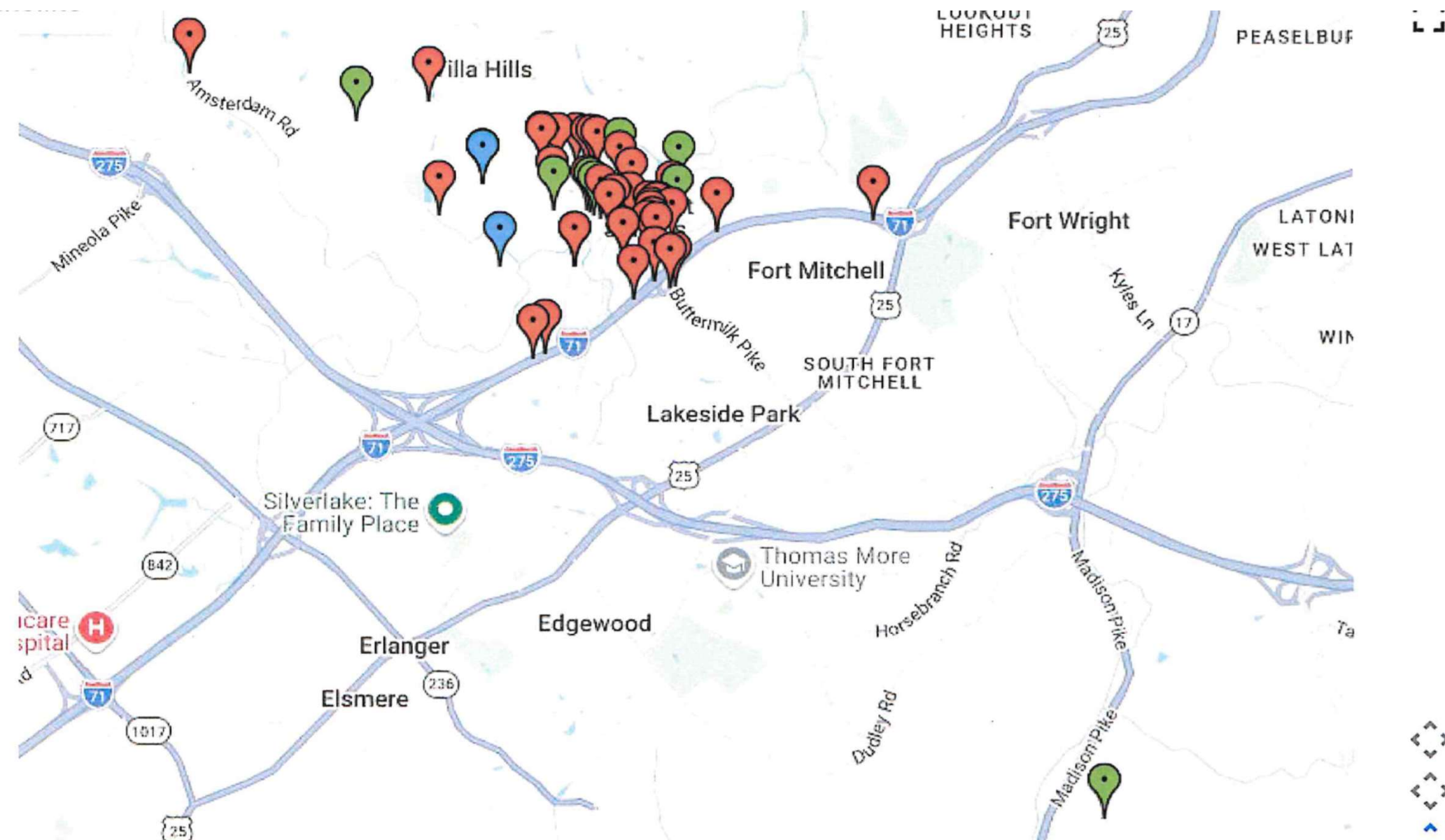

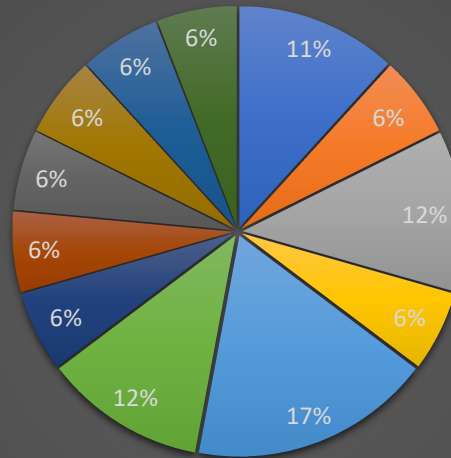
Red – Traffic Stops (39)

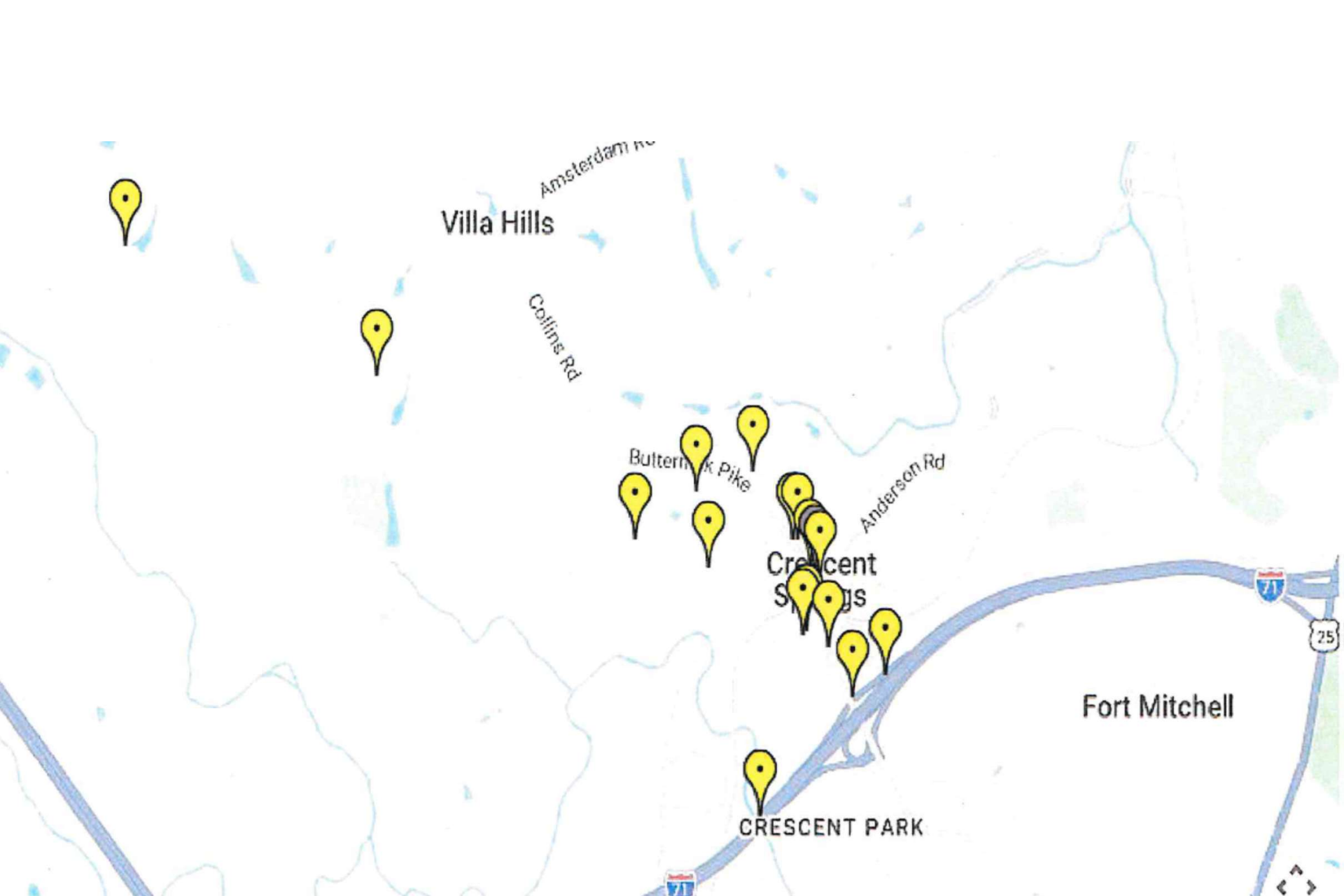

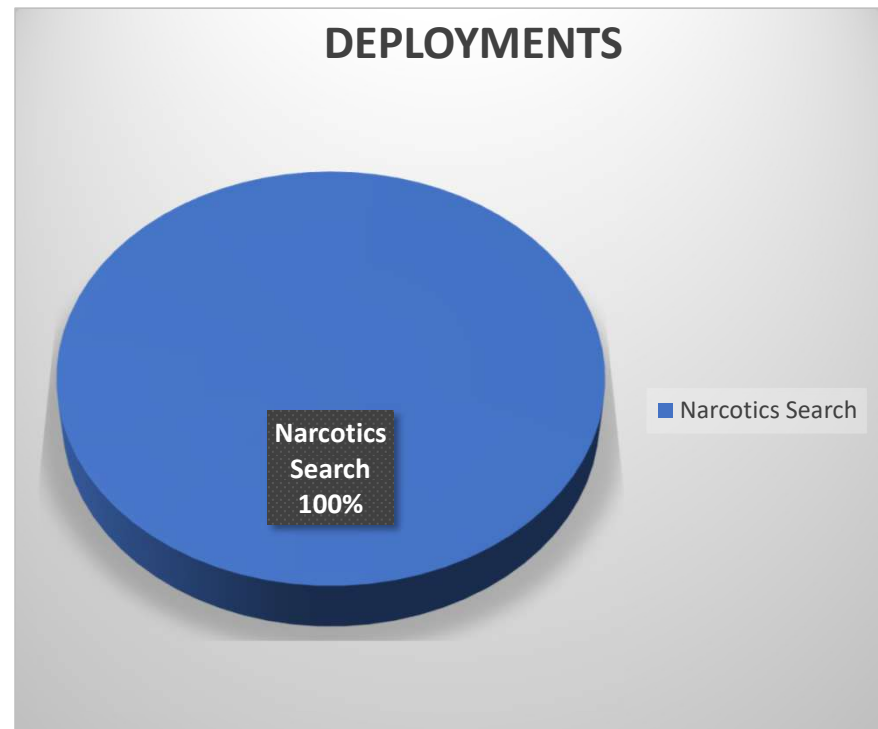

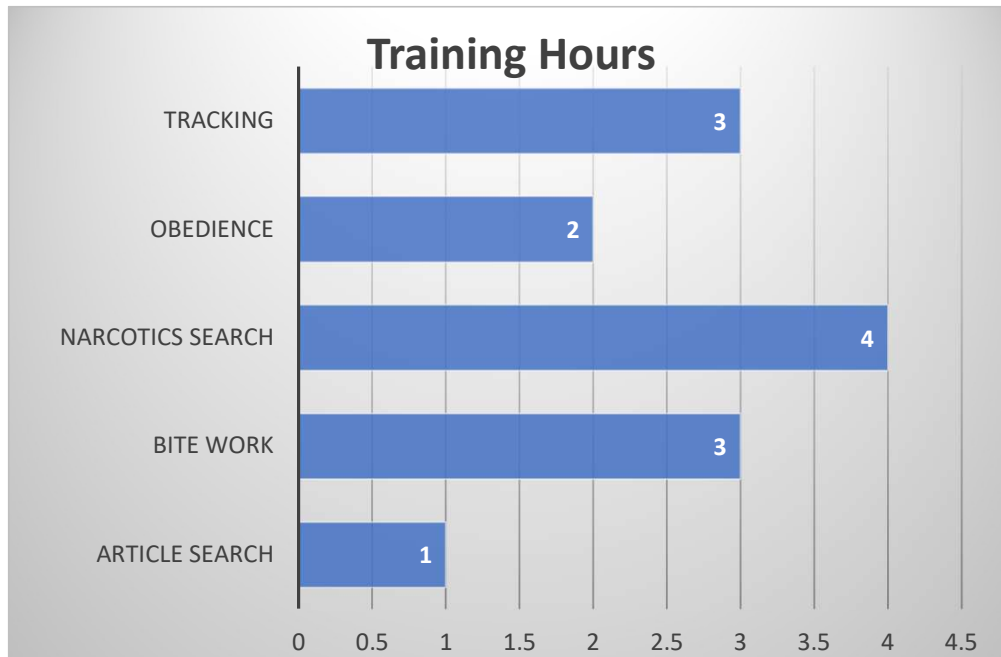
